I note the following with respect to the May 2 docket:

- No. 40, Case No. 20451: WPX' Collie well. This is a competing application with Matador's Case No. 20324 (K Grevey). WPX asks that Case No. 20451 be continued, and that both Nos. 20451 and 20324 be set on the May 30 docket. I have conferred with Mr. Bruce, and Matador does not object.
- Nos. 48- 51, Case Nos. 20456-20459: Catena's Cable and Anchor wells. These applications are competing with Mewbourne's applications in Case Nos. 20328 and 20329, which do not appear to be on any docket at this time. The parties are negotiating and ask that the Catena applications be continued and that both Catena's applications and Mewbourne's applications be continued until May 16. I have conferred with Mr. Bruce, and Mewbourne agrees to this continuance.
- No. 47, Case No. 20161: Devon's Lone Tree Draw. Devon asks that this case be dismissed.
