Dear Examiners,

These consolidated cases were initially presented on September 6, 2018 before Chief Examiner Mike McMillan.

Before an order was entered, however, the applications were amended to include proximity tracts. The amended applications were heard on February 7, 2019 before Chief Examiner Scott Dawson.

Since the February 7 hearing, Ameredev has made the decision to switch the surface hole location from the south end of Section 8 to the north end of Section 5 (Lot 4) for the proposed Pine Straw Fed Com 25 36 08 No. 091H and the Pine Straw Fed Com 25 36 08 No. 101 wells. Attached are revised C-102s reflecting this change for both of the proposed wells. New well proposal letters with AFEs were sent out to interest owners. A copy of the well proposal letters, with the corresponding AFEs, are also attached to this email.

With the above exceptions, the testimony and exhibits presented at the February 7 hearing remain unchanged.

Ameredev respectfully requests that the above-referenced changes to the surface hole locations be incorporated into any orders entered in these consolidated cases.
