



Case No. 20332: Application of Chevron Production Company for compulsory pooling, Eddy County, New Mexico. Applicant in the above-styled cause seeks an order pooling all uncommitted interests in the Wolfcamp formation [Purple Sage; Wolfcamp (Gas)] in the 640-acre horizontal spacing unit comprised of the E/2 of Section 15 and the E/2 of Section 22 of Township 23 South, Range 28 East, NMPM, Eddy County, New Mexico. The above-referenced unit will be dedicated to the following proposed wells:

- The **CB NE 15 22 002** No. 1H, which will be horizontally drilled from a surface hole location in the NW/4 NE/4 (Unit B) of Section 15 to a bottom hole location in the SW/4 SE/4 (Unit O) of Section 22;
- The **CB NE 15 22 002** No. 2H, which will be horizontally drilled from a surface hole location in the NW/4 NE/4 (Unit B) of Section 15 to a bottom hole location in the SE/4 SE/4 (Unit P) of Section 22; and
- The **CB NE 15 22 002** No. 3H, which will be horizontally drilled from a surface location in the NE/4 NE/4 (Unit A) of Section 15 to a bottom hole location in the SE/4 SE/4 (Unit P) of Section 22.

The completed interval for the proposed **CB NE 15 22 002H** will be within 330' of the quarter-quarter line separating the W/2 E/2 from the E/2 E/2 of Sections 15 and 22 to allow inclusion of this acreage into a standard 640-acre horizontal spacing unit. Pursuant to the Special Rules for the Purple Sage; Wolfcamp, the completed intervals for these wells will comply with the 330-foot setback requirement. Since the proposed wells will be simultaneously drilled and completed, Chevron requests an extension of the time period to drill and complete the initial well from 120 days to 365 days. Also, to be considered will be the cost of drilling and completing the wells, the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of Chevron Production Company as operator, and a 200% charge for risk involved in drilling and completing the well. Said area is located approximately 3 miles northeast of Loving, New Mexico.
