This letter is to advise you that 3Bear Field Services LLC ("3Bear") filed the enclosed C-108 application on March 4, 2019, with the New Mexico Oil Conservation Commission seeking authorization to drill two Acid Gas Injection (AGI) wells at their Libby Gas Plant (the "Plant") in Lea County, New Mexico. AGI #1 will be a vertical well, located at 1970' FWL, 1475' FSL in Section 26, T20S, R34E. AGI #2 will be a deviated well, and the surface location will be at 1970' FWL and 1910 FSL, with a bottom hole location of 1320 FWL and 2275 FWS, also in Section 26, T20S, R34E, NMPM, Lea County, New Mexico. 3Bear plans to inject up to 8 million standard cubic feet per day (MMSCFD) of treated acid gas from the Plant at a maximum pressure of 4,525 psig into the Devonian and Upper Silurian Wristen and Fusselman Formations, approximately 14,900 to 16,400 feet below the surface. The proposed wells will serve as a disposal well for acid gas at this plant.

This application (Case Number 20409) has been set for hearing before the New Mexico Oil Conservation Commission at 9:00 AM on Thursday, April 11, 2019, in Wendell Chino Building at the New Mexico Oil Conservation Division's Santa Fe office located at 1220 South Saint Francis Drive, Santa Fe, New Mexico 87505. You are not required to attend this hearing, but as an owner of an interest that may be affected by 3Bear's application, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the application at a later date.

A party appearing at the hearing is required by Division Rule 19.15.4.13 NMAC to file a Pre-Hearing Statement at least four days in advance of a scheduled hearing, but in no event not later than 5:00 p.m. Mountain Time on the Thursday preceding the scheduled hearing date. This statement must be filed at the Division's Santa Fe office at the above-specified address and should include the names of the parties and their attorneys; a concise statement of the case; the names of all witnesses the party will call to testify at the hearing; the approximate time the party will need to present its case; and an identification of any procedural matters that need to be resolved prior to the hearing.
