APPLICATION OF TAP ROCK OPERATING, LLC FOR COMPULSORY POOLING, LEA COUNTY, NEW MEXICO

APPLICATION

Tap Rock Operating, LLC ("Tap Rock"), through its undersigned attorneys, hereby files this application with the Oil Conservation Division pursuant to the provisions of NMSA 1978, \$ 70-2-17, for an order pooling all mineral interests in the Wolfbone formation ([98098] WC-025 G-09 S243532M) in a standard 320-acre, more or less, horizontal spacing and proration unit comprised of the W/2 W/2 of Section 34, Township 24 South, Range 35 East, and the W/2 W/2 of Section 3, Township 25 South, Range 35 East, in Lea County, New Mexico. In support of its application, Tap Rock states:

- 1. Tap Rock is a working interest owner in the standard horizontal spacing and proration unit ("HSU") and has the right to drill thereon.
- 2. Tap Rock proposes to dedicate the HSU to its 2-mile **Mulva Fed Com #131H** well, to be horizontally drilled from an approximate surface hole location 418' FSL and 655' FWL of Section 27-T24S-R35E, to an approximate bottom hole location 5' FSL and 660' FWL of Section 3-T25S-R35E. This well defines the HSU.
- 3. Also to be drilled are the following infill wells: (1) the 2-mile **Mulva Fed Com #211H** well, to be horizontally drilled from an approximate surface hole location 448' FSL and 655' FWL of Section 27-T24S-R35E, to an approximate bottom hole location 5' FSL and 334' FWL of Section 3-T25S-R35E; and (2) the 2-mile **Mulva Fed Com #215H** well, to be horizontally

drilled from an approximate surface hole location 448' FSL and 685' FWL of Section 27-T24S-R35E, to an approximate bottom hole location 5' FSL and 989' FWL of Section 3-T25S-R35E.

- 4. The completed intervals and first and last take points meet the setback requirements set forth in the statewide rules for horizontal oil wells.
- 5. Tap Rock has in good faith sought and been unable to obtain voluntary agreement for the development of these lands from all of the mineral interest owners in the HSU.
- 6. Approval of the HSU and the pooling of all mineral interest owners in the Wolfbone formation underlying the HSU will avoid the drilling of unnecessary wells, will prevent waste, and will protect correlative rights.
- 7. In order to permit Tap Rock to obtain its just and fair share of the oil and gas underlying the subject lands, all uncommitted interests in this HSU should be pooled and Tap Rock should be designated the operator of the HSU.

WHEREFORE, Tap Rock requests that this application be set for hearing before an Examiner of the Oil Conservation Division on September 5, 2019, and, after notice and hearing as required by law, the Division enter an order:

- A. Creating a standard 320-acre, more or less, horizontal spacing and proration unit comprised of the W/2 W/2 of Section 34, Township 24 South, Range 35 East, and the W/2 W/2 of Section 3, Township 25 South, Range 35 East, Lea County, New Mexico;
- B. Pooling all mineral interests in the Wolfbone formation ([98098] WC-025 G-09
 S243532M) underlying the HSU;
 - C. Designating the Mulva Fed Com #131H well as the defining well for said HSU;
- D. Allowing the drilling of (1) the Mulva Fed Com /#211H well and (2) the Mulva Fed Com #215H well as infill wells.

- E. Designating Tap Rock as operator of the HSU and the wells to be drilled thereon;
- F. Authorizing Tap Rock to recover its costs of drilling, equipping and completing the wells;
- G. Approving the actual operating charges and costs of supervision while drilling and after completion, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and;
- H. Imposing a 200% penalty for the risk assumed by Tap Rock in drilling and completing the wells against any interest owner who does not voluntarily participate in the drilling of the wells.
