STATEMENT OF CASE

APPLICANT:

NGL seeks an order approving disposal into the Silurian-Devonian formation through the Tomahawk SWD #1 well at a surface location 900 feet from the North line and 151 feet from the East line of Section 4, Township 25 South, Range 34 East, NMPM, Lea County, New Mexico for the purpose of operating a salt water disposal well. NGL seeks authority to inject salt water into the Silurian-Devonian formation at a depth of 16,805' to 18,475'. NGL further seeks approval of the use of 7 inch tubing inside the surface and intermediate casings and 5 ½ inch tubing inside the liner and requests that the Division approve a maximum daily injection rate for the well of 50,000 bbls per day.
