#### **APPLICANT**

Applicant seeks an order pooling all mineral interests in the Wolfcamp formation in a horizontal spacing unit comprised of the E/2 of Section 28, Township 23 South, Range 29 East, NMPM. The unit will be dedicated to the Anderson Laing Fed. Com. Well Nos. 208H and 228H, with surface locations in the SE/4SE/4 and final take points in the NE/4NE/4 of Section 28.
