APPLICATION

Novo Oil & Gas Northern Delaware, LLC (“Novo” or “Applicant”) (OGRID No. 372920), through its undersigned attorneys, hereby files this application with the Oil Conservation Division pursuant to the provisions of NMSA 1978, § 70-2-17, for an order pooling all uncommitted interests in the Wolfcamp formation underlying a standard 320-acre, more or less, horizontal spacing unit comprised of the N/2 of Section 13, Township 23 South, Range 28 East, NMPM, Eddy County, New Mexico. In support of its application, Novo states:

1. Applicant is a working interest owner in the proposed horizontal spacing unit and has the right to drill thereon.

2. Applicant seeks to dedicate the above-referenced horizontal spacing unit to the following proposed initial wells:

- The **Ovation Fed Com 13 #211H Well**, the **Ovation Fed Com 13 #212H Well**, the **Ovation Fed Com 13 #221H Well**, the **Ovation Fed Com 13 #231H Well**, and the **Ovation Fed Com 13 #232H Well**, each will be horizontally drilled from a common surface location in the NE/4 of Section 14, T23S, R28E, to bottom hole locations in the NE/4 NE/4 (Unit A) of Section 13.
- The **Ovation Fed Com 13 #215H Well**, the **Ovation Fed Com 13 #222H Well**, the **Ovation Fed Com 13 #225H Well**, and the **Ovation Fed Com 13 #235H Well**

each will be horizontally drilled from a common surface location in the NE/4 of Section 14, T23S, R28E, to bottom hole locations in the SE/4 NE/4 (Unit H) of Section 13.

3. Applicant has sought and been unable to obtain voluntary agreement for the development of these lands from all mineral interest owners in the subject spacing unit.

4. The pooling of interests will avoid the drilling of unnecessary wells, will prevent waste, and will protect correlative rights.

5. In order to permit Applicant to obtain its just and fair share of the oil and gas underlying the subject lands, all uncommitted interests in this horizontal spacing unit should be pooled, and Applicant should be designated the operator of this proposed horizontal well and spacing unit.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on November 14, 2019, and, after notice and hearing as required by law, the Division enter an order:

- A. Pooling all uncommitted interests in the horizontal spacing unit and approving the initial wells thereon;
- B. Designating Applicant as operator of this spacing unit and the horizontal wells to be drilled thereon;
- C. Authorizing Applicant to recover its costs of drilling, equipping and completing the wells;
- D. Approving the actual operating charges and costs of supervision while drilling and after completion, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and

- E. Imposing a 200% charge for the risk assumed by Applicant in drilling and completing the wells against any working interest owner who does not voluntarily participate in the drilling of the wells.

Application of Novo Oil & Gas Northern Delaware LLC for compulsory pooling, Eddy County, New Mexico. Applicant in the above-styled cause seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a standard 320-acre, more or less, horizontal spacing unit comprised of the N/2 of Section 13, Township 23 South, Range 28 East, NMPM, Eddy County, New Mexico. Said horizontal spacing unit will be dedicated to the following proposed initial wells:

- The **Ovation Fed Com 13 #211H Well**, the **Ovation Fed Com 13 #212H Well**, the **Ovation Fed Com 13 #221H Well**, the **Ovation Fed Com 13 #231H Well**, and the **Ovation Fed Com 13 #232H Well**, each will be horizontally drilled from a common surface location in the NE/4 of Section 14, T23S, R28E, to bottom hole locations in the NE/4 NE/4 (Unit A) of Section 13.
- The **Ovation Fed Com 13 #215H Well**, the **Ovation Fed Com 13 #222H Well**, the **Ovation Fed Com 13 #225H Well**, and the **Ovation Fed Com 13 #235H Well** each will be horizontally drilled from a common surface location in the NE/4 of Section 14, T23S, R28E, to bottom hole locations in the SE/4 NE/4 (Unit H) of Section 13.

Also, to be considered will be the cost of drilling and completing the wells, the allocation of the costs thereof, the actual operating costs and charges for supervision, the designation of applicant as operator of the wells, and the imposition of a 200% charge for risk involved in drilling and completing the wells. Said area is located approximately 3 miles east of Loving, New Mexico.
