
**SALT CREEK MIDSTREAM, LLC'S  
UNOPPOSED MOTION FOR CONTINUANCE**

Salt Creek Midstream, LLC ("Salt Creek") moves for a continuance of the November 6, 2019 hearing in this case to the Commission's December 11, 2019 docket. In support of its motion, Salt Creek states:

1. This case is currently scheduled to be heard on November 6, 2019.
2. Salt Creek has been engaging in discussions with the New Mexico State Land Office and New Mexico Oil Conservation Division in an effort to resolve their concerns regarding the proposed Salt Creek AGI #1 well and is requesting a continuance to give the parties an opportunity to resolve the outstanding issues.
3. Salt Creek has contacted counsel for the New Mexico State Land Office and the Oil Conservation Division regarding this motion, and they do not oppose it.
4. WHEREFORE, Salt Creek requests that the Commission (i) grant this motion, and (ii) continue the hearing in this case to the Commission's December 11, 2019 docket.


