Hilcorp seeks an order: (1) pooling all uncommitted interests in the Pictured Cliffs formation underlying the SW/4 of Section 36, Township 32 North, Range 11 West, NMPM, San Juan County, New Mexico, to be dedicated to a standard 160-acre gas spacing unit within the Pictured Cliffs formation; and (2) dedicating this spacing unit to the proposed **State Com M 010**

Well (API No. 30-045-34025), to be recompleted at a standard gas well location in the NW/4 SW/4 (Unit L) of Section 36 to a depth sufficient to test the Pictured Cliffs formation.
