



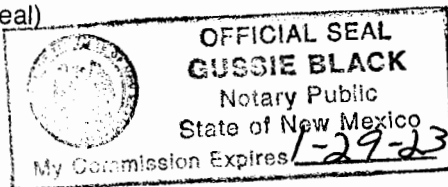

Wright, or your heirs, devisees, successors, or assigns: Mewbourne Oil Company has filed an application with the New Mexico Oil Conservation Division seeking an order pooling all mineral interests in the Bone Spring formation underlying a 237.60-acre horizontal spacing unit in the Bone Spring formation comprised of Lots 2, 7, 10, 15 and the W/2SE/4 (the W/2E/2) of irregular Section 6; Township 21 South, Range 35 East, NMPM. The unit will be dedicated to the Cast Away B2BW State Com. Well No. 1H, with a first take point in Lot 2 and a last take point in the SW/4SE/4 of Section 6. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well.
