The application submitted on behalf of Delaware Energy LLC for approval of the Ensico SWD No. 1 is being denied. This denial is based on a deficient application which has remained suspended since it was first submitted in October 2016. A protest of the application was submitted by Finley Resources in November 2016 which resulted in this application being sent to hearing in Case No. 16375. With the withdrawal of Finley's protest, the case was dismissed at the September 20, 2018 Examiner's hearing and was followed by the issuance of Division Order R-20251.

With both the notice of protest and the notice of the protest withdrawal, the Division listed several deficiencies in the application including the significant disregard for the protection of the Capitan Reef aquifer in the well design. With these deficiencies, the continued lack of response, and a pending application which is now over two years in age, the Division is denying the application and will reject any resubmittal of this application with similar content.
