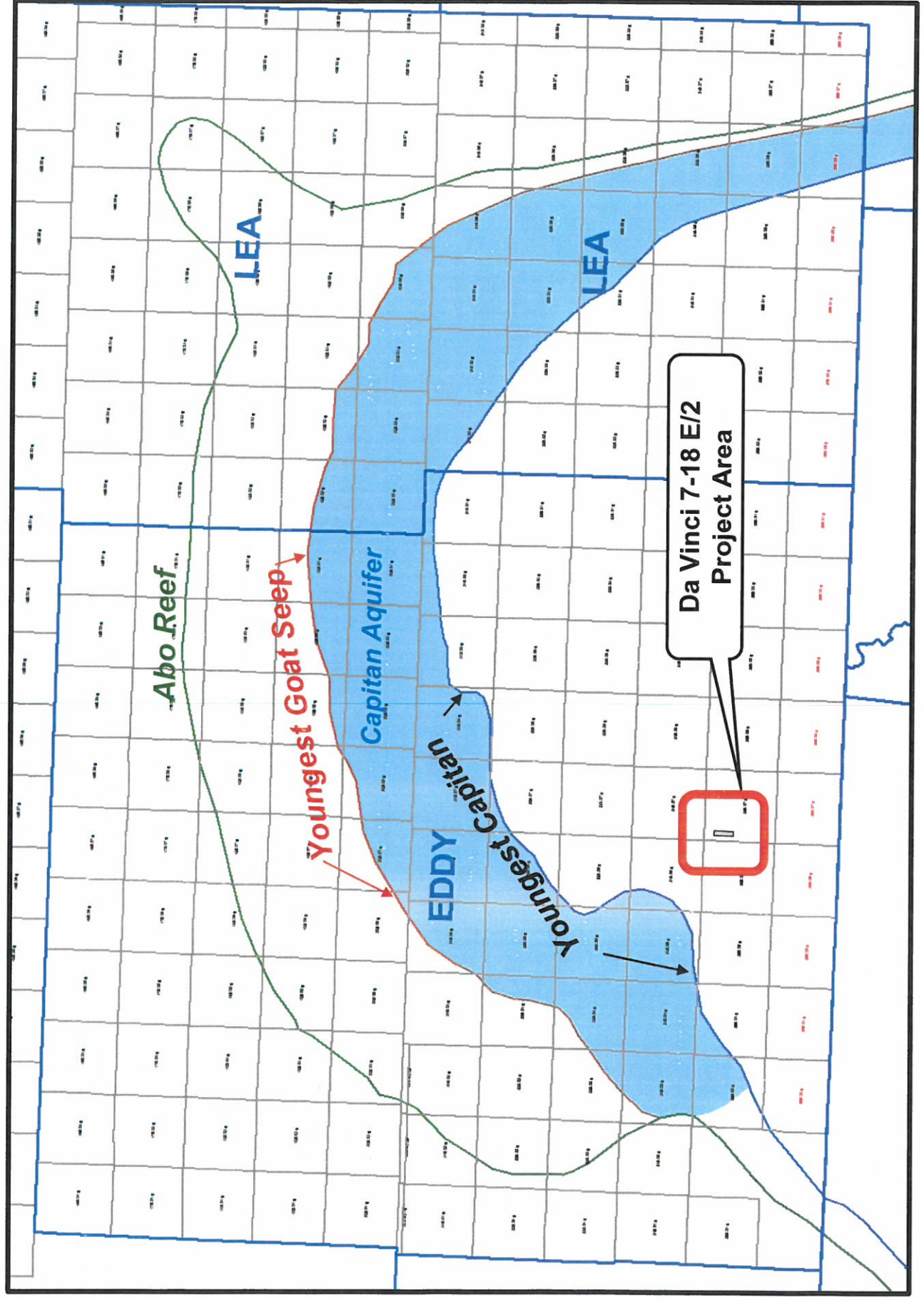
XEC DaVinci 7-18 Fed 29H & 30H Gun Barrel Diagram

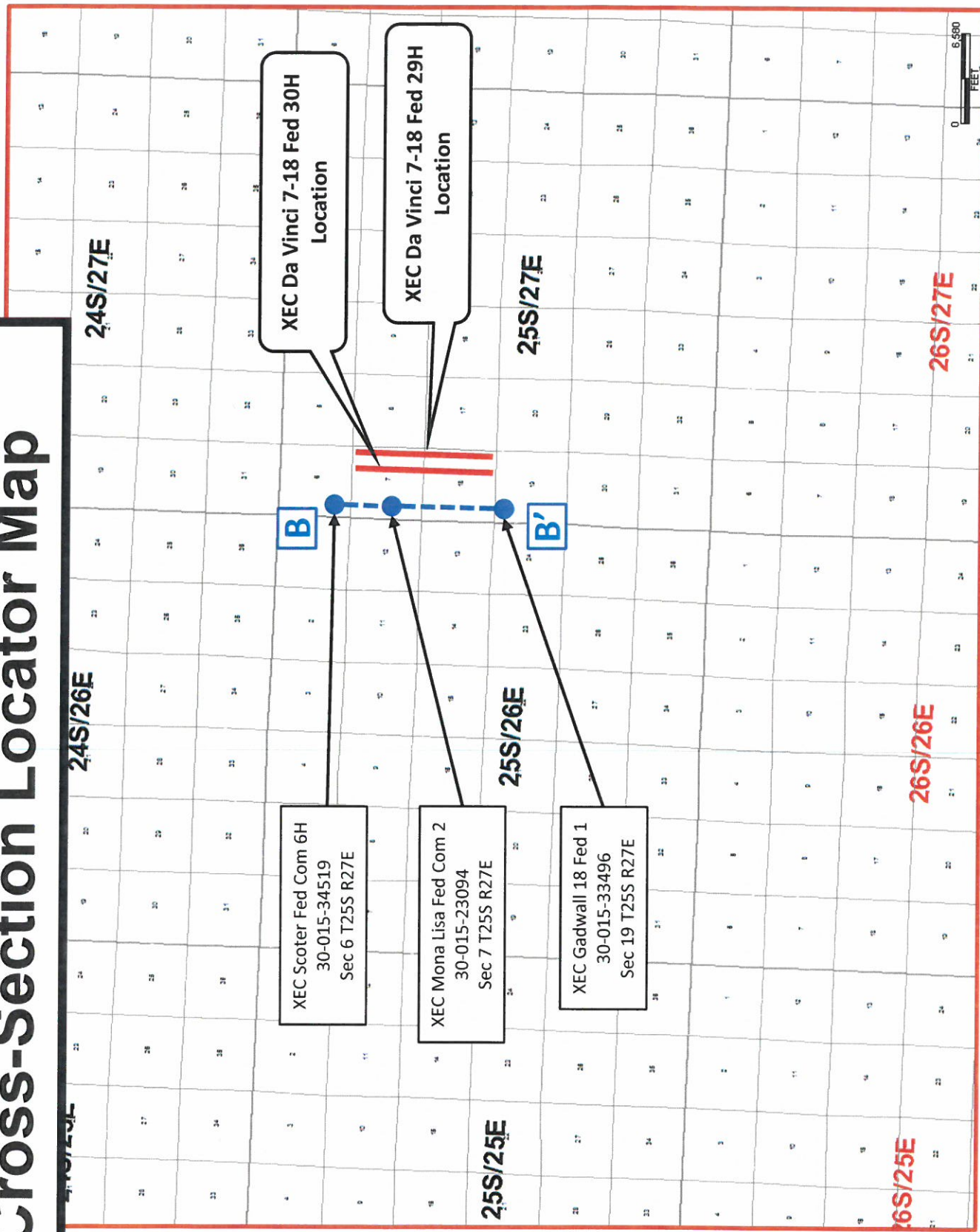

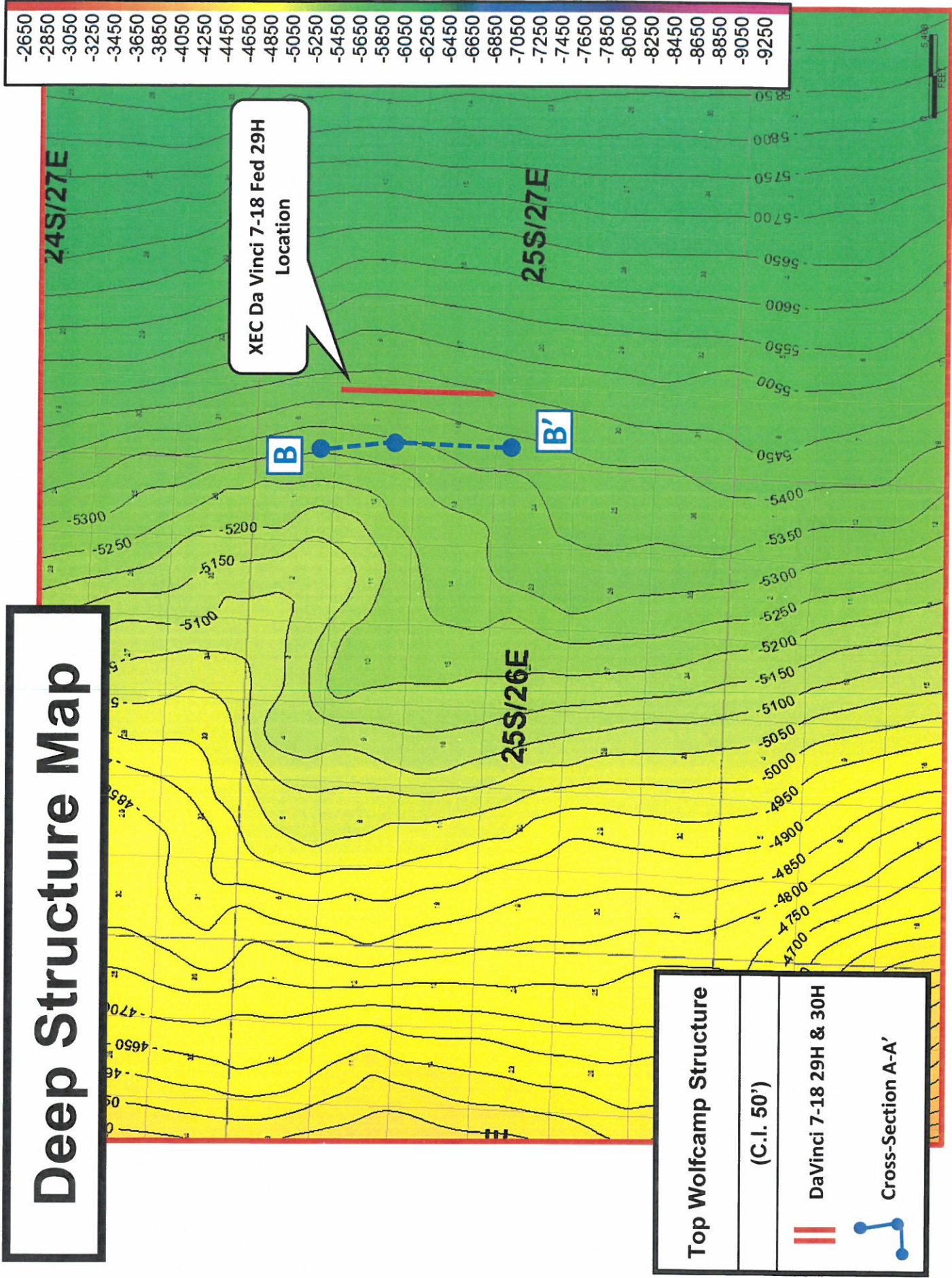
Da Vinci 7-18 Fed Com E/2 (29H & 30H) Locator Map



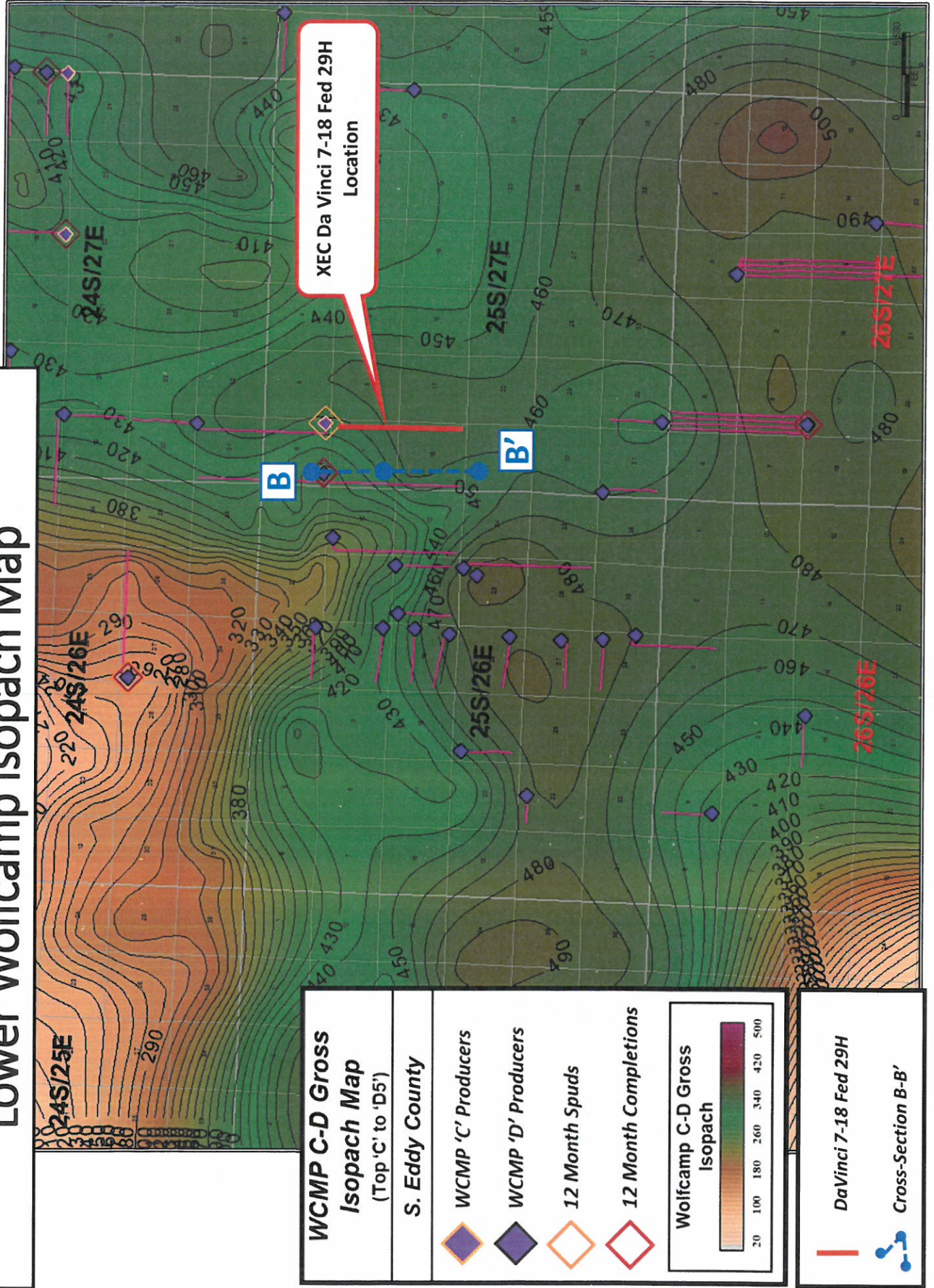
Cross-Section Locator Map

Lower Wolfcamp Isopach Map

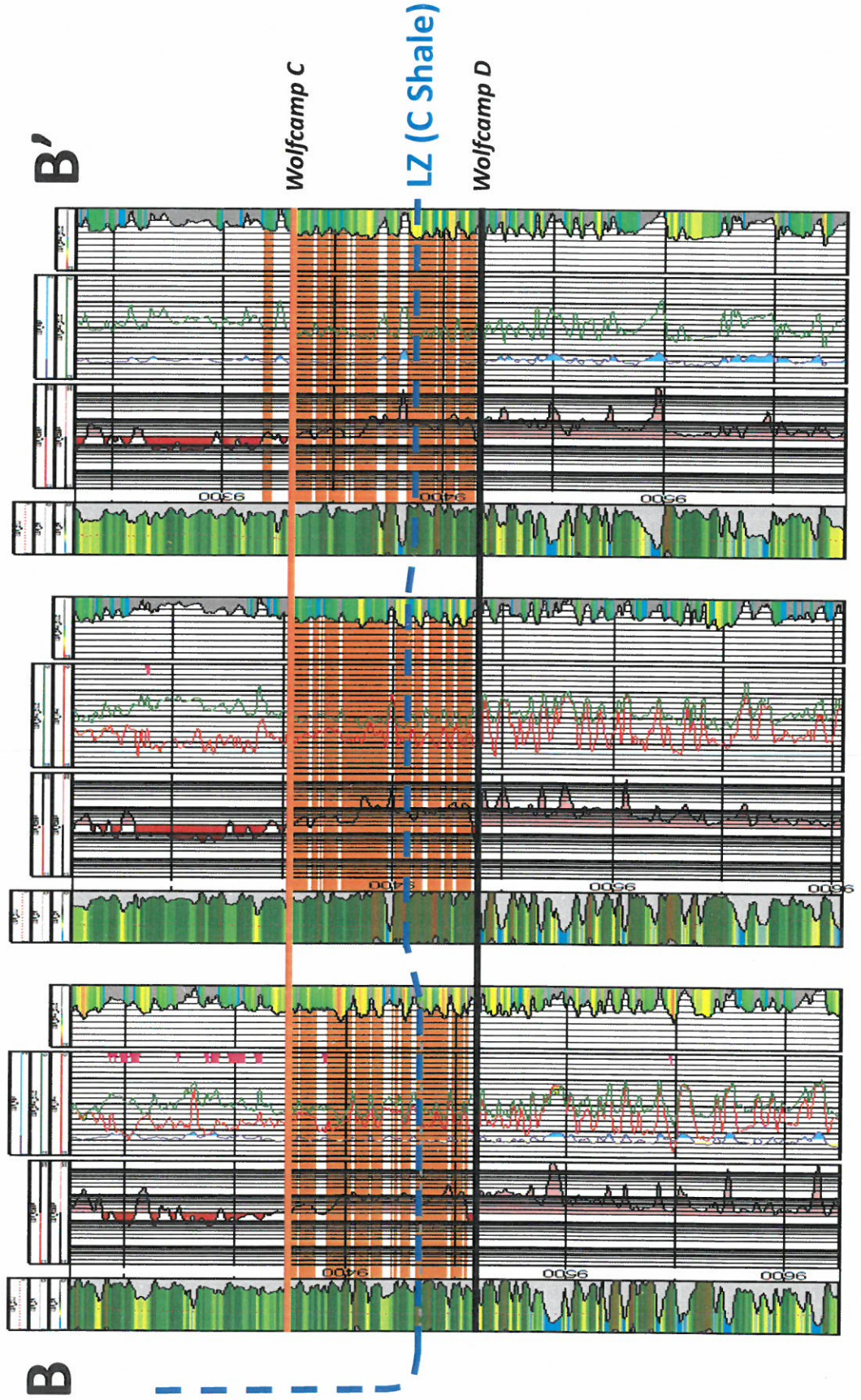


Lower Wolfcamp N-S Cross-Section B-B'

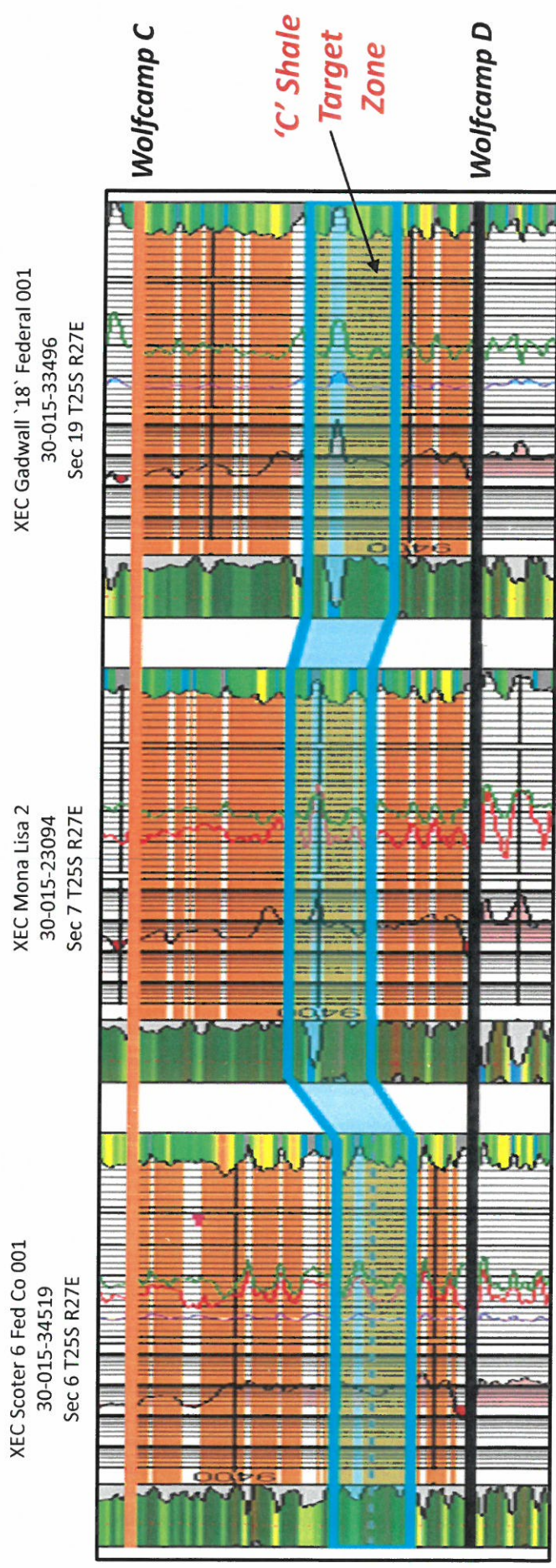

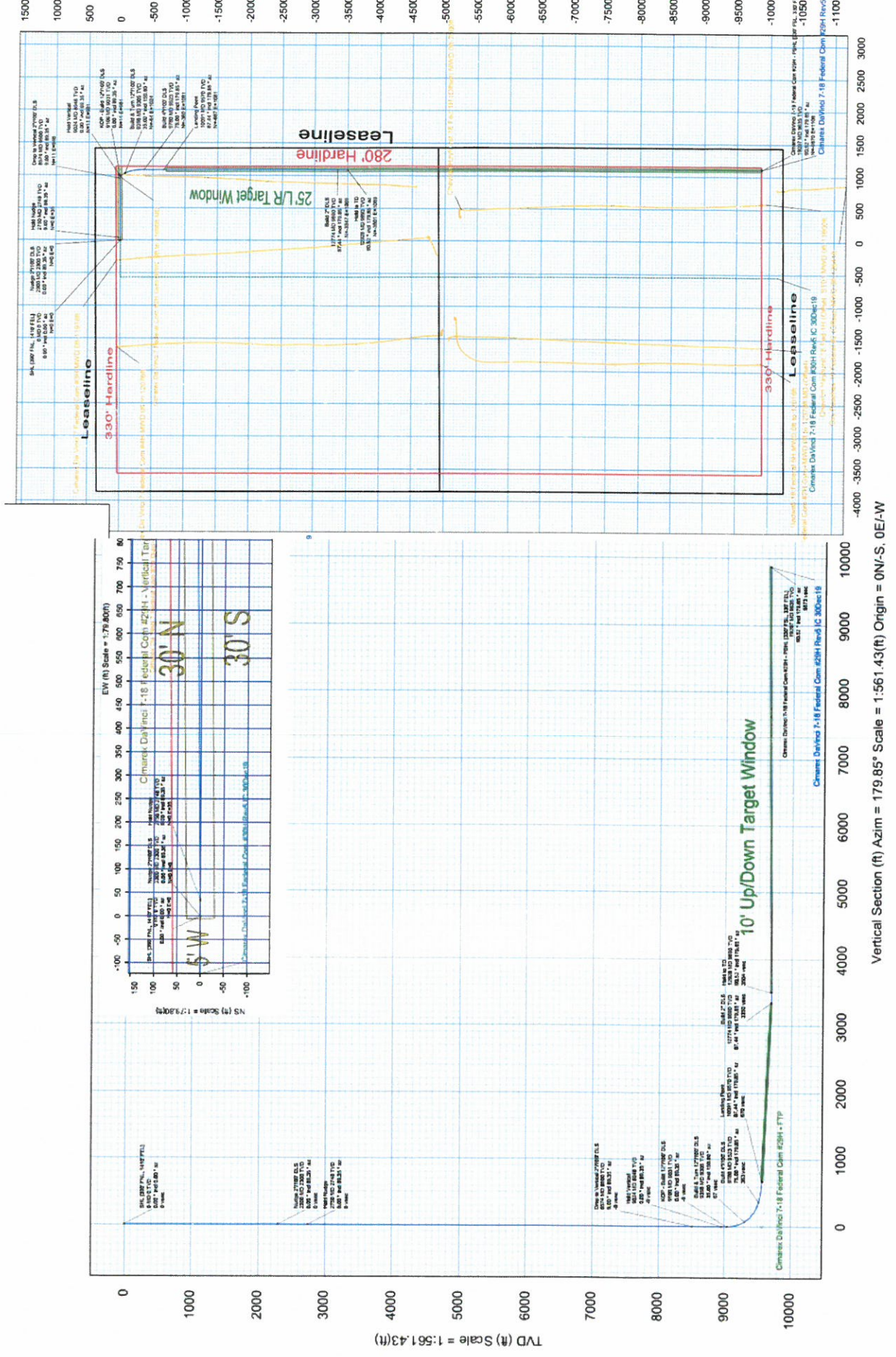


Lower Wolfcamp N-S Cross-Section B-B' – 'C' Shale LZ

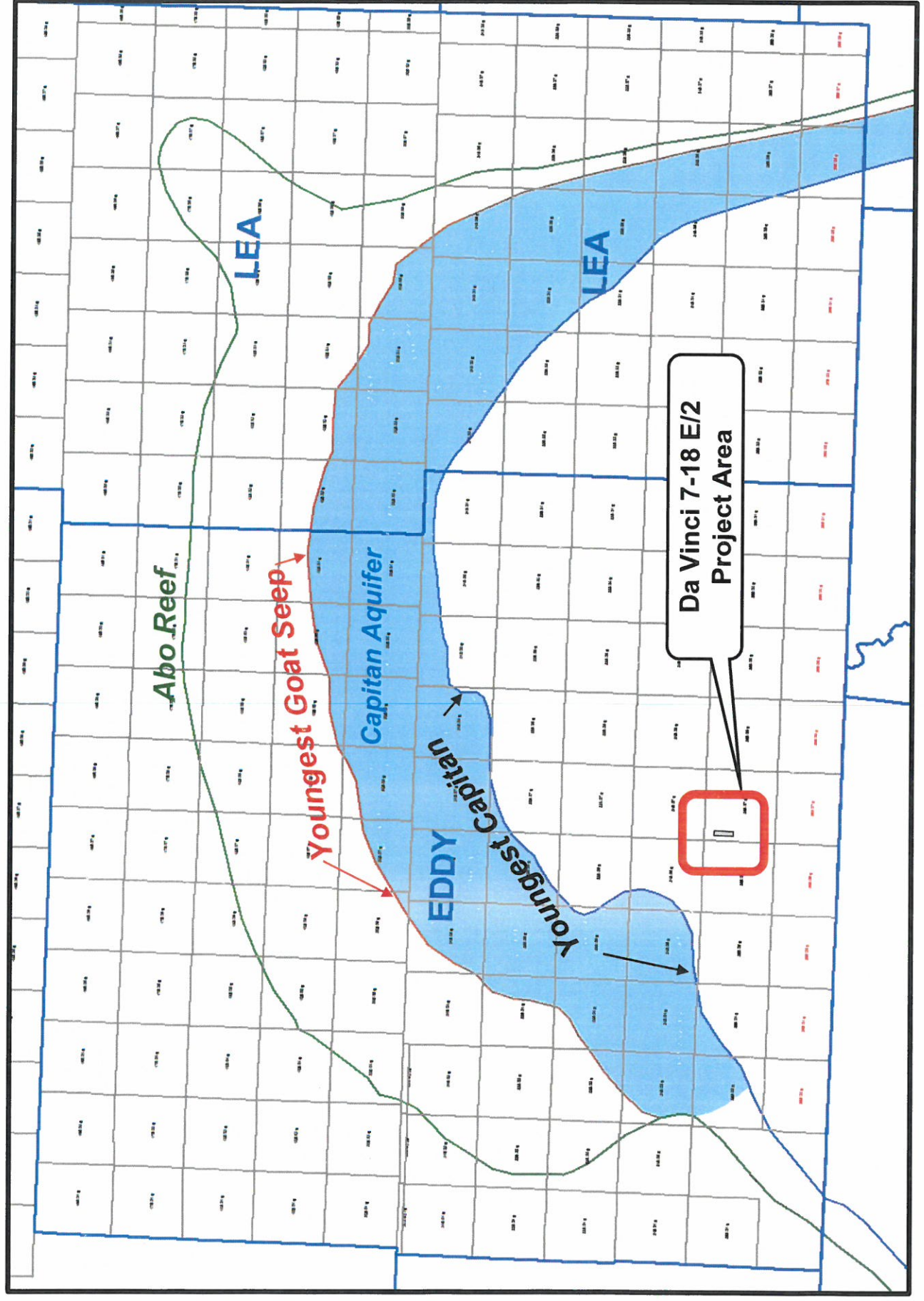

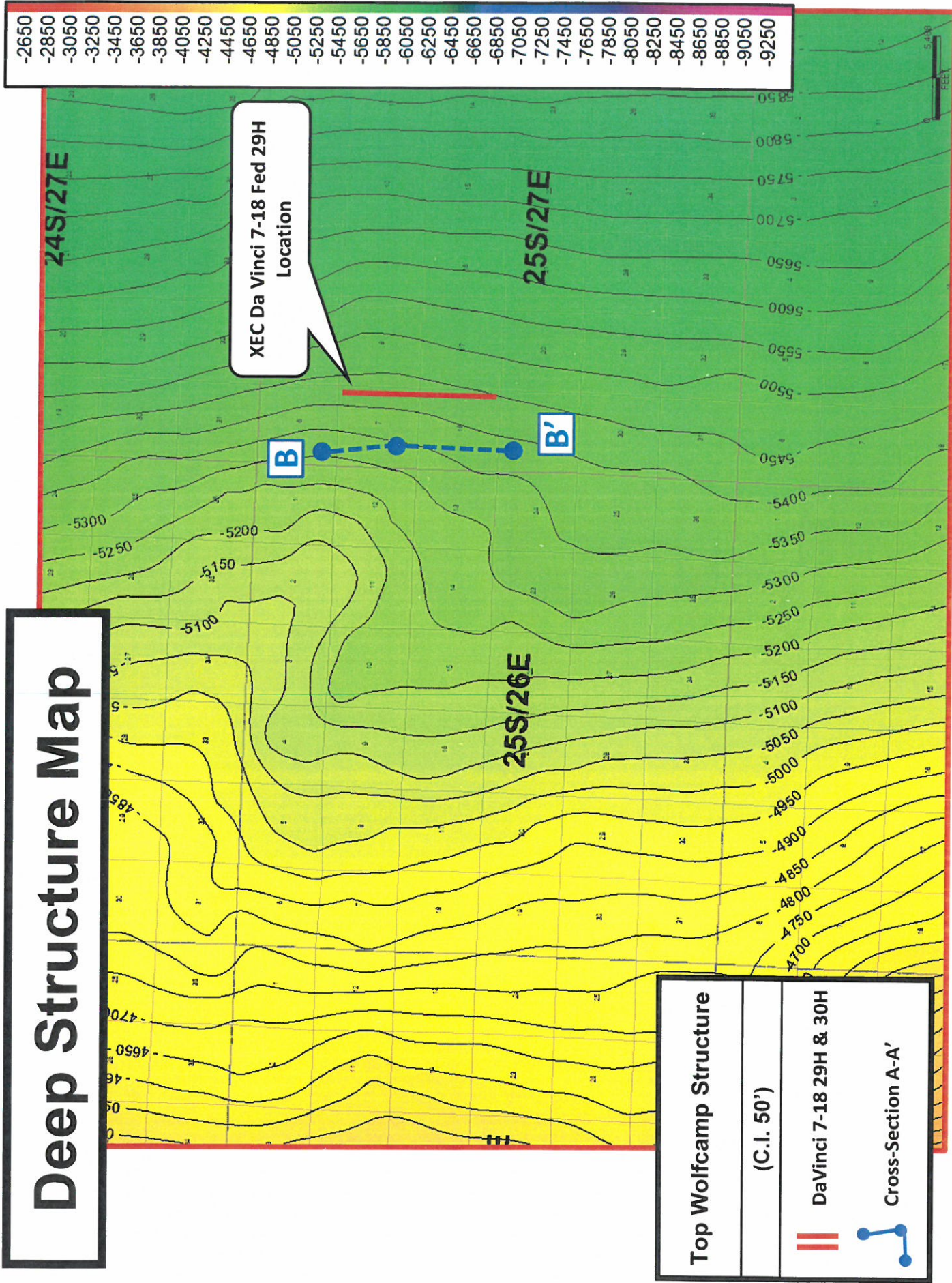
Da Vinci 7-18 Fed Com E/2 (29H & 30H) Locator Map



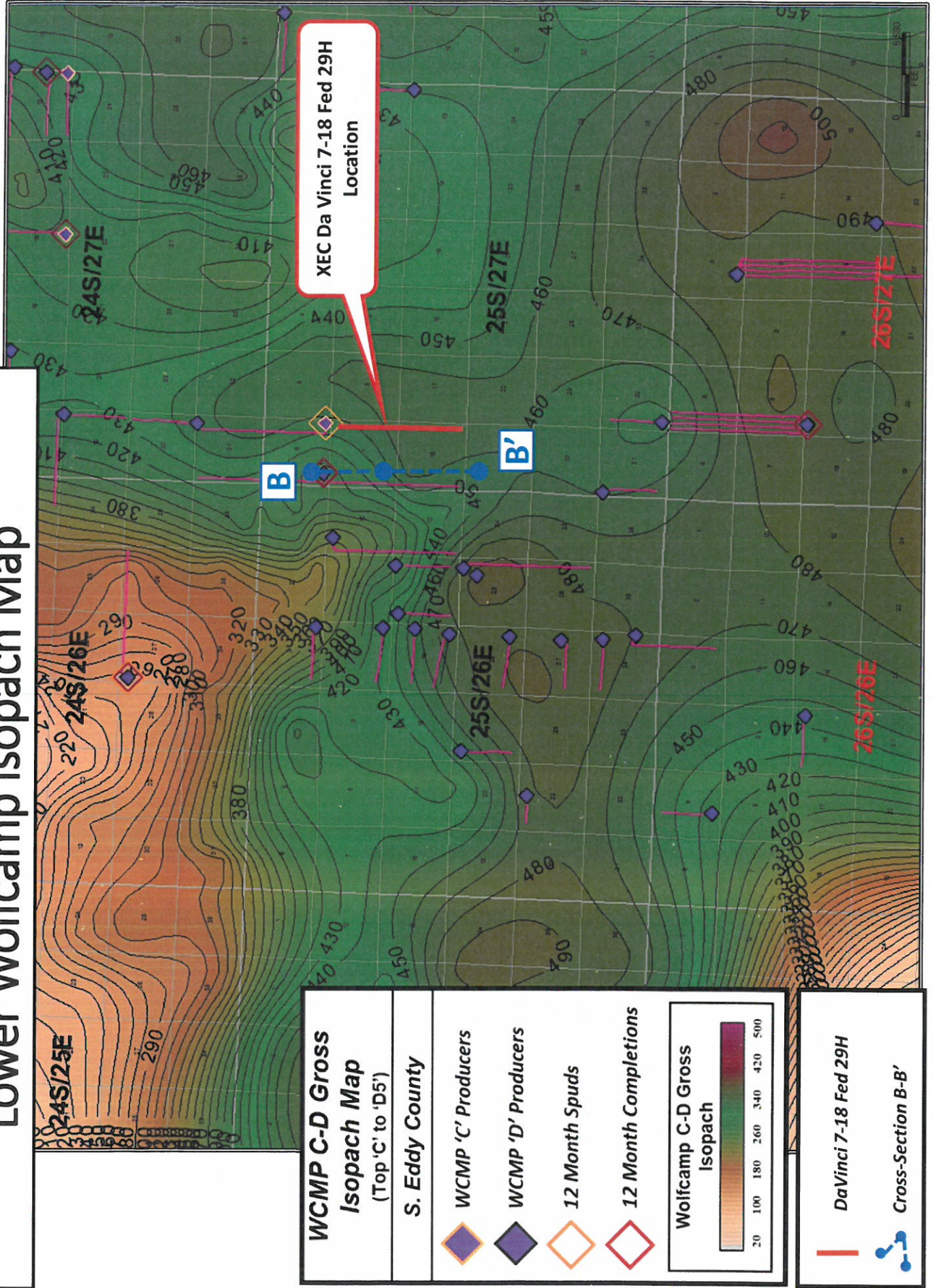
Cross-Section Locator Map

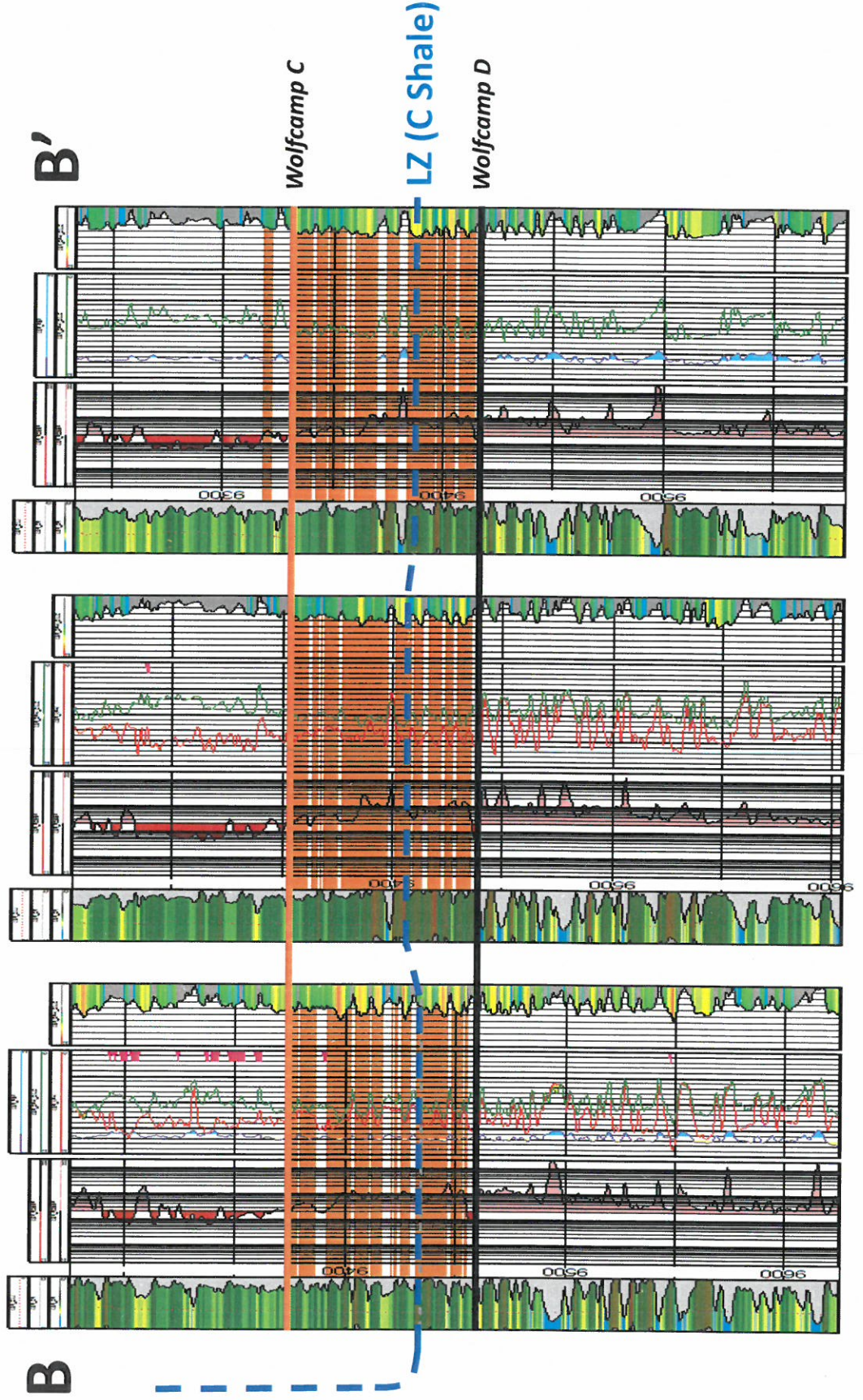

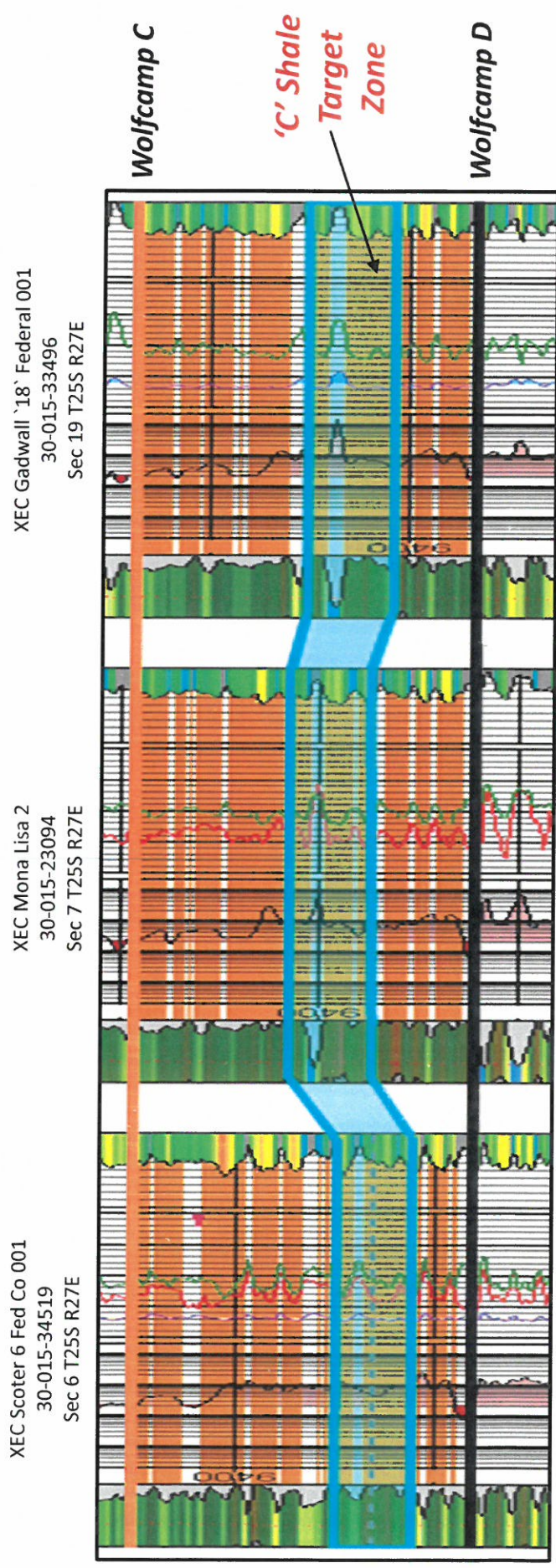

Lower Wolfcamp N-S Cross-Section B-B' – 'C' Shale LZ

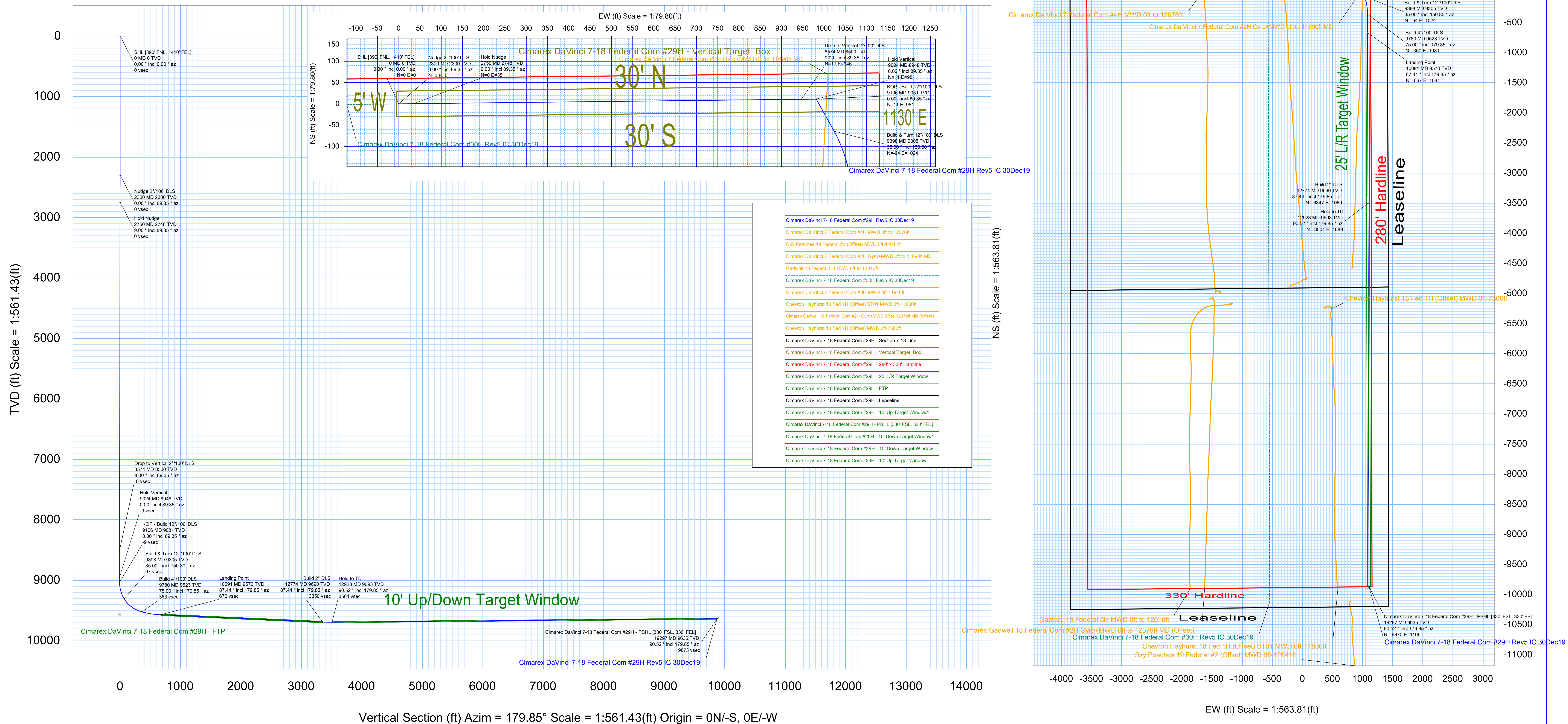
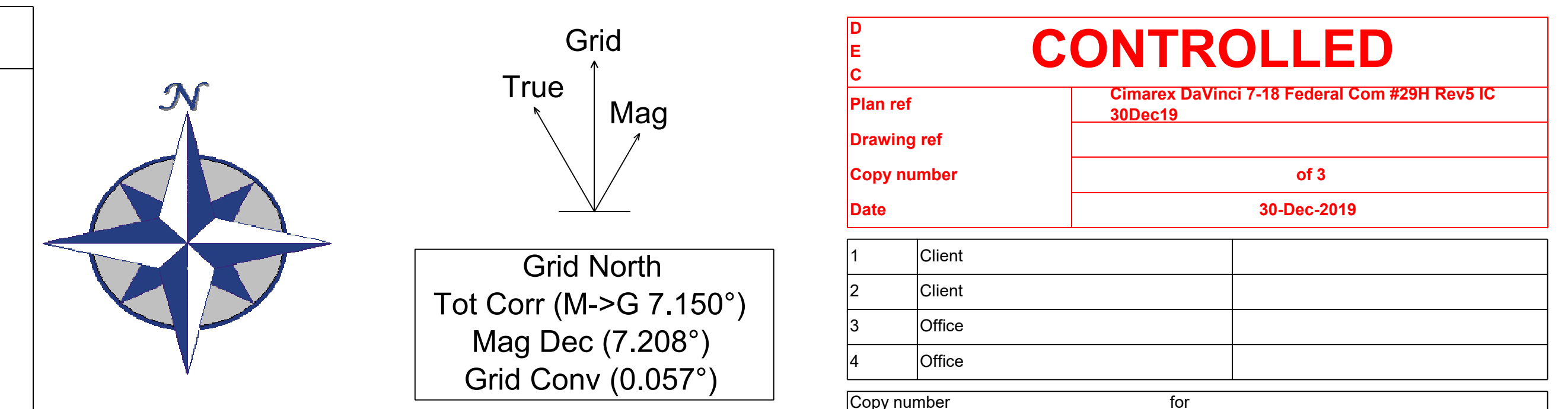
