Mr. Stone,

The WLC South Federal SWD #3 well application, was protested, has gone to hearing and been taken under advisement. Therefore, the change of location cannot be made outside of the hearing process and requires that the case be reopened for consideration of a new surface location. This would include re-notice of the SLO and NGL, as well as the standard notice under 19.15.4 NMAC.

Another option in this instance would be to dismiss case: # 20765 and submit a new application with the modified location. This application would then be able to be reviewed through the administrative process.
