6 Steward's application seeks an order pooling
7 interests in the 480 acre spacing unit comprised of the W/2
8 of Section 23 and NW/4 of Section 26, Township 13 South,
9 Range 38 East in Lea County. And it is in the San Andres
10 formation.

11 We have provided the affidavit of the landman and
12 geologist, and our compulsory pooling checklist is behind
13 the index. And so the landman Exhibit Number A 11 and A 12
