APPLICANT'S STATEMENT OF THE CASE

Devon seeks an order: (1) pooling all uncommitted interests in the Bone Spring formation (Livingston Ridge; Bone Spring (39350)) underlying a standard 960-acre, more or less, horizontal spacing unit comprised of the E/2 of Sections 15, 22, and 27, Township 23 South, Range 31 East, NMPM, Eddy County, New Mexico; and (2) dedicating the horizontal spacing unit to the following initial proposed wells:

- (1) The **Maldives 15-27 Fed Com #234H Well**, to be drilled from a surface hole location in the SW/4 SE/4 (Unit O) of Section 10 to a bottom hole location in the SW/4 SE/4 (Unit O) of Section 27;

- (2) The **Maldives 15-27 Fed Com #235H Well**, and (3) the **Maldives 15-27 Fed Com #236H Well**, both of which are to be drilled from surface hole locations in the SE/4 SE/4 (Unit P) of Section 10 to bottom hole locations in the SE/4 SE/4 (Unit P) of Section 27.

The completed interval for the **Maldives 15-27 Fed Com #235H Well** will remain within 330 feet of the W/2 E/2 of Sections 15, 22, and 27 to allow inclusion of these proximity tracts in a standard 960-acre horizontal well spacing comprised of the E/2 of Sections 15, 22, and 27.
