This is for 20 pooling the E/2 E/2 of Section 7 in Township 22 South, Range 21 34 East in Lea County, New Mexico. 22 23 And as provided here in the packets, you have 24 Exhibit A, the landman portion. 25 The geology portion, which again is the affidavit
