And Ameredev has requested that Case Numbers 8 21152 and 21153 be consolidated for purposes of this 9 hearing. LUCK: Thank you. On April 14 Ameredev 18 Operating submitted its package of exhibits for these two 19 cases to the Division by e-mail. 20 21 Included with the packet of exhibits are the pooling application checklists for both cases, as well as 22 copies of the applications. Also included in the exhibit 23 24 packet are the affidavit of Brandon Forteza who is the 25 landman in this case. And the geologist, Parker Foy, both

Page 4 of them provide the standard land and geology exhibits for 1 these two pooling cases. Both of these pooling cases 2 request standard spacing unit to be created in the Wolfcamp 3 4 formation in Lea County, New Mexico. And then behind Exhibit E and F are the notice 5 information that reflect that notice was timely provided to 6 7 the parties to be pooled in these two cases. In both cases 8 Ameredev only seeks to pool working interest owners, and a 9 couple of the notices were not delivered, so we also 10 published these cases out of an abundance of caution. So those notices of publication are provided behind Exhibit F. 11 12 And with that, I would ask that the cases be 13 taken under advisement, and I would move the admission of 14 Exhibits A through F. 15 HEARING EXAMINER ORTH: All right. Thank you. Exhibits A through F are admitted. Mr. Coss, do you have 16 17 questions of Ms. Luck. 18 EXAMINER COSS: I don't have any questions at 19 this time. Thank you.
