1 HEARING EXAMINER ORTH: Moving then to case

- 2 Number 21161, WPX Energy, a compulsory pooling matter, well
- 3 name Beagle 35.
- 4 Is someone here from Montgomery and Andrews for
- 5 this matter?
- 6 MS. SHAHEEN: Good morning, Madam Examiner,
- 7 Sharon Shaheen on behalf of WXP Energy LLC.
- 8 HEARING EXAMINER ORTH: Thank you. I have no
- 9 other appearances at this moment. Let me pause for just a
- 10 moment to see if anyone speaks up.
- 11 (No response.)
- 12 HEARING EXAMINER ORTH: No? Please proceed.
- 13 MS. SHAHEEN: First I will note that I did submit
- 14 material at about 4:30 on Tuesday, however, due to a
- 15 technical glitch, the compulsory checklists were not
- 16 included behind the appropriate tab. So then I resent it
- 17 yesterday with the checklist, and it was a large file
- 18 because there was a lot of notices. So we had to send it by
- 19 share file link, and in the abundance of caution, last night
- 20 I took all the certified green cards off and then
- 21 recirculated the exhibits to OCD Hearings and directly by
- 22 e-mail, so if anyone has access to that, they can look at
- 23 the material.
- 24 These are cases that -- in which we filed amended
- 25 applications to previous cases that are still pending, and

- that's Case Number 20450 and 20451. Those cases were heard
- 2 on July 12, 2019, and the Hearing Examiners at that time had
- 3 a few questions. So in these amended applications we did
- 4 two things.
- 5 One is, we determined there are additional
- 6 parties that needed to be noted, and second, we at added one
- 7 well to each application, so now each application has two
- 8 wells.
- 9 So what I have done with the exhibit package is I
- 10 tried to put everything in, in the current package that the
- 11 Hearing Examiner will need, the Division will need to -- to
- 12 fully evaluate and take this case under advisement.
- 13 And so just running through the table of
- 14 contents, Tab 1 and Tab 2 we have the checklist. Tab 3 and
- 15 4, we have the the second amended application for the Beagle
- 16 wells and an amended application for the Collie well.
- 17 Tab 5 we have a supplemental affidavit of the
- 18 landman with exhibits and it provides all the necessary
- 19 information, and particularly the answers to the questions
- 20 from the July hearing, from the Examiners from the July
- 21 hearing about notice and about depth severance. Turns out
- 22 there was no depth severance in the Wolfcamp, so he
- 23 addresses that in his affidavit.
- Tab 6 we have the affidavit of the geologist with
- 25 his exhibit. These exhibits apply to both cases.

1 HEARING EXAMINER ORTH: So, Ms. Shaheen, if I

- 2 could interrupt you for just a moment.
- 3 MS. SHAHEEN: Yes.
- 4 HEARING EXAMINER ORTH: Before you began your
- 5 presentation, I had called only 21161, which relates to the
- 6 well named Beagle 35. I had not called 21162 because it
- 7 related to a well that's called Collie 35 -- someone
- 8 obviously loves dogs here.
- 9 But as I understand your presentation, you are
- 10 presenting as to both, and I just wanted to clarify the
- 11 transcript on that point.
- 12 MS. SHAHEEN: Thank you very much. I appreciate
- 13 that. These are wells in the Sections 34 and 35 of Township
- 14 22 South, and Range 27 East, and the Beagle wells are the
- 15 south half and the Collie wells are the north half.
- 16 HEARING EXAMINER ORTH: Thank you.
- 17 MS. SHAHEEN: Jumping back in with respect to the
- 18 affidavit of the geologist, who we included everything
- 19 that's required by the checklist. And finally Tab 7,
- 20 affidavit of notice, which is very large.
- 21 What I can say is that I have identified those
- 22 folks where notice was undeliverable and where we did not
- 23 receive returned receipts, but in an abundance of caution,
- 24 we published to everyone, so I believe the notice was
- 25 sufficient.

Page 6 With that I would ask that exhibits be admitted 1 2 into the record, and that's these two cases be taken under advisement. 3 HEARING EXAMINER ORTH: All right, thank you. 4 5 Mr. Coss, do you have questions? EXAMINER COSS: I wanted to ensure that 6 7 additional wells being proposed were standard location? MS. SHAHEEN: Yes, that is what the landman 8 9 represents in his affidavit. HEARING EXAMINER ORTH: Okay. Thank you. Well, 10 I will check with Marlene to ensure these exhibits were --11 that she received everything necessary, but other than that 12 13 I don't have any questions. 14 MS.
