Page 3 HEARING EXAMINER ORTH: We will be moving next to 1 22 on the list which, is Case Number 21145, applicant, 2 Foundation Energy, salt water disposal, application for a 3 4 well, Blue Quail, but we have an agreement, based upon a request from counsel to call this matter only after 10 a.m. 5 6 MR. MANI: Yes, Madam Examiner, that's my 7 understanding. I'm Phil Mani of Mani, Little & Wortman on 8 behalf of Foundation Energy, the applicant. 9 HEARING EXAMINER ORTH: Thank you very much, 10 Mr. Mani. And who is here from Holland & Hart? MR. RANKIN: Madam Examiner, Adam Rankin with the 11 12 law firm of Holland & Hart on behalf of Devon Energy. 13 HEARING EXAMINER ORTH: All right. 14 Thank you both, and I will call on you again once 15 we get to 10 a.m. MR. MANI: Thank you, Madam Hearing Examiner. 16 17 (Pause in proceeding.) 18 HEARING EXAMINER ORTH: So let me ask, now we have come to the end of the worksheet with the exception of 19 the petition 21145. A few more minutes before I can call 20 that. Oh, I see Mr. Ames. 21 22 MR. AMES: I'm ready and available. 23 HEARING EXAMINER ORTH: Okay, terrific. 24 Mr. Mani, are you -- yes, I see you. 25 MR. MANI: Yes, Madam Examiner.

Page 4 HEARING EXAMINER ORTH: Okay. And let me call it 1 then. And Mr. Rankin, I see you as well. 2 Okay. So this is case Number 21145, Foundation 3 4 Energy, salt water disposal application, well named Blue 5 Quail. Applicant's counsel, Mr. Mani is on. Mr. Rankin is on for Devon, and Mr. Ames is on for the Division. 6 7 Prehearing statement was filed by the applicant. 8 Do I understand that this is a status conference? 9 MR. MANI: Yes, Madam Examiner. 10 HEARING EXAMINER ORTH: Okay. If you would, Mr. Mani, kick us off. 11 12 MR. MANI: Case Number 21145 is Foundation's 13 application for authorization to recomplete and operate a 14 non-commercial salt water injection well to dispose of 15 produced salt water from Foundation's nearby wells. The well to be recompleted is the Blue Quail 16 Federal Number 1 well located in the SE/4 of Section 7, 17 township 23 South, Range 32 East, Lea County, about 30 miles 18 southwest of Eunice. An injection will be into the Bell 19 Canyon formation between 4640 feet and 4850 feet subsurface 20 through casing perforations. 21 22 The disposal of salt water will be from produced water from Foundation's wells only, and the maximum 23 24 injection pressure will be about 928 psi. The status is 25 that the application was opposed by Devon Energy and by the

Page 5 Division. NGL Permian also entered an appearance which has 1 2 now been withdrawn after discussions with, with us. Presently Foundation is interested in proceeding 3 4 with a virtual hearing, and we are in discussions with 5 Devon's attorney, Adam Rankin, to try to come to a stipulated order. 6 HEARING EXAMINER ORTH: Okay, thank you. 7 8 Mr. Rankin, do you have anything to add? 9 MR. RANKIN: Nothing at this time, Madam 10 Examiner, other than we have broached the topic of preparing a prehearing order outlined with the Division's guidelines. 11 Our preference would be to have some time to confer with the 12 13 parties, with Division counsel, as well as counsel for 14 Foundation to prepare a proposed and stipulated prehearing order. 15 HEARING EXAMINER ORTH: All right, thank you. 16 Mr. Ames, anything to add? 17 MR. AMES: Yes, thank you, Ms. Orth. 18 Just two points. First I would like to let 19 Mr. Mani know that he may have misunderstood our entry of 20 appearance as opposition. But I think we, we, too, would 21 like to confer with y'all regarding the joint stipulation as 22 23 well as the Division's concerns regarding the application. 24 So I would like to invite you to call me to 25 discuss the issues further but we also would like to be part

hearing.

3 HEARING EXAMINER ORTH: Okay. Thank you. So 4 what I would like to do is the same thing as I requested of 5 counsel in a few of the previous cases. Mr. Mani, if you 6 would, to the extent possible, finalize a stipulated 7 prehearing order and send it to my e-mail.

8 Again, I'm in the New Mexico Bar Directory. And 9 Mr. Rankin and Mr. Ames, to the extent that you find 10 ultimately that you are not able to stipulate to the entirety of the pretrial order and you have some alternate 11 12 language or alternate dates, if you would then go ahead and 13 e-mail that to me as well, we'll get on a -- a prehearing 14 conference call as necessary and we will march toward 15 hearing.

MR. MANI: Yes, Madam Examiner. May I just say to Mr. Ames' point, we were anticipating just getting into at least preliminary agreements with Devon before reaching out to Mr. Ames, and we, certainly we're -- we're hoping for a stipulated order with all three parties, if possible.

HEARING EXAMINER ORTH: Terrific, thank you. Is there anything else on this matter before I say I look forward to the e-mail from you? MR. MANI: No, ma'am.
