1 HEARING EXAMINER ORTH: Moving then to Number

- 2 6 -- well, 6 and 7, really, Case Numbers 21264 and 21265,
- 3 COG Operating, again compulsory pooling applications for a
- 4 well named Green Beret.
- Is that you, Mr. Feldewert?
- 6 MR. FELDEWERT: Yes, ma'am, Madam Examiner.
- 7 Michael Feldewert of the Santa Fe Office of Holland & Hart
- 8 appearing on behalf of the applicant in these consolidated
- 9 cases.
- 10 HEARING EXAMINER ORTH: Thank you. Let me pause
- 11 for a moment.
- 12 (No audible response.)
- 13 HEARING EXAMINER ORTH: Please go ahead.
- 14 MR. FELDEWERT: In these consolidated cases, COG
- 15 is seeking to pool the same acreage, but to Case 21264 it's
- in the Bone Spring, and for 21265 it's in the Wolfcamp.
- 17 We have provided the compulsory pooling
- 18 checklist, and then the applications themselves. But as
- 19 part of our hearing package you will see an affidavit from
- 20 Megan Tipton who has previously testified before this
- 21 Division. And she identifies in the application that the
- 22 company seeking to pool working interest, unleased mineral
- 23 interest owners, a group of non-participating royalty, and
- 24 then some estates that have some title issue. She provides
- 25 the usual affidavits that she's seen in the pool -- I'm

- 1 sorry -- the usual exhibits that you see in these pooling
- 2 cases. And that comprises all of Exhibit A.
- 3 Exhibit B is the affidavit of Brian Sitek. He is
- 4 the geologist for the company who likewise has previously
- 5 testified before this Division. He has provided a structure
- 6 map for both the Bone Spring and then the upper portion of
- 7 the, of the Wolfcamp.
- 8 He has also provided for you a stratigraphic
- 9 cross section of both the Second Bone Spring Sand, which is
- 10 one of the target intervals. And then the same
- 11 stratigraphic cross section but in the lower part of it
- 12 showing the Third Bone and then the upper Wolfcamp which is
- 13 the target intervals for the remaining wells.
- We have also provided as Exhibit C, the affidavit
- of notice of the filing of these applications, and then the
- 16 hearing.
- 17 And then finally, because we had some estates and
- 18 heirs, heirs of those estates, we have an affidavit or
- 19 affidavits of publication which comprise Exhibit D and in
- 20 both Case 21264 and 21265. The percentage of interest that
- 21 the company seeks to pool here is very small. I did some
- 22 quick math, and I think it's only around 3 percent. COG
- 23 owns the -- has control of the main, and you will see those
- 24 percentages on Page 27 of what we submitted which is part of
- 25 Exhibit A-3.

1 With that, we move to ask that Exhibits A, B, C

- 2 and D be admitted into evidence and that both of these
- 3 matters be taken under advisement.
- 4 HEARING EXAMINER ORTH: All right. Thank you.
- 5 Ms. Murphy, do you have questions of Mr. Feldewert?
- 6 EXAMINER MURPHY: Good morning, Mr. Feldewert. I
- 7 do have another question on this one. So Tap Rock and
- 8 Meridian which owns some of those percent, they don't
- 9 object?
- 10 MR. FELDEWERT: Correct.
- 11 EXAMINER MURPHY: And so they are mile and a half
- 12 laterals?
- 13 MR. FELDEWERT: Yes, in both Bone Spring and the
- 14 Wolfcamp.
- 15 EXAMINER MURPHY: And it's not a test area, it's
- 16 an area with producing wells?
- 17 MR. FELDEWERT: Take a look at Exhibit --
- 18 EXAMINER MURPHY: Exhibit 5?
- 19 MR. FELDEWERT: Do you have the exhibits? I'm
- 20 actually on Page 56, which is part of the Exhibit B-6. You
- 21 will see there is an area of development map that shows the
- 22 orientation of the existing wellbores both in the --
- 23 EXAMINER MURPHY: Okay.
- MR. FELDEWERT: In the Wolfcamp and Bone Spring.
- 25 So that gives a pretty good idea of the extent of the

Page 6 surrounding development. 1 2 EXAMINER MURPHY: Thank you very much. I have no 3 more questions. MR. FELDEWERT: Thank you. 4 5 HEARING EXAMINER ORTH: Thank you, Ms. Murphy.
