In Case No. 21399, Devon seeks an Order for (1) creating a standard 316.44-acre, more or less, spacing and proration unit comprised of the W/2 W/2 of Sections 30 and 31, Township 23 South, Range 35 East, NMPM, Lea County, New Mexico, and (2) pooling all uncommitted mineral interests in the Bone Spring formation (ANTELOPE RIDGE; BONE SPRING [Pool Code 2200])

underlying said unit. Devon proposes for the HSU its **Red Bull 30-31 Fed State Com 1H Well**, an oil well, to be horizontally drilled from a surface location in NE/4 NW/4 (Unit C) of Section 30 to a bottom hole location in the SW/4 SW/4 (Lot 4) of Section 31.
