### **STATEMENT OF THE CASE**

Applicant in the above-styled cause seeks an order pooling all uncommitted interests in the Wolfcamp formation, Purple Sage Wolfcamp Gas Pool (98220), underlying a standard 1280-acre, more or less, horizontal spacing unit comprised of all of Sections 29 and 32, Township 24 South, Range 28 East, Eddy County, New Mexico. Applicant seeks to dedicate the above-referenced horizontal spacing unit to the to the following proposed wells:

- Tomahawk Federal Unit #701H to be drilled from a surface hole location in SE/4SE/4 (Unit P) of Section 20 to a bottom hole location in the SE/4SE/4 (Unit P) of Section 32;
- Tomahawk Federal Unit #702H to be drilled from a surface hole location in SE/4SE/4 (Unit P) of Section 20 to a bottom hole location in the SW/4SE/4 (Unit O) of Section 32;
- Tomahawk Federal Unit #703H to be drilled from a surface hole location in SE/4SW/4 (Unit N) of Section 20 to a bottom hole location in the SE/4SW/4 (Unit N) of Section 32;
- Tomahawk Federal Unit #704H to be drilled from a surface hole location in SE/4SW/4 (Unit N) of Section 20 to a bottom hole location in the SE/4SW/4 (Unit N) of Section 32;
- Tomahawk Federal Unit #705H to be drilled from a surface hole location in SE/4SW/4 (Unit N) of Section 20 to a bottom hole location in the SW/4SW/4 (Unit M) of Section 32.

The completed interval for the proposed Tomahawk Federal Unit #703H well will be within 330' of the line separating the W/2 and the E/2 of Sections 29 and 32 to allow inclusion of this acreage into a standard 1280-acre, more or less, horizontal well spacing unit.

Also, to be considered will be the cost of drilling and completing the wells, the allocation of the cost thereof, the actual operating costs and charges for supervision, the designation of applicant as operator, and the imposition of 200% charge for risk involved in drilling and completing each well. Said area is located approximately 3 miles south of Malaga, New Mexico.
