1 HEARING EXAMINER ORTH: We will move to 21372 and
2 21373. The applicant is Kaiser-Francis, compulsory pooling
3 application, and the well is Mosaic. Mr. Bruce, are you
4 here for Kaiser-Francis?

5 MR. BRUCE: Yes, I am.

6 HEARING EXAMINER ORTH: All right. I don't see
7 another appearance, but let me pause a moment to see if
8 there are any others this morning?

9 (No response.)

10 HEARING EXAMINER ORTH: No, hearing nothing,
11 please go ahead, Mr. Bruce.

12 MR. BRUCE: Yes. In these cases Kaiser-Francis
13 seeks to force pool collectively the N/2 N/2 of Section 24,
14 23 South, 28 East, and the N/2 of Section 19, 23, 29 East
15 for two Second Bone Spring wells. They are force pooling
16 the entire Bone Spring formation, but this is for the
17 initial wells are Second Bone Spring wells.

18 The only party being pooled is Chevron USA Inc.
19 which owns approximately 78 acres of fee land collectively
20 in the two well units. Notice has been given and the
21 landman's affidavit contains the usual proposal letters and
22 AFEs, et cetera, and a geologic presentation is made with
23 each, with each case.

24 And I was just checking to make sure I attached
25 the, the pooling checklist, which I did. There is no --

1 since actual notice was received by Chevron, there is no
2 affidavit of publication.

3 And with that, I move the admission of exhibits 1
4 through 5 in each case and as that the two cases be taken
5 under advisement.

6 HEARING EXAMINER ORTH: All right. Thank you,
7 Mr. Bruce. Mr. McClure, do you have any questions of Mr.
8 Bruce.

9 EXAMINER McCLURE: No, ma'am, I have no questions
10 at this time.

11 HEARING EXAMINER ORTH: Thank you. Mr. Garcia?

12 EXAMINER GARCIA: I do not, either.

13 HEARING EXAMINER ORTH: All right. Thank you.
14 Exhibits 1 through 5 in each matter are admitted, and the
15 matter is taken under advisement.
