Page 3 1 (Time noted 8:38 a.m.) 2 HEARING EXAMINER ORTH: Let's move then to 3 Matters 21390 and 21391. The Applicant is Mewbourne Oil, 4 Compulsory Pooling application. The well in each case is 5 named Eastwatch. Mr. Feldewert, are you here again for the 6 7 Applicant? 8 Oh, no, sorry. It's Hinkle, Shanor. MS. HARDY: Yes. Good morning. Dana Hardy from 9 the Santa Fe office of Hinkle, Shanor on behalf of 10 Mewbourne Oil Company. 11 12 HEARING HEARING EXAMINER ORTH: All right. Thank you. Mr. Feldewert, I trust you are here for MRC 13 Permian. 14 15 MR. FELDEWERT: Yes, Madam Examiner. 16 HEARING EXAMINER ORTH: Let me pause a moment to 17 see if there are any other appearances. No. 18 Ms. Hardy. MS. HARDY: Thank you, Madam Examiner. 19 We requested a status conference in these 20 21 matters because MRC Permian has filed applications this 22 week that compete with Mewbourne's applications, so it looks like at this point we need to get a date for a 23 24 contested hearing. I know that MRC's applications aren't 25 set currently for today, but we are hoping to get the

Page 4 Eastwatch applications set and then be able to have the 1 2 MRC applications added to that hearing, if possible. 3 HEARING EXAMINER ORTH: Okay. So I'm looking at the calendar. 4 5 Mr. Feldewert, when do you anticipate the MRC cases? They have already been filed but not set? Is 6 7 that my understanding? 8 MR. FELDEWERT: Madam Examiner, they were filed on Tuesday of this week so they will be listed on the 9 October 8th docket. 10 Uhm, the current -- I mean, just to blur 11 12 the line here, Mewbourne's Eastwatch wells I think involve Sections 3 and 4, so they are lay down wells. MRC is what 13 14 they call their deep wells, which are stand up wells 15 involving Sections 3 and 10, that's the first group, and 16 then the second group involves Sections 4 and 9. So they overlap at Sections 3 and 4, which creates the conflict. 17 18 So I anticipate if the parties cannot reach 19 an agreement that we are going to need a hearing date, and it will be your typical debate over whether the wells 20 21 should be stand up or lay down, and how it should be oriented. 22 23 So I suspect each party will have three 24 WITNESSES, and so it could take perhaps a day. 25 So again, ours will be on the docket on

1 October 8th.

2 HEARING EXAMINER ORTH: Okay. So I'm looking at 3 the calendar for that -- for October 8th. I have a line 4 drawn through most of the week there to handle the Ridge 5 Runner hearings. And then the following session is October 6 7 the 22nd. We have two special hearings already set there. We already have a special hearing set November 5th from --8 two special hearings set in connection with the November 9 19th hearing. 10 The next hearing date would be December 11 12 3rd. There are no special hearings set in connection with the December 3rd docket. 13 14 We do already have a special hearing set in 15 connection with December 17th. 16 What do you think about December 3rd for 17 all of these matters? MS. HARDY: Madam Examiner, we think that if 18 that's the earliest date that we could get, then I think 19 that would work. I'll have to confirm my WITNESSES' 20 21 availability, but that sounds reasonable to me. 22 HEARING EXAMINER ORTH: Okay. Mr. Feldewert? 23 MR. FELDEWERT: We too will endeavor to make 24 that work. 25 HEARING EXAMINER ORTH: All right. So I will

Page 6 talk with Marlene about what that means for the MRC 1 2 Permian matters. 3 Is there any reason then to have it on the 4 October 8th docket, or should we just set it on the December 3rd? 5 MR. FELDEWERT: Well, let me suggest as 6 7 applications that were filed and in the course of Notice 8 that will go out will reflect a hearing date of October the 8th, so I think probably they should remain on the 9 October 8th docket, and then can be called, and at that 10 time we will be able to then I think effectively move it 11 12 to the hearing date that's available. 13 HEARING EXAMINER ORTH: Okay. All right. Let's 14 see. 15 Mr. Cox, do you have any questions about 16 our discussion here? 17 MR. COX: No, ma'am. HEARING EXAMINER ORTH: Okay. Anything further, 18 19 Mr. Feldewert or Ms. Hardy? 20 MS. HARDY: Not for me, Madam Examiner. 21 MR. FELDEWERT: No, Madam Examiner. Thank you 22 very much. 23 HEARING EXAMINER ORTH: All right.
