- 2 HEARING EXAMINER ORTH: Let's move on, then, to
- 3 the next three matters, 21430, 21431 and 21432. The
- 4 Applicant is Mewbourne Oil. These are compulsory pooling
- 5 applications relating to a well named Iron Horse.
- 6 Mr. Bruce, you're here for the Applicant?
- 7 MR. BRUCE: Yes, I am.
- 8 HEARING EXAMINER ORTH: All right. When I went
- 9 to the file I saw only the application, and I did see some
- 10 email communication about bundling it with two other
- 11 matters -- what was it, 21379 and 80 for hearing on
- 12 November 19th -- but I have to confess I was confused by
- 13 that email. I don't remember discussing these three
- 14 matters in connection with the other two.
- 15 So first let me ask if there are other
- 16 appearances for these three.
- 17 MR. HOUGH: Madam Examiner, Lance Hough from
- 18 Modrall, Sperling on behalf of Colgate Operating, LLC.
- 19 HEARING EXAMINER ORTH: Okay. Any other
- 20 appearances this morning?
- No. All right. Mr. Bruce, if you would,
- 22 please.
- MR. BRUCE: Yes. Mr. Hough's client Colgate had
- 24 pooling matters set on the docket for August 6th, I
- 25 believe, and Mewbourne filed an entry of appearance in

1 those cases 21379 and 21380, so on that date a scheduling

- 2 conference on August 6th was heard, and Mr. Hough and I
- 3 preliminarily agreed on a hearing date, so that's why it
- 4 was moved to -- what was the date, November 19th?
- 5 HEARING EXAMINER ORTH: Yeah.
- 6 MR. BRUCE: And a couple of days before that
- 7 hearing, or right around the hearing date I did file these
- 8 three applications on behalf of Mewbourne.
- 9 And so what we have here is Colgate's
- 10 pooling applications, which are partially overlapped by
- 11 Mewbourne's applications, and I guess I was just under the
- 12 impression -- I couldn't find a transcript of what was
- 13 stated on the record of August 6th -- that these cases
- 14 were just going along with the Colgate cases; and I wasn't
- 15 aware that I needed to file a continuance motion, I
- 16 thought they would just be continued as a matter of
- 17 course. Obviously a continuance motion wasn't filed, but
- 18 I believe Mr. Hough and I both believe the cases need to
- 19 be heard together, and so that's why I filed no exhibits
- 20 and neither Mr. Hough nor I filed any Prehearing
- 21 Statements in these cases, these three cases.
- 22 So what I ask is that the cases be moved to
- 23 November 19th, whatever the date is in the Prehearing
- 24 Order on these other two cases, and if you need me to file
- 25 three continuance motions, I will do so.

1 HEARING EXAMINER ORTH: Okay. Yeah, filing the

- 2 continuance motions through the fee portal would be
- 3 necessary.
- 4 Let me just confirm with Mr. Hough that you
- 5 agree these are competing applications and need to be
- 6 heard in connection with 21379 and 21380, because --
- 7 MR. HOUGH: I do.
- 8 HEARING EXAMINER ORTH: You do.
- 9 I'm sorry, because the Prehearing Order
- 10 that was admitted in -- this is what confused me. The
- 11 Prehearing Order in 21379 and -80 didn't mention these
- 12 three.
- MR. BRUCE: Yeah. And I think that's because as
- 14 of the date that Mr. Hough put together the Scheduling
- 15 Order, the Prehearing Order, I don't know that I had case
- 16 numbers for these matters yet.
- 17 MR. HOUGH: Madam Examiner this is Lance Hough.
- Just wanted to add, you know, we agree with
- 19 Mr. Bruce's representations, and, you know, if it's
- 20 helpful we can submit an amended Prehearing Order that
- 21 would consolidate those, you know, as a matter of ease for
- 22 the Division.
- HEARING EXAMINER ORTH: All right. Well, thank
- 24 you for that.
- 25 So Mr. Bruce, if you would please file

Page 6 through the portal, --MR. BRUCE: I will. HEARING EXAMINER ORTH: -- and request November 19th. And, Mr. Hough, if you would please send us an Amended Prehearing Order just to keep us straight with everything that we will be doing on November 19th. MR. BRUCE: Thank you. MR. HOUGH: Thank you. HEARING EXAMINER ORTH: Thank you, Mr. Bruce and Mr. Hough. (Time noted 9:31 a.m.)
