APPLICANT'S STATEMENT OF THE CASE

In **Case No. 21433**, Devon seeks an order: (1) pooling all uncommitted interests in the Bone Spring formation (James Ranch; Bone Spring, East [Pool code 96919]) underlying a 960-acre standard horizontal spacing unit comprised of the W/2 of Sections 14, 23, and 26, Township 23 South, Range 31 East, NMPM, Eddy County, New Mexico; and (2) dedicating this horizontal spacing unit to the following proposed initial wells:

- a. **Galapagos 14-26 Fed Com 211H well** (API No. 30-015-47287) to be horizontally drilled from a surface hole location in the NW/4 NW/4 (Unit D) of Section 14 to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 26;
- b. **Galapagos 14-26 Fed Com 212H well** (API No. 30-015-47295) to be horizontally drilled from a surface hole location in the NW/4 NW/4 (Unit D) of Section 14 to a bottom hole location in the SE/4 SW/4 (Unit N) of Section 26; and
- c. **Galapagos 14-26 Fed Com 213H well** (API No. 30-015-47290) to be horizontally drilled from a surface hole location in the NE/4 NW/4 (Unit B) of Section 14 to a bottom hole location in the SE/4 SW/4 (Unit N) of Section 26.

The completed interval for the proposed **Galapagos 14-26 Fed Com 212H well** will be within 330' of the quarter-quarter line separating the W/2 W/2 and the E/2 W/2 of Sections 14, 23, and 26 to allow inclusion of this acreage into a standard horizontal well spacing unit.

In **Case No. 21434**, Devon seeks an order: (1) pooling all uncommitted interests in the Bone Spring formation (James Ranch; Bone Spring, East [Pool code 96919]) underlying a 960-acre standard horizontal spacing unit comprised of the E/2 of Sections 14, 23, and 26, Township 23 South, Range 31 East, NMPM, Eddy County, New Mexico; and (2) dedicating this horizontal spacing unit to the following proposed initial wells:

- a. **Galapagos 14-26 Fed Com 214H well** (API No. 30-015-47289) to be horizontally drilled from a surface hole location in the NW/4 NE/4 (Unit B) of Section 14 to a bottom hole location in the SW/4 SE/4 (Unit O) of Section 26;
- b. **Galapagos 14-26 Fed Com 215H well** (API No. 30-015-47291) to be horizontally drilled from a surface hole location in the NE/4 NE/4 (Unit A) of Section 14 to a bottom hole location in the SE/4 SE/4 (Unit P) of Section 26; and

- c. **Galapagos 14-26 Fed Com 216H well** (API No. 30-015-47288) to be horizontally drilled from a surface hole location in the NE/4 NE/4 (Unit A) of Section 14 to a bottom hole location in the SE/4 SE/4 (Unit P) of Section 26.

The completed interval for the proposed **Galapagos 14-26 Fed Com 215H well** will be within 330' of the quarter-quarter line separating the E/2 E/2 and the W/2 E/2 of Sections 14, 23, and 26 to allow inclusion of this acreage into a standard horizontal well spacing unit.


