In Case No. 21396, Devon seeks an Order for 1) creating a standard 320-acre, more or less, spacing and proration unit comprised of the E/2 E/2 of Sections 30 and 31, Township 23 South, Range 35 East, NMPM, Lea County, New Mexico, and (2) pooling all uncommitted

mineral interests in the Bone Spring formation (ANTELOPE RIDGE; BONE SPRING [Pool Code 2200]) underlying said unit. **Red Bull 30-31 Fed State Com 4H Well**, an oil well, to be horizontally drilled from a surface location in NW/4 NE/4 (Unit B) of Section 30 to a bottom hole location in the SE/4 SE/4 (Unit P) of Section 31.
