The wells are located in Section 31, Township 25 South, Range 33 East, NMPM and Section 6, Township 26 South, Range 33 East, NMPM.

The wells were timely commenced under the orders. Ordering Paragraph (7) in Order No. R-20405, and Ordering Paragraph (6) in Order Nos. R-20740 through 20743, require commencement of completion operations within one year of well commencement. As set forth above, well completions are not scheduled to be commenced in the time fixed by the orders. This was due to operational reasons (KFOC desired to drill a number wells so that they could be completed more or less simultaneously to minimize costs), and due to adverse economic conditions beginning early this year.

Pursuant to each order, KFOC requests an extension of the well completion deadlines through January 31, 2021.
