- 8 on behalf of Franklin Mountain Energy LLC.
- 9 HEARING EXAMINER ORTH: Thank you. I see no
- 10 other appearances. Let me pause for a moment to see if
- 11 there will be any other appearances.

- 13 HEARING EXAMINER ORTH: Hearing nothing, if you
- 14 would, please.
- 15 MS. BENNETT: Good morning. Case Number 21442 is
- 16 the companion case to 21440 and 21439. This case involves
- 17 the W/2 E/2 of Sections 1 and 12, and the NW/4 of the NE/4
- 18 of Section 13, Township 26 South, Range 35 East, in Lea
- 19 County.
- 20 The application materials are in the exhibit
- 21 packet that I presented, which I did also e-mail -- I should
- 22 have said that for the last case -- to the Division on
- 23 Tuesday before 5.
- 24 But the exhibit packet includes again on Page 9
- 25 the overview of the development plan which identifies the

- 1 wells that Franklin Mountain Energy is seeking on the units
- 2 that Franklin Mountain Energy is seeking in the entire
- 3 development plan.
- 4 This case for the Katson Fed Com 603H well is a
- 5 Bone Spring well. We've included with this application or
- 6 these exhibit materials Ms. Albrechts' affidavit, our
- 7 landman. As I mentioned before, Ms. Albrecht has previously
- 8 testified before the Division and her credentials were
- 9 accepted as a matter of record.
- 10 Behind her affidavit are the application, the
- 11 C-103, the lease tract map, along with the breakout of the
- ownership, the recapitulation table, as well as the summary
- 13 of contacts of working interest owners, the proposal letter
- 14 and the AFE.
- 15 Also behind her affidavit is my notice affidavit
- 16 where I testify that I did timely send out notice letters
- 17 and published.
- 18 Behind that material is Mr. Kessel's affidavit,
- 19 and Mr. Kessel is the geologist, and he has previously
- 20 testified before the Division. And behind his geology
- 21 tab -- excuse me -- behind his geology affidavit are the
- 22 usual geologic slides including a locator map, a gunbarrel,
- 23 wine rack view of the proposed development, structure map,
- 24 cross section, the cross section well identified, and a
- 25 gross interval isochore.
