1 HEARING EXAMINER ORTH: Let's move then to the

- 2 next about, what is it, about eight matters.
- 3 (Audio interference.)
- 4 HEARING EXAMINER ORTH: Okay. 21447, 21448,
- 5 21449, 21450, 21451, 21452, 21453, 21454, Matador
- 6 Production, and it's the application (unclear). These are
- 7 compulsory pooling applications. I'm not sure where that
- 8 noise is coming from.
- 9 Okay. The well name is Young Deep. Is that you,
- 10 Mr. Feldewert, on behalf of the applicant?
- MR. FELDEWERT: Yes, Madam Examiner. Good
- 12 morning.
- 13 HEARING EXAMINER ORTH: Good morning. I see
- 14 appearances from EOG. Who here is from Modrall Sperling for
- 15 EOG?
- 16 REPORTER: Ms. Orth, I'm sorry, can I cut in
- 17 here. This is the court reporter. I'm getting a lot of
- 18 background noise. I'm not sure where it's coming from.
- 19 HEARING EXAMINER: Okay. Let's see.
- 20 REPORTER: Is it from Deana?
- 21 HEARING EXAMINER: I didn't see that it was from
- 22 Deana.
- 23 REPORTER: She's not muted, from what I can see.
- 24 HEARING EXAMINER: Oh, it stopped. Okay. No, it
- 25 didn't stop. How's that?

1 REPORTER: Let's go ahead and try that and see

- 2 how it does.
- 3 HEARING EXAMINER: All right. I actually muted
- 4 Mr. Feldewert. We might be getting some feedback from a
- 5 nearby device.
- 6 So, let's see. Mr. Hough, you are appearing on
- 7 behalf of EOG. Sorry to interrupt you.
- 8 MR. HOUGH: No problem. Just entering my
- 9 appearance on behalf of EOG Resources.
- 10 HEARING EXAMINER ORTH: Thank you. I see an
- 11 appearance as well from Mewbourne. Was that you, Ms. Hardy,
- 12 from Hinkle Shanor?
- 13 MS. HARDY: Yes, it is. Good morning, Madam
- 14 Examiner. Dana Hardy from Mewbourne Oil company.
- 15 HEARING EXAMINER ORTH: Thank you. Let me pause
- 16 a moment to see if there are any other appearances this
- 17 morning.
- 18 (No audible response.)
- 19 HEARING EXAMINER ORTH: I hear nothing. We have
- 20 you on the schedule for a status conference -- and I hear
- 21 the noise again. And, Mr. Feldewert, let's (audio
- 22 interference). Mr. Feldewert, do you have a device nearby?
- MR. FELDEWERT: I do not. I don't know if it's
- 24 me, or I see Deana is not muted.
- 25 HEARING EXAMINER ORTH: Let's see here.

- 1 MS. BENNETT: Can you all hear me?
- 2 HEARING EXAMINER ORTH: I'm going to mute Deana
- 3 here. Mute -- okay, I muted Deana. Have I muted everyone?
- 4 Is that what I just did? Let's see here. Now I have muted
- 5 everyone. All right, I didn't mean to do that. I was
- 6 trying to mute Deana.
- 7 I will -- let's see, I need to unmute
- 8 Mr. Hough -- Mr. Feldewert, it's definitely -- it's
- 9 definitely you, Mr. Feldewert. But let's proceed with
- 10 the -- let's proceed with the status conference. And I
- 11 have unmuted Ms. Hardy. So I'm going to mute myself, and if
- 12 you would, please, tell me where you are.
- 13 MR. FELDEWERT: Sure. Matador's wells on these
- 14 eight cases involve Bone Spring formation, seeking eight
- 15 spacing units involving basically stand-up wells in Sections
- 16 4 and 9 and then stand-up wells in Sections 3 and 10.
- 17 They compete with Mewbourne's East Watch Wells,
- 18 which are lay-down wells in Sections 3 and 4. And we have,
- 19 you recall that this matter -- the Mewbourne wells were
- 20 called for hearing at the September 10 docket. At that time
- 21 we discussed a December 3 hearing date. It's my
- 22 understanding that Mewbourne desires an earlier hearing date
- 23 due to a lease expiration issue.
- 24 Matador does not object to that; Ms. Hardy and I
- 25 have discussed the potential time frame. So that's where we

1 are with these cases. I will let Ms. Hardy take it from

- 2 there.
- 3 MS. HARDY: Thank you, Mr. Feldewert. Mr.
- 4 Feldewert is correct. We talked about an earlier hearing
- 5 date. Mewbourne does have a lease expiration issue and was
- 6 hoping for a date prior to December. Really, the sooner the
- 7 better for Mewbourne. Mr. Feldewert, and I have discussed,
- 8 I believe, November 3 and November 5, and November 5 is a
- 9 regular docket. Either of those dates would work for
- 10 Mewbourne if those dates might be a possibility for Madam
- 11 Hearing Examiner.
- 12 HEARING EXAMINER ORTH: Okay. Thank you, Mr.
- 13 Feldewert and Ms. Hardy. Mr. Hough, do you have anything to
- 14 add?
- MR. HOUGH: Just add, you know, I guess, the
- 16 reason that EOG, it appears that they had not, I quess,
- 17 received the Matador applications. And I'm not saying they
- 18 weren't sent, I'm just saying they hadn't received a
- 19 thorough (unclear). So they weren't aware of these until
- 20 recently. They actually just pulled these off the docket,
- 21 so they're still -- the reason for all of this, they are
- 22 still evaluating their position on the Matador cases. You
- 23 know, it's happening real time right now that they are
- 24 evaluating their position on it.
- With regard to the Mewbourne case, (unclear)

1 proceeding earlier, and so at this point, I guess I'm just

- 2 preserving the fact that EOG can't say one way or the other
- 3 whether they are strictly opposed to a November setting on
- 4 the 3rd, the 5th, but I understand Mewbourne is seeking that
- 5 because of its time with its lease expiration, so I'm just
- 6 preserving that for the record at this moment. It doesn't
- 7 necessarily have any basis to take a strong opposition to
- 8 the, to the request for a November setting, but anything
- 9 after that is fine, too.
- 10 HEARING EXAMINER ORTH: All right. Thank you,
- 11 Mr. Hough. So I'm looking on November 3rd and 5th, and at
- 12 the moment there is one contested hearing that I believe is
- 13 still scheduled for November 5. I have on the calendar
- 14 written down 20964. I don't remember anything about 20964,
- 15 but I do have it down now on November 5.
- 16 Ms. Hardy, do you have an estimate as to how long
- 17 this hearing will be?
- 18 MS. HARDY: I think it would take one day at the
- 19 most.
- 20 HEARING EXAMINER ORTH: So we could potentially
- 21 take a full day, and I am not available on November 6 at
- 22 all, we might perhaps want to distract ourselves from
- 23 November 3rd, and -- right? I'm available that day. Let me
- 24 confirm with Marlene that it would be okay to offer that
- 25 date. Marlene? Marlene?

1 MS. SANDOVAL: So Tuesday, November 3rd?

- 2 HEARING EXAMINER ORTH: Yes.
- 3 MS. SANDOVAL: Okay. I mean, whatever works,
- 4 I'll just have to let my boss know that I won't attend a
- 5 meeting, but I'm good with that.
- 6 HEARING EXAMINER ORTH: Good, thank you. And I
- 7 believe we need to also make some pre-arrangements with the
- 8 court reporter. So, Irene?
- 9 REPORTER: Yes, good to go.
- 10 HEARING EXAMINER ORTH: Terrific. Myself and I
- 11 and the court reporter are available on November 3rd, and we
- 12 can set the -- set this hearing for 21447 through 21454 for
- hearing on November 3rd, and let's begin at 8:30.
- 14 MR. FELDEWERT: Madam Examiner, I assume also
- 15 then -- would you like -- do you need a prehearing order?
- 16 HEARING EXAMINER ORTH: Yes, please.
- 17 MR. FELDEWERT: At that time then I think Ms.
- 18 Hardy will add the Mewbourne cases because I don't think
- 19 they have been set, yet. Have they, Ms. Hardy?
- 20 MS. HARDY: No. We were hoping to setting them
- 21 altogether, yes.
- 22 HEARING EXAMINER ORTH: All right. Thank you for
- 23 that. Is there anything else we need to talk about then?
- 24 (No audible response.)
- 25 HEARING EXAMINER ORTH: No? Mr. Simmons, do you

Page 9 have any questions about what was just discussed? TECHNICAL EXAMINER SIMMONS: No, ma'am. Thank you. HEARING EXAMINER ORTH: All right. Thank you all very much. We will see you on November 3rd. MS. HARDY: Thank you. HEARING EXAMINER ORTH: Terrific. (Concluded.)
