1 HEARING EXAMINER ORTH: Let's move then to 21461,
2 Catena Resources, another compulsory pooling application.
3 The well name is Rambo.

4 Ms. Luck, are you counsel for the applicant?

5 MS. LUCK: That's correct. I will be presenting
6 these affidavits.

7 HEARING EXAMINER ORTH: All right. Thank you. I
8 didn't see any other appearances. Let me pause for a moment
9 to see if there are any appearances this morning.

10 (No audible response.)

11 HEARING EXAMINER ORTH: No.? I did see a
12 prehearing statement by the applicant, so if you would,
13 please, go ahead.

14 MS. LUCK: Thank you. The next case, Catena
15 understood that there would be no opposition to the case
16 proceeding by affidavit, and so Catena's exhibits were again
17 filed on Tuesday.

18 The exhibits include the standard compulsory
19 pooling application checklist, and a copy of the filed
20 application.

21 And then Catena's Exhibit A is the landman
22 affidavit, and he testifies that in this case Catena is
23 seeking an order pooling all uncommitted interest in the
24 Wolfcamp formation underlying a standard 640-acre spacing
25 unit in the W/2 of Sections 8 and 17, and this is in

1 Township 19 South, Range 35 East, Lea County, New Mexico.

2 This is, again, a single-well spacing unit at
3 this point and will be dedicated to the Rambo 193517 3H
4 well. And this well is again a proximity tract well, which
5 will remain within 330 feet of the W/2 of the E/2 of
6 Sections 8 and 17 to create a larger horizontal spacing
7 unit, and that's because this well is located in the Scharb
8 Wolfcamp Pool, Pool Code 55640, which is that 40-acre oil
9 pool.

10 Catena also provides the standard land exhibits,
11 including a C-102, a location map, tract and unit recap
12 reflecting the owners to be pooled into this spacing unit.

13 Catena's landman testifies there is no depth
14 severance underlying the acreage, and he also provides
15 copies of the well proposal letters, AFE, and a record of
16 his contact with uncommitted interest owners.

17 Next Catena Exhibit B is the geology affidavit
18 for this development, and again, Mr. Smith has testified
19 before the Division, and he provides the standard Wolfcamp
20 structure map, cross section map and cross section. And he
21 testifies that the development of this spacing unit by a
22 horizontal well is in the best interest of conservation, the
23 prevention of waste and the protection of correlative
24 rights.

25 Finally, as Catena Exhibits C and D, we provided

1 the notice affidavit and notice of publication which
2 reflects that notice of this pooling hearing was timely
3 provided to interest owners to be pooled in this case.

4 So with that, I would move the admission of
5 Catena Exhibits A through D and request that this case be
6 taken under advisement.

7 HEARING EXAMINER ORTH: Thank you, Ms. Luck. Mr.
8 Simmons, do you have any questions?

9 TECHNICAL EXAMINER SIMMONS: No. Everything
10 appears to be in order. Thank you.

11 HEARING EXAMINER ORTH: Thank you. Your exhibits
12 are admitted and Matter 21461 will be taken under
13 advisement.

14 MS. LUCK: Thank you.
