In Case No. 21522, Devon seeks an order (1) creating a standard 320-acre, more or less, spacing and proration unit comprised of the N/2 S/2 of Sections 13 and 14, Township 21 South, Range 27 East, NMPM, Eddy County, New Mexico, and (2) pooling all uncommitted mineral

interests in the Wolfcamp formation (ALACRAN HILLS UPPER WOLFCAMP OIL [98314]) underlying said unit.
