APPLICATION

Longfellow Energy, LP (“Longfellow”), through its undersigned counsel Montgomery & Andrews, P.A. (Sharon T. Shaheen and John F. McIntyre), hereby files this application with the Oil Conservation Division pursuant to the provisions of NMSA 1978, § 70-2-17, for an order pooling all mineral interests in the Yeso formation (Empire; Glorieta-Yeso [96210]) in a standard 320-acre, more or less, horizontal spacing and proration unit (“HSU”) comprised of the S/2 of Section 13, Township 17 South, Range 28 East, NMPM, in Eddy County, New Mexico. In support of its application, Longfellow states as follows:

1. Longfellow is a working interest owner in the proposed HSU and has the right to drill thereon.
2. Longfellow proposes to drill the following 1-mile wells in the proposed HSU:
 - **Hendrix State Com 13CD 001H** well, to be horizontally drilled from an approximate surface hole location 1387’ FSL and 175’ FEL of Section 14, T17S-R28E, to an approximate bottom hole location 2315’ FSL and 20’ FEL of Section 13, T17S-R28E.
 - **Hendrix State Com 13CD 002H** well, to be horizontally drilled from an approximate surface hole location 1362’ FSL and 175’ FEL of Section 14, T17S-

R28E, to an approximate bottom hole location 1820' FSL and 20' FEL of Section 13, T17S-R28E.

- **Hendrix State Com 13CD 003H** well, to be horizontally drilled from an approximate surface hole location 1337' FSL and 175' FEL of Section 14, T17S-R28E, to an approximate bottom hole location 1330' FSL and 20' FEL of Section 13, T17S-R28E.
- **Hendrix State Com 13CD 004H** well, to be horizontally drilled from an approximate surface hole location 1312' FSL and 175' FEL of Section 14, T17S-R28E, to an approximate bottom hole location 835' FSL and 20' FEL of Section 13, T17S-R28E.
- **Hendrix State Com 13CD 005H** well, to be horizontally drilled from an approximate surface hole location 1287' FSL and 175' FEL of Section 14, T17S-R28E, to an approximate bottom hole location 390' FSL and 20' FEL of Section 13, T17S-R28E.

3. The completed intervals and first and last take points will meet the setback requirements set forth in the statewide rules for horizontal oil wells.

4. Longfellow has in good faith sought and been unable to obtain voluntary agreement for the development of these lands from all of the mineral interest owners in the HSU.

5. Approval of the HSU and the pooling of all mineral interest owners in the Yeso formation underlying the HSU will avoid the drilling of unnecessary wells, prevent waste, and protect correlative rights.

6. In order to permit Longfellow to obtain its just and fair share of the oil and gas underlying the subject lands, all uncommitted interests in this HSU should be pooled and Longfellow should be designated the operator of the HSU.

WHEREFORE, Longfellow requests that this application be set for hearing before an Examiner of the Oil Conservation Division on November 5, 2020, and that, after notice and hearing as required by law, the Division enter an order:

A. Creating a standard 320-acre, more or less, HSU comprised of the S/2 of Section 13, Township 17 South, Range 28 East, NMPM, in Eddy County, New Mexico;

B. Pooling all mineral interests in the Yeso formation underlying the HSU;

C. Allowing the drilling of the following 1-mile wells in the HSU: (1) Hendrix State Com 13CD 001H, (2) Hendrix State Com 13CD 002H, (3) Hendrix State Com 13CD 003H, (4) Hendrix State Com 13CD 004H, and (5) Hendrix State Com 13CD 005H.

D. Designating Longfellow as operator of the HSU and the wells to be drilled thereon;

E. Authorizing Longfellow to recover its costs of drilling, equipping and completing the wells;

F. Approving the operating charges and costs of supervision while drilling of \$8,000/month and, after completion, \$800/month, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and

G. Imposing a 200% penalty for the risk assumed by Longfellow in drilling and completing the wells against any interest owner who does not voluntarily participate in the drilling of the wells.

AFFIDAVIT OF RYAN CULPEPPER

I, being duly sworn on oath, state the following:

1. I am over the age of 18 and have the capacity to execute this Affidavit, which is based on my personal knowledge.
2. I am employed as a Land Manager with Longfellow Energy, LP (“Longfellow”), and I am familiar with the subject applications and the lands involved.
3. This affidavit is submitted in connection with the filings by Longfellow of the above referenced compulsory pooling applications pursuant to 19.15.4.12.A(1) NMAC.
4. I have not previously testified before the New Mexico Oil Conservation Division as an expert witness in petroleum land matters. My education and work experience are as follows: I graduated from the University of Oklahoma in 2006 with a Bachelor of Arts degree in Communications. I have been employed with Longfellow since 2009. Prior to being employed by Longfellow, I worked as a Landman and Land Coordinator in various states since 2006. I have been working on New Mexico oil and gas matters for approximately 3 years.
5. The purpose of these applications is to force pool working interest owners and uncommitted mineral interest owners into the horizontal spacing and proration unit (“HSU”) described below, and in the wells to be drilled in that unit.

6. No opposition is expected. The interest owners being pooled have been contacted regarding the proposed wells, but have failed or refused to voluntarily commit their interests in the wells.

7. In Case No. 21509, Longfellow seeks an order pooling all uncommitted interests in the Yeso formation (Empire; Glorieta-Yeso [96210]) in a standard 320 acre, more or less, HSU comprised of the S/2 of Section 13-17S-28E in Eddy County, New Mexico. Longfellow proposes to drill the following wells in the HSU:

- **Hendrix State Com 13CD 001H** well, to be horizontally drilled from an approximate surface hole location 1387' FSL and 175' FEL of Section 14, T17S-R28E, to an approximate bottom hole location 2315' FSL and 20' FEL of Section 13, T17S-R28E. The proposed true vertical depth is approximately 4,000' and the total measured depth is approximately 9,608'. The first take point will be located approximately 2,325' FSL and 100' FWL of Section 13-17S-28E and the last take point will be located approximately 2,315' FSL and 100' FEL of Section 13-17S-28E.
- **Hendrix State Com 13CD 002H** well, to be horizontally drilled from an approximate surface hole location 1362' FSL and 175' FEL of Section 14, T17S-R28E, to an approximate bottom hole location 1820' FSL and 20' FEL of Section 13, T17S-R28E. The proposed true vertical depth is approximately 4,400' and the total measured depth is approximately 9,891'. The first take point will be located approximately 1,830' FSL and 100' FWL of Section 13-17S-28E and the last take point will be located approximately 1,820' FSL and 100' FEL of Section 13-17S-28E.

- **Hendrix State Com 13CD 003H** well, to be horizontally drilled from an approximate surface hole location 1337' FSL and 175' FEL of Section 14, T17S-R28E, to an approximate bottom hole location 1330' FSL and 20' FEL of Section 13, T17S-R28E. The proposed true vertical depth is approximately 4,000' and the total measured depth is approximately 9,443'. The first take point will be located approximately 1,340' FSL and 100' FWL of Section 13-17S-28E and the last take point will be located approximately 1,330' FSL and 100' FEL of Section 13-17S-28E.
- **Hendrix State Com 13CD 004H** well, to be horizontally drilled from an approximate surface hole location 1312' FSL and 175' FEL of Section 14, T17S-R28E, to an approximate bottom hole location 835' FSL and 20' FEL of Section 13, T17S-R28E. The proposed true vertical depth is approximately 4,400' and the total measured depth is approximately 9,864'. The first take point will be located approximately 845' FSL and 100' FWL of Section 13-17S-28E and the last take point will be located approximately 835' FSL and 100' FEL of Section 13-17S-28E.
- **Hendrix State Com 13CD 005H** well, to be horizontally drilled from an approximate surface hole location 1287' FSL and 175' FEL of Section 14, T17S-R28E, to an approximate bottom hole location 390' FSL and 20' FEL of Section 13, T17S-R28E. The proposed true vertical depth is approximately 4,000' and the total measured depth is approximately 9,534'. The first take point will be located approximately 400' FSL and 100' FWL of Section 13-17S-28E and the last

take point will be located approximately 390' FSL and 100' FEL of Section 13 of 17S-28E.

The completed intervals and first and last take points for all wells will meet the setback requirements set forth in the statewide rules for horizontal oil wells. As is evident from the C-102s attached hereto as Exhibit A-6, the units are slightly irregular such that the distance from the south line of the section to the south line of the N/2 of the section is approximately 2,651 feet.

8. A general location map is included as Exhibit A-1.
9. Maps illustrating the tracts in the proposed HSU and the ownership of each individual tract can be found in the exhibit package as Exhibit A-2.
10. Exhibit A-3 is a list of owners in the HSU, with lease numbers and the location of the wellbores.
11. The ownership breakdown of interests and list of parties to be can be found at Exhibit A-4. There are no depth severances within the Yeso formation.
12. A chronology of contacts with the non-joined working interest owners is attached as Exhibit A-5.
13. The locations of the proposed wells within the respective HSUs are depicted in the draft C-102 forms attached as Exhibit A-6.
14. I have conducted a diligent search of the public records in Eddy County, NM, where the wells will be located, and conducted phone directory and computer searches to obtain contact information for parties entitled to notification. I mailed all parties well proposals, included an Authorization for Expenditure ("AFE") for each well. Way West Oil Co. has signed the JOA and Harry B. Hinkle has assigned their interest, so both parties can be dismissed from Case No. 21509.

15. Exhibit A-7 includes sample copies of the well proposal letters and AFEs for the proposed wells. The estimated costs for the wells set for in the AFEs are fair, reasonable and comparable to the costs of other wells of similar depths and lengths drilled in this area of New Mexico.

16. Longfellow has made a good faith effort to obtain voluntary joinder of the working interest owners in the proposed wells.

17. Exhibit A-8 includes copies of the notice letters that were sent with the applications to all of the uncommitted interest owners in the proposed HSUs.

18. Longfellow requests the Division to approve operating charges and costs of supervision while drilling of \$8,000/month and after completion, \$800/month, together with a provision adjusting the rates pursuant to the COPAS accounting procedures.

19. Longfellow requests the maximum cost, plus 200% risk charge, be assessed against non-consenting working interest owners.

20. Longfellow requests that it be designated operator of the wells.

21. The Exhibits to this Affidavit were prepared by me, or compiled from Longfellow's business records.

22. The granting of these Applications is in the interest of conservation, the prevention of waste and the protection of correlative rights.

23. The foregoing is correct and complete to the best of my knowledge and belief.

Longfellow Energy, LP (“Longfellow”), through its undersigned counsel Montgomery & Andrews, P.A. (Sharon T. Shaheen and John F. McIntyre), hereby files this application with the Oil Conservation Division pursuant to the provisions of NMSA 1978, § 70-2-17, for an order pooling all mineral interests in the Yeso formation (Empire; Glorieta-Yeso [96210]) in a standard 320-acre, more or less, horizontal spacing and proration unit (“HSU”) comprised of the S/2 of Section 13, Township 17 South, Range 28 East, NMPM, in Eddy County, New Mexico. In support of its application, Longfellow states as follows:

1. Longfellow is a working interest owner in the proposed HSU and has the right to drill thereon.
2. Longfellow proposes to drill the following 1-mile wells in the proposed HSU:
 - **Hendrix State Com 13CD 001H** well, to be horizontally drilled from an approximate surface hole location 1387’ FSL and 175’ FEL of Section 14, T17S-R28E, to an approximate bottom hole location 2315’ FSL and 20’ FEL of Section 13, T17S-R28E.
 - **Hendrix State Com 13CD 002H** well, to be horizontally drilled from an approximate surface hole location 1362’ FSL and 175’ FEL of Section 14, T17S-

R28E, to an approximate bottom hole location 1820' FSL and 20' FEL of Section 13, T17S-R28E.

- **Hendrix State Com 13CD 003H** well, to be horizontally drilled from an approximate surface hole location 1337' FSL and 175' FEL of Section 14, T17S-R28E, to an approximate bottom hole location 1330' FSL and 20' FEL of Section 13, T17S-R28E.
- **Hendrix State Com 13CD 004H** well, to be horizontally drilled from an approximate surface hole location 1312' FSL and 175' FEL of Section 14, T17S-R28E, to an approximate bottom hole location 835' FSL and 20' FEL of Section 13, T17S-R28E.

3. The completed intervals and first and last take points will meet the setback requirements set forth in the statewide rules for horizontal oil wells.

E. Authorizing Longfellow to recover its costs of drilling, equipping and completing the wells;

AFFIDAVIT OF HARVIN BROUGHTON

I, being duly sworn on oath, state the following:

1. I am over the age of 18 and have the capacity to execute this Affidavit, which is based on my personal knowledge.
2. I am a petroleum geologist employed as the Senior Geologist for Longfellow Energy, LP (“Longfellow”) and am familiar with the subject application and geology involved.
3. This affidavit is submitted in connection with the filings by Longfellow of the above referenced compulsory pooling application pursuant to 19.15.4.12.A(1) NMAC.
4. I have previously testified before the New Mexico Oil Conservation Division as an expert witness in petroleum geology matters. My credentials as a petroleum geologist have been accepted by the Division and made a matter of record. I have been employed with Longfellow Energy, LP as a Senior Geologist since 2020. Prior to working at Longfellow, I was with Concho Oil and Gas from 2008 to 2019. I have been working on New Mexico oil and gas matters for approximately fifteen years.
5. Exhibit B-1, provided for the above referenced application, is a geological summary, a regional map and a generalized stratigraphic column for the Northwest Shelf of the Delaware Basin.

6. Exhibit B-2 is a regional Yeso structure map with 50' contour intervals, which illustrates the location of the HSU by a red square.

7. Exhibit B-3 is a Spacing Unit Schematic showing the Yeso structure with 50' contour intervals, which illustrates the location of the HSU by a red square outlined in in red and the approximate locations of the proposed wells and whether the wells are considered bench 1 "Paddock" or bench 2 "Blinebry".

8. Exhibit B-4 is a type log of the production portion of the Yeso formation on the Northwest Shelf with and further defines bench 1 "Paddock" and bench 2 "Blinebry", within the Yeso formation. This type log was used to identify the key tops used to evaluate reservoirs and landing targets for the proposed wells.

8. Exhibit B-5 is a Yeso structural cross section map with 50' contour intervals with the location of the HSU outlined in in red and the approximate locations of the proposed wells and whether the wells are considered bench 1 "Paddock" or bench 2 "Blinebry".

9. Exhibit B-6 is the structural cross section and indicates that these wells are being placed in a zone that has an estimated gross interval thickness of 1,500'. This gross thickness is being calculated from the top of the Paddock to the top of the Tubb, within the Yeso formation.

10. Exhibit B-7 is a gunbarrel diagram depicting each well. These show the approximate landing zones in reference to the type log for the area and the associated spacing of the wellbores within the half-section width HSU.

11. The measured depths and true vertical depths for each well are approximately as follows:

12. The true vertical landing depth of the target formation is approximately 4,000' for the bench 1 "Paddock" wells (001H, 003H, 004H), and approximately 4,400' for the bench 2 "Blinbry" wells (002H and 004H) based on the structural cross section, Exhibit B-6.

13. Based on my geologic study of the area, I conclude the following:

- a. the horizontal spacing and proration units are justified from a geologic standpoint.
- b. There are no structural impediments or faulting that will interfere with horizontal development.
- c. Each quarter-quarter section in the units will contribute more or less equally to production.
- d. The preferred well orientation is east-west because there is no known and generally accepted preferential drilling orientation based on present-day stress regime or other geological factors. The vast majority of existing NW Shelf Yeso horizontal wells are oriented W-E, so an established trend is present. This orientation also fits our lease and surface availability aligns with the remainder of Longfellow's planned development in the adjoining tracts and therefore doesn't strand any acreage or reserves.

14. The Exhibits to this Affidavit were prepared by me, or compiled from Longfellow's business records.

15. The granting of these Applications is in the interest of conservation, the prevention of waste and the protection of correlative rights.

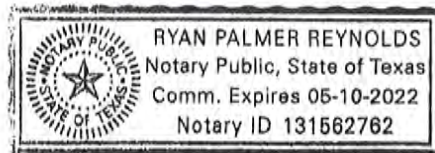

The vast majority of existing NW Shelf Yeso horizontal wells are oriented W-E, so an established trend is present. This orientation also fits our lease and surface availability aligns with the remainder of Longfellow’s planned development in the adjoining tracts and therefore doesn’t strand any acreage or reserves.

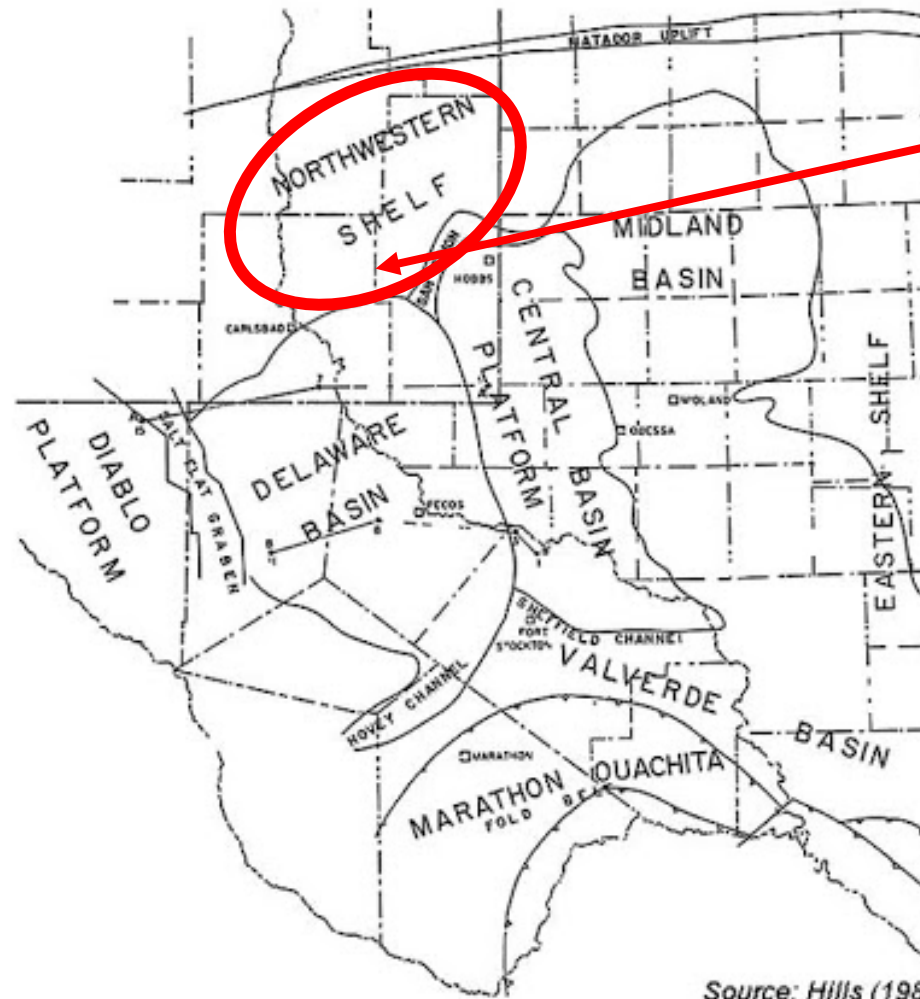

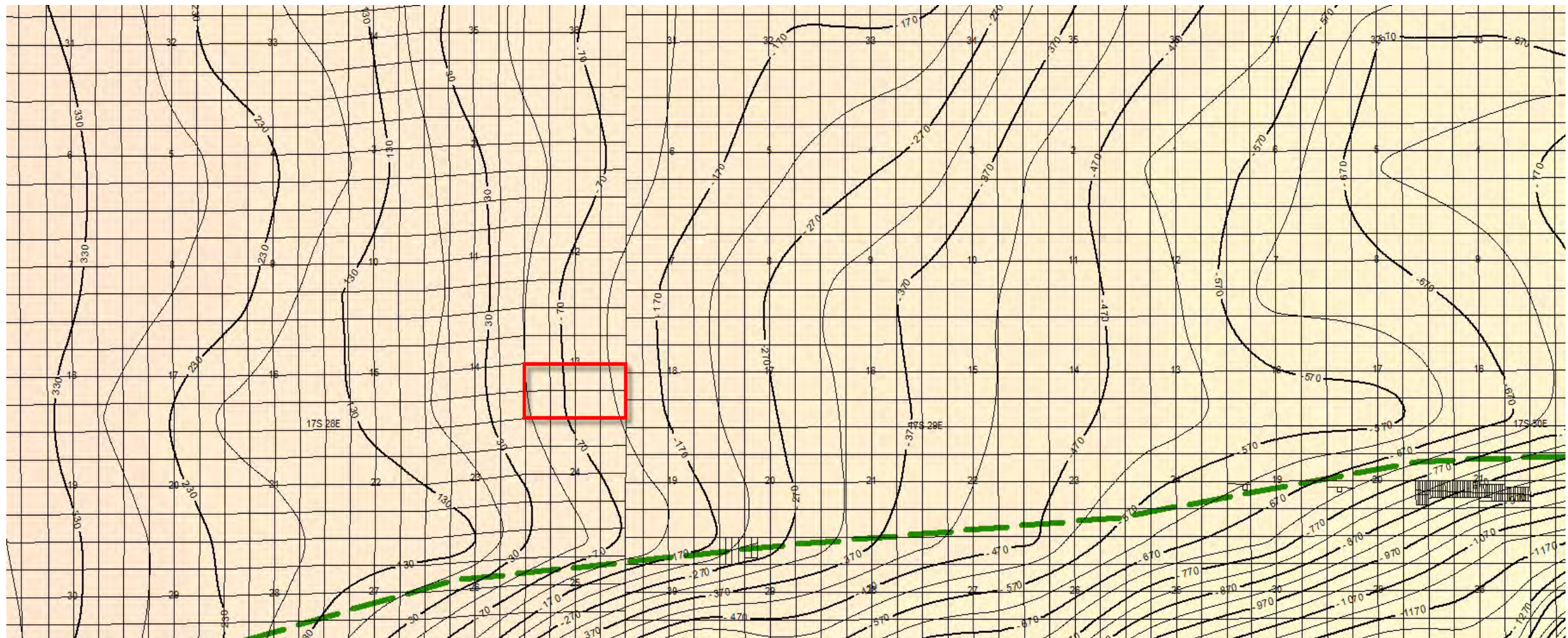

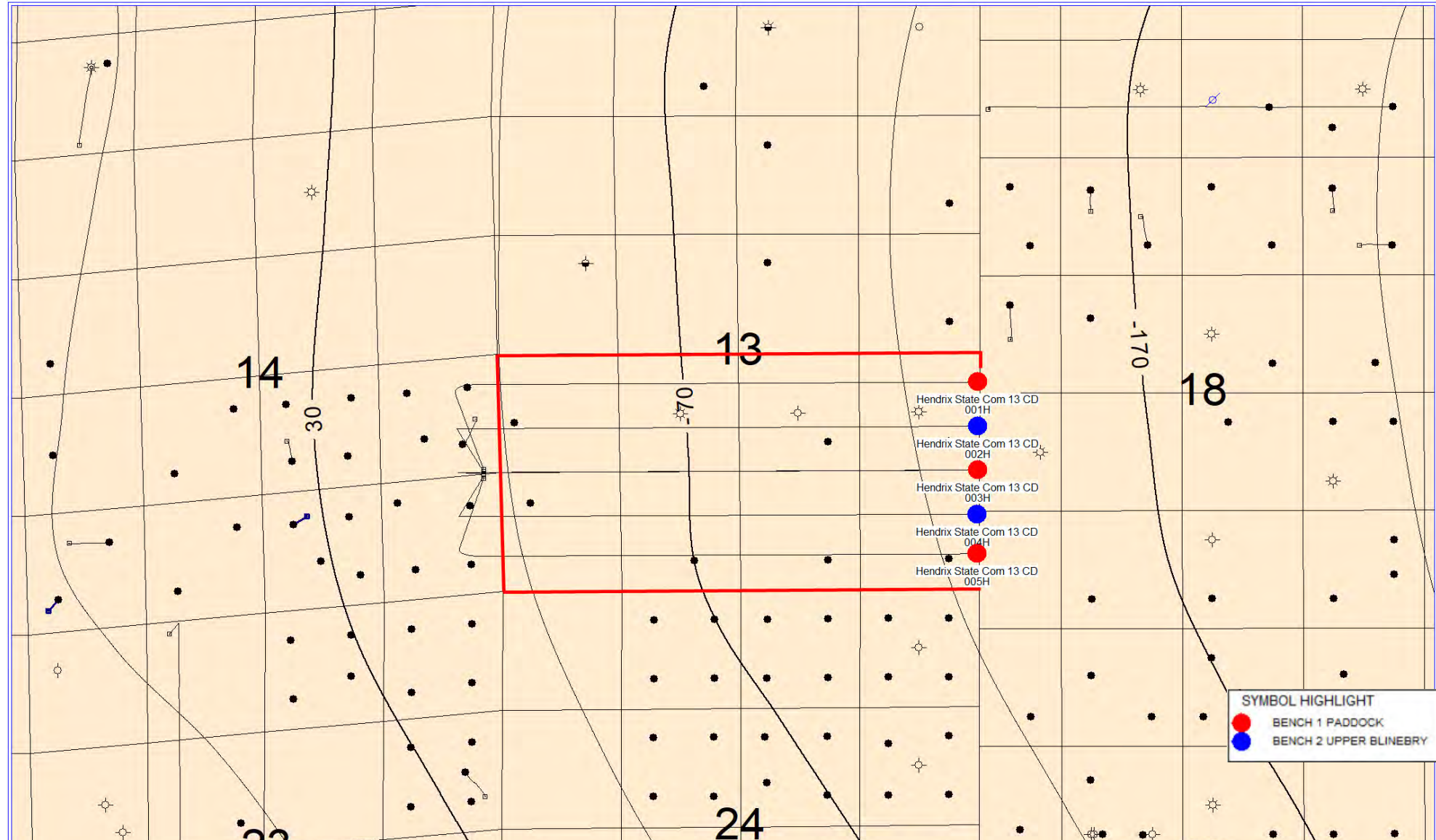

Spacing Unit Schematic

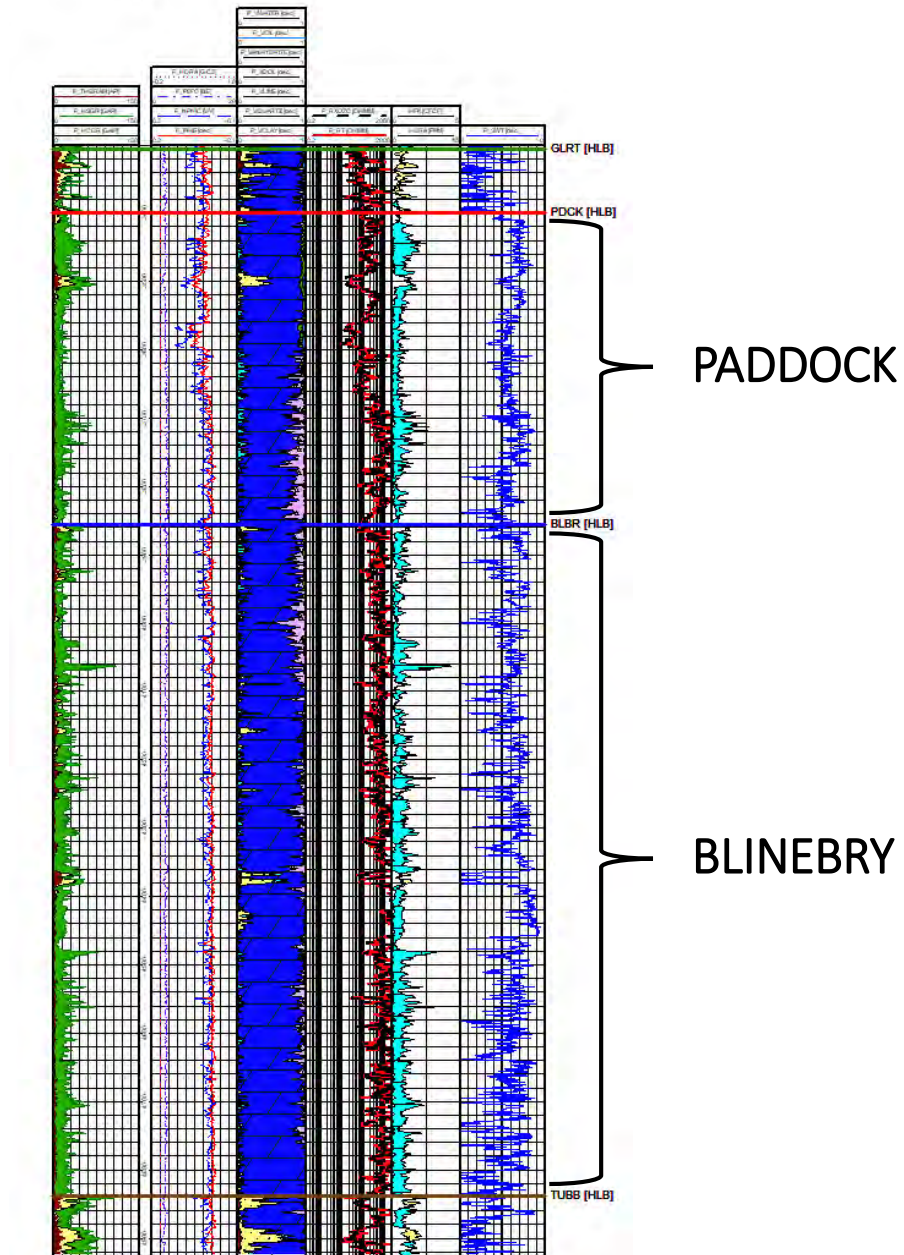

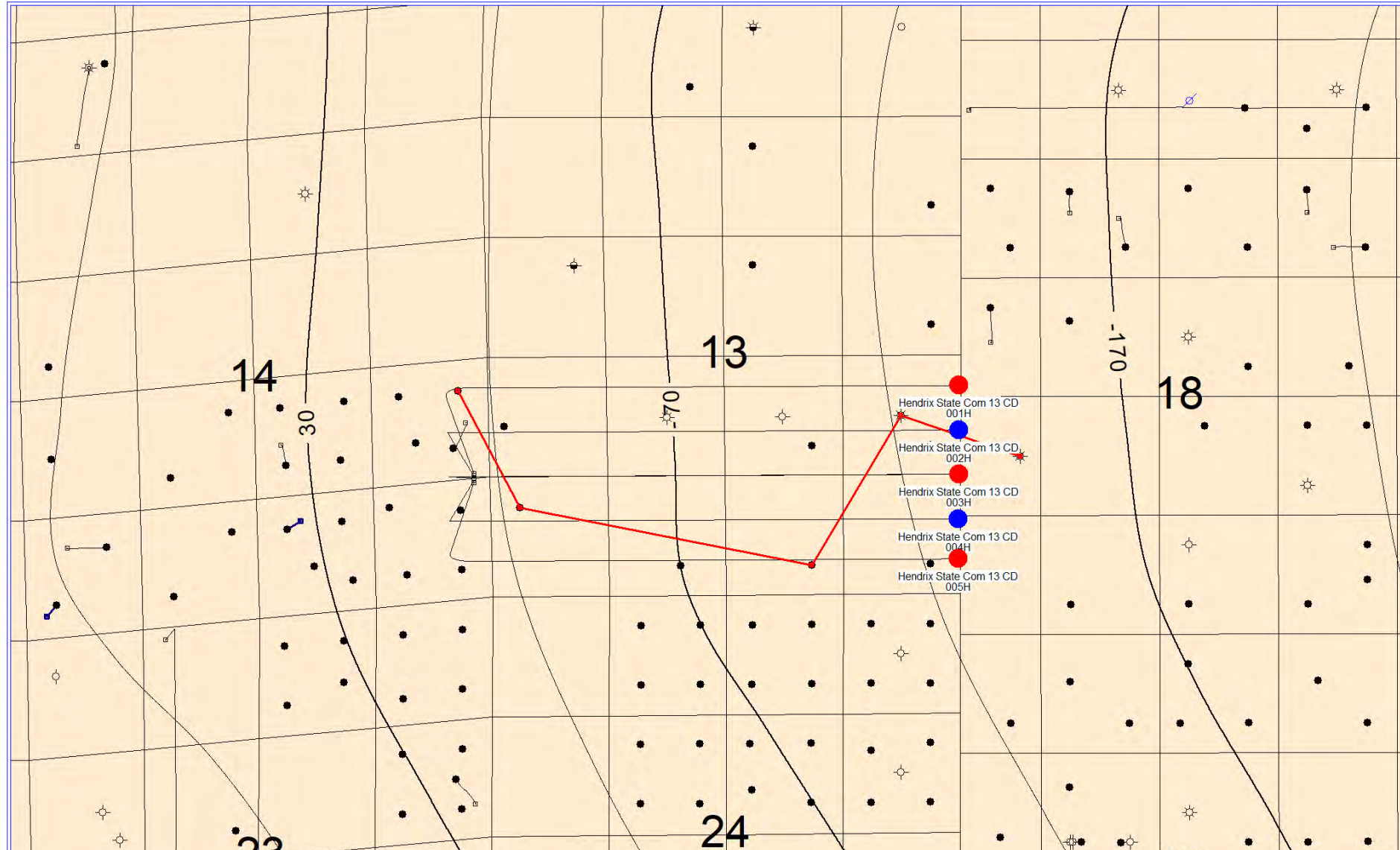
NW Shelf Yeso Type Log Showing Target Intervals

Hendrix Lease Cross Section Line

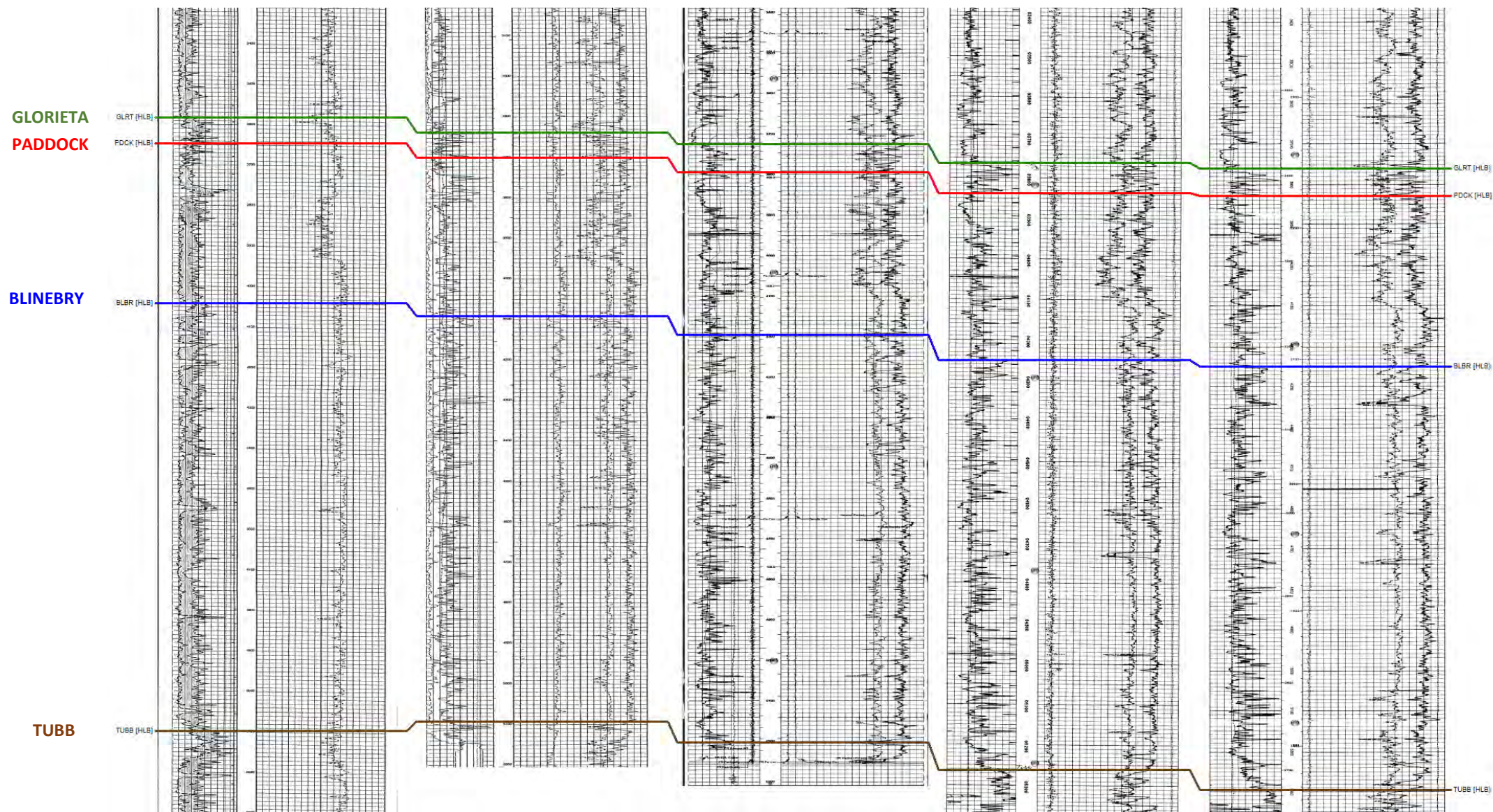

Applicant proposes to drill the following wells: (1) Hendrix State Com 13CD 001H well, to be horizontally drilled from an approximate surface hole location 1387' FSL and 175' FEL of Section 14, T17S-R28E, to an approximate bottom hole location 2315' FSL and 20' FEL of Section 13, T17S-R28E; (2) Hendrix State Com 13CD 002H well, to be horizontally drilled from an approximate surface hole location 1362' FSL and 175' FEL of Section 14, T17S-R28E, to an approximate bottom hole location 1820' FSL and 20' FEL of Section 13, T17S-R28E; (3) Hendrix State Com 13CD 003H well, to be horizontally drilled from an approximate surface hole location 1337' FSL and 175' FEL of Section 14, T17S-R28E, to an approximate bottom hole location 1330' FSL and 20' FEL of Section 13, T17S-R28E; (4) Hendrix State Com 13CD 004H well, to be horizontally drilled from an approximate surface hole location 1312' FSL and 175' FEL of Section 14, T17S-R28E, to an approximate bottom hole location 835' FSL and 20' FEL of Section 13, T17S-R28E; and (5) Hendrix State Com 13CD 005H well, to be horizontally drilled from an approximate surface hole location 1287' FSL and 175' FEL of Section 14, T17S-R28E, to an approximate bottom hole location 390' FSL and 20' FEL of Section 13, T17S-R28E. The completed intervals and first and last take points for these wells will meet statewide setback requirements for horizontal wells.
