1 HEARING EXAMINER ORTH: Let's move to Case 21479,
2 the applicant is Mewbourne Oil. This is a request to amend
3 an order in order to add additional parties. Ms. Hardy, I
4 think I see you from Hinkle Shanor.

5 MS. HARDY: Yes. Good morning, Madam Examiner.
6 Dana Hardy with the Santa Fe Office of Hinkle Shanor on
7 behalf of Mewbourne Oil Company.

8 HEARING EXAMINER ORTH: Thank you. And I don't
9 see other appearances made yet. Let me ask if there are any
10 at this time.

11 (No audible response.)

12 HEARING EXAMINER ORTH: No? All right.

13 And I do hear some shuffling, Ms. Hardy, and
14 it's -- I think it may interfere with our ability to hear
15 you.

16 MS. HARDY: Let me adjust my microphone. It was
17 kind of -- is that better?

18 HEARING EXAMINER ORTH: Not really. When you
19 move, the -- let's see now.

20 MS. HARDY: Is that better?

21 HEARING EXAMINER ORTH: That's better.

22 MS. HARDY: Okay. I think the cord was wrapped
23 around the microphone. I apologize.

24 HEARING EXAMINER ORTH: I didn't hear any other
25 appearances, so if you would, go ahead.

1 MS. HARDY: Thank you. In Case 21479, Mewbourne
2 seeks to pool additional interest owners under the terms of
3 Order R-21292. That order was entered in April of 2020 in
4 Case Number 21156. And it created a 240 acre standard
5 horizontal spacing unit comprised of the W/2 of the E/2 of
6 Section 26 and the W/2 of the SE/4 of Section 23, Township
7 21 South, Range 34 East in Lea County. The order pooled
8 interest in the Bone Spring formation and dedicated the unit
9 to the Inland 26/23 B20J State Com 1H well.

10 And in Case Number 21480, Mewbourne seeks to
11 similarly pool additional interest owners under the terms of
12 Order Number R-21293. That order was also issued in April
13 of 2020, and it was issued in Case Number 21157. It also
14 created a 240 acre spacing unit, and this one was comprised
15 of the E/2 of the E/2 of Section 26 and the E/2 of the SE/4
16 of Section 23, Township 21 South, Range 34 East in Lea
17 County. That order pooled interest in the Bone Spring
18 formation and dedicated the unit to the Inland 26/23 B2PI.
19 State Com 1H well.

20 We have provided in our exhibits the affidavit of
21 landman Brad Dunn. And he discusses the orders that were
22 issued by the Division, and those orders are also attached
23 to his affidavits.

24 And he provides a plat of the tracts, and the
25 ownership information is included in Exhibit A-5 in Case

1 21479, and it's Exhibit A-4 in Case 21480. And those
2 exhibits identify the ownership interest in each tract, the
3 parties who were pooled under the original orders, and then
4 the parties who are being added here in these cases, and
5 that exhibit also identifies the parties that are
6 unlocatable.

7 We provided notice of the hearing more than 20
8 days in advance by certified mail. That information is also
9 attached to Mr. Dunn's affidavits, and in both cases we also
10 did publish notice more than 10 days prior to the hearing,
11 and I have provided the affidavits of publication.

12 So with that information, unless there are
13 questions, I would ask that the exhibits be accepted into
14 the record and that the cases be taken under advisement.

15 HEARING EXAMINER ORTH: Thank you, Ms. Hardy.
16 Mr. Rose-Coss, do you have questions of Ms. Hardy in
17 relation to matters 21479 or 21480.

18 TECHNICAL EXAMINER COSS: Thank you, Ms. Orth, I
19 do not have any questions at this time. Thank you.

20 HEARING EXAMINER ORTH: All right. Ms. Hardy,
21 your exhibits are admitted and these two matters will be
22 taken under advisement.

23 MS. HARDY: Thank you very much.
