1 HEARING EXAMINER ORTH: Let's move then to 21494.

- 2 Mewbourne Oil is the applicant, compulsory pooling
- 3 application, the well name is El Jefe. Mr. Bruce, you are
- 4 here for the applicant?
- 5 MR. BRUCE: Yes, I am.
- 6 HEARING EXAMINER ORTH: I don't see any other
- 7 entries of appearance in the record. Let me pause for a
- 8 moment to see if there are any this morning.
- 9 (No audible response.)
- 10 HEARING EXAMINER ORTH: No? Please go ahead.
- 11 MR. BRUCE: In this case Mewbourne seeks to force
- 12 pool the W/2 of Section 35, 24 South, 28 East, and the W/2
- of Section 2, 25 South, 28 East for a couple of -- actually,
- 14 four Purple Sage Wolfcamp gas wells.
- 15 The wells are the El Jefe 35/2 wells. Two of --
- 16 let me see. Make sure I have the right -- yes. They are
- 17 both Upper -- or all of the wells are Upper Wolfcamp wells.
- 18 One of them is a Wolfcamp Sage -- Wolfcamp Sand, and I
- 19 believe another set of them are just below that in the Upper
- 20 Wolfcamp Shale.
- 21 The landman, Mitch Robb, has previously testified
- 22 before the Division as an expert, and his affidavit contains
- 23 the usual information on what was done to locate the parties
- 24 and contains information on the overhead rates, et cetera.
- 25 There are plats identifying the different tracts

- in the well unit and the different leasehold ownership.
- 2 Mewbourne does seek to force pool about 25 percent of the
- 3 interest in the well unit, and the interest owners being
- 4 pooled are denoted on the tract ownership list by an
- 5 asterisk.
- 6 The geologist Charles Crosby has previously
- 7 testified before the Division as an expert geologist, and he
- 8 also submits the usual structure map, cross sections showing
- 9 that the wells should be drilled as horizontal wells, and
- 10 that in this area the Wolfcamp preferred orientation is
- 11 north to south.
- 12 My notice affidavit sent out to all the parties
- 13 being pooled contained -- there is a few envelopes that I
- 14 did not receive back, or green cards, but notice was
- 15 published in the Carlsbad newspaper, and that is shown on
- 16 Exhibit 5, so everyone received actual or constructive
- 17 notice.
- 18 And then Exhibit 6 is the pooling checklist.
- 19 I believe all the necessary info is located in
- 20 the packet, and I would move the admission of Exhibits 1
- 21 through 6 and ask that the matter be taken under advisement.
- 22 HEARING EXAMINER ORTH: All right. Thank you,
- 23 Mr. Bruce. Mr. Rose-Coss, do you have any questions?
- 24 TECHNICAL EXAMINER COSS: I do not have any
- 25 questions for Mr. Bruce at this time. Thank you, Ms. Orth.
