- 3 is Silver, Silver Fed. Mr. Bruce, you are here for the

- 7 appearance by Modrall Sperling for Marathon. Is that you,
- 8 Ms. Bennett?
- 9 MS. BENNETT: Good morning, Madam Examiner. This
- 10 is Deana Bennett on behalf of Marathon Permian LLC, and
- 11 Marathon does not object to these cases going forward by
- 12 affidavit. Marathon is entering its appearance in these
- 13 cases just to preserve its right to appeal. Thank you.
- 14 HEARING EXAMINER ORTH: Thank you very much, Ms.
- 15 Bennett. Let me pause for a moment to see if there are any
- 16 other appearances this morning.
- 17 (No audible response.)
- 18 HEARING EXAMINER ORTH: I hear nothing. Mr.
- 19 Bruce, please go ahead.
- MR. BRUCE: Yes, in these two cases Ascent again
- 21 seeks to force pool the Bone Spring and Wolfcamp formations
- 22 underlying the W/2 W/2 of Section 4 and W/2 W/2 of
- 23 Section 9, 20 South, 33 East. This is -- these -- that
- land immediately abuts the property which was pooled in the
- 25 prior four cases. Yes, these are the Silver Fed Com wells,

- 1 family of wells.
- Other, other than having different, different
- 3 ownership and the different acreage, the exhibit packages
- 4 are virtually the same. The landman's package contains all
- 5 the usual information required by the Division to see that
- 6 an effort was made to obtain voluntary joinder of the
- 7 parties, and it gives the overhead rates, et cetera.
- 8 Again, the geologist exhibits are broken down
- 9 into Bone Spring exhibits for Exhibit 3-A, and then Wolfcamp
- 10 exhibits for Exhibit 3-B, but the geology is exactly the
- 11 same as for the prior four cases, so that when I e-mail Mr.
- 12 Rose-Coss the exhibits, the one package covers -- he will
- 13 get just one package of exhibits that will cover everything
- 14 so that he doesn't need to review it six times.

- 16 who was pooled received actual notice, and therefore notice
- was not published in the newspaper.
- 18 And the pooling checklist for the two cases are
- 19 marked Exhibits 5 and 6.
- 20 And with that, I would move the admission of te
- 21 exhibits and ask that the matters be taken under advisement.
