- 1 HEARING EXAMINER ORTH: Let's move to the next
- 2 set of matters. This is 21513, 21514, 21515, 21516, 21517,
- 3 21518. Manzano is the applicant. These are compulsory
- 4 pooling applications related to a well named Vindicator.
- 5 Holland & Hart entered an appearance on behalf of the
- 6 applicant.
- 7 MR. FELDEWERT: Yes, Madam Examiner. Michael
- 8 Feldewert of the Santa Fe office of Holland & Hart.
- 9 HEARING EXAMINER ORTH: Thank you, Mr. Feldewert.
- 10 I saw entries by Modrall Sperling on behalf of Marathon.
- 11 Ms. Bennett, is that you?
- MS. BENNETT: Yes, Madam Examiner. Deana Bennett
- 13 on behalf Marathon Oil Permian LLC.
- 14 HEARING EXAMINER ORTH: All right. And an entry
- 15 of appearance from Mr. Bruce on behalf of Texas Standard.
- MR. BRUCE: Yes, I'm here.
- 17 HEARING EXAMINER ORTH: Hello. Are there any
- 18 other entries this morning?
- 19 (No audible response.)
- 20 HEARING EXAMINER ORTH: I don't hear any. And as
- 21 I understand it, we are having a status conference this
- 22 morning.
- 23 MR. FELDEWERT: Yeah. Yes, Madam Examiner, just
- 24 a little context here. These pooling applications filed by
- 25 Manzano deal with a state exploratory unit, the Vindicator

1 Canyon State Exploratory Unit that's pending before the

- 2 Division because it's been previously heard in the Division
- 3 without objection.
- 4 These pooling applications essentially seek to
- 5 develop acreage within the pending exploratory unit as well
- 6 as some window acreage -- what I would call window acreage
- 7 just outside the -- kind of between some of the unit
- 8 acreage.
- 9 My understanding is I guess Texas Standard now is
- 10 going to file some competing proposals, pooling
- 11 applications, and as I understand it, it includes the same
- 12 acreage in the state exploratory unit and the window acreage
- 13 that Manzano is seeking to develop.
- 14 I'm not sure what Texas Standard intends to argue
- 15 since the development plans are basically the same. It's
- 16 the same acreage. It's the same orientation. It's the same
- 17 well pattern. And Manzano is soon to be the operator of the
- 18 state exploratory unit that's being approved by the Division
- 19 and State Land Office.
- So I guess we have to have a hearing, but I'm not
- 21 sure exactly what Texas Standard is going to argue.
- 22 MR. BRUCE: Oh, attorneys can always find
- 23 something to argue about.
- 24 HEARING EXAMINER ORTH: All right.
- 25 MR. BRUCE: They are going to be arguing for

- 1 operations, and we'll get into that, but, yeah, we need to
- 2 set a special hearing date. I don't believe -- and, Mike,
- 3 speak up -- I believe it is rather straightforward, but
- 4 since we would be prefiling testimony, I do not think it
- 5 would take all that long to present. Would you agree with
- 6 that?
- 7 MR. FELDEWERT: Yes.
- 8 HEARING EXAMINER ORTH: All right. Do you have a
- 9 proposed date, or do we -- a couple of months or so?
- 10 MR. BRUCE: No, I haven't.
- MR. FELDEWERT: No, you're right, and we had not.
- 12 And I understand from the discussions earlier that sometime
- 13 apparently in January, there's a few other things going on
- in January that might cause a problem for me personally,
- 15 like with there's a matter that's going to be pending --
- 16 that is pending before the Commission that's going to last a
- 17 couple weeks.
- 18 But there's -- there's a -- like I said, I guess
- 19 we are going to go to hearing. If there is a hearing date
- 20 sometime later January after the 15th, that would be
- 21 helpful. I know that Manzano has been visiting with the
- 22 State Land Office. The State Land Office was hoping to have
- 23 the initial well, unit well drilled the first part of
- 24 January. My assumption is they will be able to get an
- 25 extension of that if we are able to inform them we have this

- 1 objection and we have to go to hearing.
- 2 So but a hearing date in the latter part of
- 3 January would be helpful.
- 4 HEARING EXAMINER ORTH: All right. So let me
- 5 effectively state what I said earlier to the other parties.
- 6 The second hearing session in January is the 23rd. We
- 7 already have one contested hearing set on that date to
- 8 follow the regular session.
- 9 Having said that, these matters often settle and
- 10 presumably would not take two days in any event. So if you
- 11 wanted to have this matter set on the 21st, it would follow
- 12 the regular session which usually takes us to about 10 a.m.
- 13 The other contested hearing that's already been set there,
- 14 if it's settled by then, and we would continue through the
- 15 21st and through the 22nd if necessary.
- 16 The alternative is to identify a date or two when
- 17 you all are in agreement that it could be heard, to propose
- 18 that date in an e-mail in that prehearing order, let me
- 19 check that date with Marlene and the court reporter, and we
- 20 can give you a different date if that works.
- 21 MR. FELDEWERT: To make things easy, the 21st
- 22 would work for Manzano.
- MR. BRUCE: And that works for my client, also.
- 24 HEARING EXAMINER ORTH: Ms. Bennett?
- MS. BENNETT: (No audible response.)

3 muted. Marathon is entering its appearance in these

4 cases -- well, I'm basically just along for the ride. So I

5 will agree to whatever works for the other two who are more

7 HEARING EXAMINER ORTH: All right. So it sounds

8 like January 21 would be a good date, and if you would then,

9 please, Mr. Feldewert, submit a prehearing order with that

10 date.

MR. FELDEWERT: Sure.

12 HEARING EXAMINER ORTH: And we will get that

13 executed and on the track.

MR. FELDEWERT: Appreciate that. Thank you.
