In **Case No. 21542**, Matador seeks an order: (1) pooling all uncommitted interests in the Morrow formation (Carlsbad; Morrow, South (Gas) Pool (73960)) underlying a standard 320-acre, more or less, spacing unit comprised of the S/2 of Section 23, Township 23 South, Range 27 East, Eddy County, New Mexico; and (2) dedicating this vertical spacing unit to the proposed **Norris-Thornton Com #2H well** (API No. 30-015-42700) that has been drilled from a surface location in the NE/4 SE/4 (Unit I) of Section 23. The Division issued Administrative Order NSL-7626 approving the non-standard location of this well.


