APPLICATION

Matador Production Company ("Matador" or "Applicant"), through its undersigned attorneys, hereby files this application with the Oil Conservation Division, pursuant to the provisions of NMSA 1978, § 70-2-17, for an order pooling all uncommitted interests in the Morrow formation underlying a standard 320-acre, more or less, spacing unit comprised of the N/2 of Section 23, Township 23 South, Range 27 East, Eddy County, New Mexico. In support of its application, Matador states:

1. An affiliate entity of Matador (OGRID No. 228937) is a working interest owner in the proposed spacing unit and has the right to drill thereon.

2. Applicant seeks to dedicate the above-referenced spacing unit to the initial **Colonel R. Howard Com #1H well** (API No. 30-015-42703) that has been drilled from a surface location in the NW/4 NW/4 (Unit D) of Section 23.

3. The Division issued Administrative Order NSL-7631 approving the nonstandard location of this well.

4. Applicant has sought and been unable to obtain voluntary agreement for the development of these lands from all working interest owners in the subject acreage.

5. The pooling of interests will avoid the drilling of unnecessary wells, will prevent waste, and will protect correlative rights.

6. In order to permit Applicant to obtain its just and fair share of the oil and gas underlying the subject lands, all uncommitted interests in this spacing unit should be pooled, and Applicant should be designated the operator of the initial vertical well and this vertical spacing unit.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on December 3, 2020, and, after notice and hearing as required by law, the Division enter an order:

- A. Pooling all uncommitted interests in the vertical spacing unit in the Morrow formation and approving the initial well thereon;
- B. Designating Applicant as operator of this spacing unit and the vertical well that has been drilled thereon;
- C. Authorizing Applicant to recover its costs of drilling, equipping, and completing the well;
- D. Approving the actual operating charges and costs of supervision while drilling and after completion, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and
- E. Imposing a 200% charge for the risk assumed by Applicant in drilling and completing the well against any working interest owner who does not voluntarily participate in the drilling of the well.

AFFIDAVIT OF SARA HARTSFIELD IN SUPPORT OF CASE NO. 21544

Sara Hartsfield, being first duly sworn on oath, states as follows:

1. My name is Sara Hartsfield and I am employed by MRC Energy Company, an affiliate of Matador Production Company ("Matador"), as a Senior Landman.

2. I have previously testified before the Oil Conservation Division and had my credentials as an expert in petroleum land matters accepted and made a matter of record.

3. I am the landman who is familiar with the application filed by Matador in this matter and familiar with the status of the lands in Section 23, Township 23 South, Range 27 East, NMPM, Eddy County, New Mexico.

4. In this case, Matador seeks an order pooling interest owners in the Morrow formation underlying a standard 320-acre, more or less, spacing unit comprised of the N/2 of Section 23.

5. Matador intends to initially dedicate this proposed unit to the **Colonel R. Howard Com #1H well** (API No. 30-015-42703) a vertical well that has been drilled from a surface location in the NW/4 NW/4 (Unit D) of Section 23.

6. **Matador's Exhibit C-1** reflects that the Division issued Administrative Order NSL-7631 approving the non-standard location of this well.

7. Matador Exhibit C-2 is a C-102 for this well. The Division District Office

has placed this well in the Carlsbad; Morrow, South (Gas) Pool (Pool code 73960).

8. **Matador Exhibit C-3** identifies the tracts of land comprising the proposed vertical spacing unit. All acreage is fee and federal. No ownership depth severances exist in the proposed spacing unit in the Morrow formation.

9. **Matador Exhibit C-4** identifies the working interest owner that Matador seeks to pool in this unit. Matador has conducted a diligent search for the contact information for this company and has had several discussions with the company regarding this acreage, as set forth below.

10. **Matador Exhibit C-5** contains sample well proposal letter and AFE sent to the working interest owner. The costs reflected in these AFEs are consistent with what other operators have incurred for drilling similar vertical wells in the area in this formation.

11. In addition to sending well proposal letters and AFEs, I have discussed this pooling hearing with each company that Matador seeks to pool in this case. Matador proposed the **Colonel R. Howard Com #1H well** to Flat Creek Resources on March 12, 2019, along with an Operating Agreement dated January 1, 2018. Since the original well proposal, Matador and Flat Creek have exchanged multiple emails, phone calls and had in-person meetings to discuss potential development and the possibility of trade. The most recent of these phone calls was on November 23, 2020. In my opinion, Matador has undertaken good faith efforts to reach an agreement with the uncommitted mineral owners.

12. Matador requests that the overhead and administrative costs for drilling and producing the well be set at \$8,000 per month while drilling and \$800 per month while producing. These costs are consistent with what other operators are charging in this area for similar vertical wells.

13. I have provided the law firm of Holland & Hart LLP with the names and addresses (where available) of the interest owners that Matador seeks to pool and instructed that they be notified of this hearing.

14. Matador Exhibits C-1 through C-5 were either prepared by me or compiled under my direction and supervision.


