- 1 HEARING EXAMINER ORTH: Let's move then to
- 2 Matters 21379, 21380, 21430, 21431 and 21432. I have called
- 3 them all together because I understand that they will be
- 4 collectively considered for a status conference this
- 5 morning. Counsel can certainly clarify for me if that's not
- 6 the case.
- 7 21379 and 21380, Colgate Operating is the
- 8 applicant, compulsory pooling application. The well name is
- 9 Silver Bar, and we have Modrall Sperling entering an
- 10 appearance on behalf of the applicant. Who here is
- 11 representing the applicant this morning?
- MR. HOUGH: Good morning, Madam Examiner. This
- is Lance Hough from Modrall Sperling on behalf of Colgate
- 14 Operating LLC, and your understanding is correct with
- 15 respect to these cases being heard together.
- 16 HEARING EXAMINER ORTH: Thank you very much,
- 17 Mr. Hough. We have then -- let's see. Colgate, how did
- 18 I -- the entry of appearance from another party?
- 19 (No audible response.)
- 20 HEARING EXAMINER ORTH: No? 21430, 21431, 21432
- 21 Mewbourne Oil is the applicant, compulsory pooling
- 22 applications relating to a well that is the Iron Horse. Mr.
- 23 Bruce, I have unmuted you.
- MR. BRUCE: Yes, I am here for the applicant.
- 25 And as to the Colgate cases I can't recall whether or not I

- 1 entered an appearance. I do enter an appearance in that
- 2 case and they have done so in mine, so --
- 3 HEARING EXAMINER ORTH: Yes, I was starting to
- 4 confuse myself there. Thank you. Let me pause for a moment
- 5 in the event there are any additional appearances in any of
- 6 these cases this morning.
- 7 (No audible response.)
- 8 HEARING EXAMINER ORTH: Hearing nothing, would
- 9 you please kick us off first, Mr. Hough.
- 10 MR. HOUGH: Thank you, Madam Examiner. It's
- 11 pretty straightforward. The parties here have tried to, as
- included in our stipulated request (inaudible) we are
- 13 working on a resolution. So at this point we thought a
- 14 status conference time would be an appropriate time to set a
- 15 subsequent hearing date, rather than potentially, you know,
- 16 just continuing and having a continuance, or I mean, a
- 17 subsequent status conference to set the hearing.
- 18 So that's really all that I believe we are here
- 19 to do today, but obviously Mr. Bruce can speak on behalf of
- 20 Mewbourne.
- 21 MR. BRUCE: Yeah, we just need to reset it
- 22 because I believe the parties are discussing this matter,
- 23 and there is always the chance of a settlement.
- MR. HOUGH: Hello? Madam Examiner, I believe you
- 25 are on mute.

1 HEARING EXAMINER ORTH: Yeah, muting myself. So

- 2 thank you very much, Mr. Bruce. Do counsel have a
- 3 particular month they would like to choose a Thursday
- 4 session, and Ms. Salvidrez and I have spoken and would very
- 5 much like to focus counsel on possible Thursday sessions
- 6 which reduced the need for special public notice if we can
- 7 just add it to a regular Thursday hearing.
- 8 MR. HOUGH: I know Mr. Bruce and I spoke about
- 9 sometime in February, so early February. The second docket
- 10 in February works for us, too, or at least for Colgate.
- 11 HEARING EXAMINER ORTH: All right. So there are
- 12 two hearing sessions in February 2021, either the 4th or the
- 13 18th. As you may remember, there are other cases which may
- 14 have been tentatively set with or without prehearing orders
- 15 for those dates, so I will tell you those dates have a
- 16 number of these ostensibly contested cases which then settle
- 17 such that we don't actually have contested hearings, I think
- 18 we can just go ahead and schedule more than one contested
- 19 case in connection with a regular hearing.
- 20 So do you have a preference as to the 4th or the
- 21 18th?
- 22 MR. BRUCE: I would go for the 18. I will be a
- 23 party to the two contested cases that are on February 4, and
- 24 I think it would just be easier to do the 18th.
- 25 HEARING EXAMINER ORTH: All right. Thank you,

Page 6 Mr. Hough, that's okay? 1 2 MR. HOUGH: That's okay. HEARING EXAMINER ORTH: All right. Who then is 3 going to get me a draft prehearing order? MR. HOUGH: I'm happy to go ahead and submit that 5 draft prehearing order in the next few days or so. 6 7 HEARING EXAMINER ORTH: Thank you very much. 8 there anything else we need to talk about in connection with 9 these five matters?
