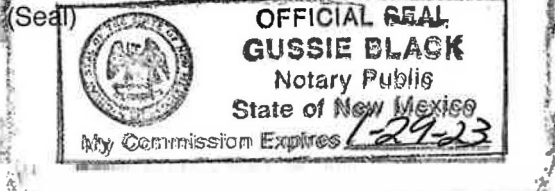

Case No. 21532: Application of Ameredev Operating, LLC for compulsory pooling, Lea County, New Mexico. Applicant in the above-styled cause seeks an order pooling all uncommitted interest in the Wolfcamp formation, underlying a standard 320-acre, more or less, spacing unit comprised of the E/2 W/2 of Sections 29 and 32, Township 25 South, Range 36 East, N.M.P.M., Lea County, New Mexico. Said unit is to be dedicated to the proposed Redbud Fed Com 25 36 32 122H Well, which will be horizontally drilled from a surface location in the SW 1/4 SW 1/4 (Unit M) of Section 32, to a bottom hole location in the NE 1/4 NW 1/4 (Unit C) of Section 29. The completed interval of the well will comply with statewide setbacks for oil wells. Also, to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for risk involved in drilling said well. Said area is located approximately 6 miles west of Jal, New Mex.
