- 3 is 9:04 on December 9, 2020, and this is a meeting of the
- 4 Oil Conservation Commission
- 5 My name is Adrienne Sandoval. I am Chair
- 6 of the Oil Conservation Commission and director of the Oil
- 7 Conservation Division.
- 8 Will the other commissioners please
- 9 introduce themselves for the record.
- 10 COMMISSIONER KESSLER: Good morning, this is
- 11 Jordan Kessler, (inaudible) and for State Land
- 12 Commissioner Stephanie Garcia Richards.
- 13 COMMISSIONER ENGLER: Good morning. This is Tom
- 14 Engler. I am designee from the Energy, Minerals and
- 15 Natural Resources Department.
- 16 COMMISSION CHAIR SANDOVAL: Also with us today
- 17 we have counselors Chris Moander and Sally Malave, as well
- 18 as Florene Davidson who is commission clerk.
- 19 On to the agenda. We have first, Item
- 20 No. 2 Approval of the Agenda. Before we do that I want to
- 21 note that Agenda Item No. 5, Case No. 15855, the status
- 22 conference between Delaware Energy and Alpha was continued
- 23 to a later date and will not be heard today.
- 24 Items Nos. 6, 7 and 8, Case No. 21473, Case
- 25 No. 21474 and Case No. 21475 were also continued to a

1 later date and will not be heard today. We will, however,

- 2 be hearing Agenda Item No. 9, which is Case No. 21476.
- 3 So with those modifications, is there a
- 4 motion to approve the agenda, the modified agenda?
- 5 COMMISSIONER KESSLER: (Inaudible.)
- 6 (Note: Discussion with reporter.)
- 7 All right. You want to -- let's try again.
- 8 Is there a motion to approve the modified agenda?
- 9 COMMISSIONER ENGLER: Let me do it. This is Tom
- 10 Engler. Motion to approve the modified agenda.
- 11 COMMISSION CHAIR SANDOVAL: Is there a second?
- 12 (Note: Pause.) It is hard to hear. It kind of
- 13 was very echoed and back and forth.
- 14 (Note: Discussion off the record.)
- 15 COMMISSION CHAIR SANDOVAL: Jordan, are you on
- 16 yet? I muted the call-in users. Not yet.
- 17 COMMISSIONER KESSLER: No, not yet.
- 18 (Note: Pause.)
- 19 COMMISSION CHAIR SANDOVAL: I just unmuted
- 20 another call-in user. Is that you, Jordan?
- 21 COMMISIONER KESSLER: Yes, that's me.
- 22 COMMISSION CHAIR SANDOVAL: That sounds a lot
- 23 better. I'm going to keep you unmuted because I can't
- 24 make a call-in user a panelist, so I'll just keep you
- 25 unmuted. So if you just want to mute and unmute your

- 1 phone.
- 2 COMMISSIONER KESSLER: Okay. Thanks.
- 3 Okay. Is there a motion to adopt the
- 4 modified agenda?
- 5 COMMISSIONER ENGLER: I move to adopt the
- 6 modified agenda.
- 7 COMMISSION CHAIR SANDOVAL: Is there a second?
- 8 COMMISSIONER KESSLER: Second, yes.
- 9 COMMISSION CHAIR SANDOVAL: Mr. Moander, would
- 10 you do a roll call, please.
- MR. MOANDER: Yes.
- 12 Chair Sandoval.
- 13 COMMISSION CHAIR SANDOVAL: I approve.
- MR. MOANDER: Member Engler.
- 15 COMMISSIONER ENGLER: Approved.
- MR. MOANDER: Member Kessler.
- 17 COMMISSIONER KESSLER: Approved.
- 18 MR. MOANDER: The vote is unanimous and the
- 19 motion is passed.
- 20 COMMISSION CHAIR SANDOVAL: Thank you. All
- 21 right. The next on the agenda is approval of the November
- 22 4th minutes.
- 23 Have the commissioners reviewed the minutes
- 24 and are there any corrections?
- 25 COMMISSIONER ENGLER: This is Tom Engler. I

- 1 have no corrections.
- 2 COMMISSIONER. KESSLER: I have reviewed the
- 3 minutes and I have no corrections either.
- 4 COMMISSION CHAIR SANDOVAL: Thank you. Is there
- 5 a motion to approve the November 4, 2020 minutes?
- 6 COMMISSIONER ENGLER: This is Tom Engler and I
- 7 so move.
- 8 COMMISSIONER KESSLER: Second.
- 9 COMMISSION CHAIR SANDOVAL: Mr. Moander, would
- 10 you please do a roll call vote.
- 11 MR. MOANDER: Yes. Chair Sandoval.
- 12 COMMISSION CHAIR SANDOVAL: Approve.
- MR. MOANDER: Member Engler.
- 14 COMMISSIONER ENGLER: Approved.
- MR. MOANDER: Member Kessler.
- 16 COMMISSIONER KESSLER: I approve.
- 17 MR. MOANDER: The motion is approved and passed
- 18 unanimously.
- 19 COMMISSION CHAIR SANDOVAL: Thank you.
- 20 (Note: Agenda Item 4 transcribed under Case
- 21 No. 21528)
- 22 (Note: Agenda Item 9 transcribed under
- 23 Case No. 21476.)
- 24 COMMISSION CHAIR SANDOVAL: All right. We can
- 25 move on to the next item on the docket, which is Agenda

- 1 Item 10, Pending Litigation.
- 2 Mr. Moander, do you have any updates?
- MR. MOANDER: Just very briefly. There's the
- 4 Novo Oil de novo appeal in District Court. The record
- 5 proper will be submitted by OCD by the middle of next
- 6 week, which will begin proceedings.
- 7 And then we have the Marker appeal. The
- 8 appellate brief was filed on December 12th. Our Response
- 9 is due on January 18th of '21, and we anticipate getting
- 10 all that done on time.
- 11 Other than that, I have nothing additional
- 12 to report.
- 13 COMMISSIONER ENGLER: Madam Chair, can I
- 14 interrupt a minute?
- The first one was which one? The de novo?
- 16 Which one was that?
- 17 MR. MOANDER: It's a -- Novo Oil has a District
- 18 Court Rule 74 appeal.
- 19 COMMISSIONER ENGLER: For?
- 20 COMMISSION CHAIR SANDOVAL: Novo appealed the
- 21 case that we heard a couple of months ago.
- 22 COMMISSIONER ENGLER: That's what I was
- 23 wondering, if that's the case that we heard. Okay. Thank
- 24 you.
- 25 COMMISSION CHAIR SANDOVAL: They appealed our

- 1 decision.
- 2 COMMISSIONER ENGLER: To district court.
- 3 MS. MALAVE: And just for purposes of
- 4 correction -- this is Sally Malave.
- I would say Mr. Moander said the Marker
- 6 appeal was filed on December 12th. In fact it was
- 7 December 2nd.
- 8 MR. MOANDER: Sorry. I misread my own notes.
- 9 It is December 2nd.
- 10 COMMISSION CHAIR SANDOVAL: Thank you.
- I guess the 20th (sic) hasn't happened yet.
- MR. MOANDER: I'm very good at -- well...
- 13 COMMISSION CHAIR SANDOVAL: Is there any other
- 14 business in front of the Commission today?
- 15 (Note: No response.)
- 16 COMMISSION CHAIR SANDOVAL: All right. Our next
- 17 meeting is a Special Meeting on December 30th. Just a
- 18 reminder that that meeting is at 8:00 a.m. not our usually
- 19 scheduled 9:00 a.m., and that will be from 8:00 a.m. until
- 20 noon.
