APPLICATION

OGX Resources LLC applies for an order (a) approving a non-standard oil spacing and proration unit in the Bone Spring formation comprised of Lots 1-4 and the South 34 acres of the N½N½ of Section 32, Township 26 South, Range 29 East, N.M.P.M., Eddy County, New Mexico, and (b) pooling all mineral interests in the Bone Spring formation underlying the non-standard unit, and in support thereof, states:

- 1. Applicant is an interest owner in Lots 1-4 and the South 34 acres of the $N\frac{1}{2}N\frac{1}{2}$ of Section 32, and has the right to drill a well thereon.
- 2. Applicant proposes to drill its Sidewinder Well No. 1 to a depth sufficient to test the Bone Spring formation. Applicant seeks to dedicate Lots 1-4 and the South 34 acres of the N½N½ of Section 32 of the Bone Spring formation to form a non-standard 126 acre oil spacing and proration unit (project area) for all pools or formations developed on 40 acre spacing. The well is a horizontal well, with a surface location in Lot 1, and a terminus in Lot 4, of Section 33.
- 3. Applicant has in good faith sought to obtain the voluntary joinder of all other mineral interest owners in the Lots 1-4 and the South 34 acres of the N½N½ of Section 32 for the purposes set forth herein.
- 4. Although applicant attempted to obtain voluntary agreements from all mineral interest owners to participate in the drilling of the well or to otherwise commit their interests to the well, certain interest owners have failed or refused to join in dedicating their interests.

5. Approval of the non-standard unit, and the pooling of all mineral interests

underlying the Lots 1-4 and the South 34 acres of the N½N½ of Section 32, will prevent the

drilling of unnecessary wells, prevent waste, and protect correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the Division enter its

order:

A. Approving a non-standard oil spacing and proration unit (project area) in the Bone

32;

B. Pooling all mineral interests in the Bone Spring formation underlying Lots 1-4

and the South 34 acres of the N½N½ of Section 32;

C. Designating applicant as operator of the well;

E. Considering the cost of drilling and completing the well, and allocating the cost

among the well's working interest owners;

D. Approving actual operating charges and costs charged for supervision, together

with a provision adjusting the rates pursuant to the COPAS accounting procedure; and

E. Setting a 200% charge for the risk involved in drilling and completing the well in

the event a working interest owner elects not to participate in the well.

OGX Resources LLC seeks an order approving a 126-acre non-standard oil spacing and proration unit (project area) in the Bone Spring formation comprised of Lots 1-4 and the south 34 acres of the N/2N/2 of Section 32, Township 26 South, Range 29 East, NMPM. Applicant further seeks the pooling of all mineral interests in the Bone Spring formation underlying the non-standard spacing and proration unit (project area) for all pools or formations developed on 40 acre spacing within that vertical extent.
