Dear Members of the Oil Conservation Commission,

I strongly support a methane rule that will position New Mexico as a leader in the reduction of emissions, while preserving the long term success of our state's oil and gas industry. I had the opportunity to listen to a BLM staffer several years ago who had spent considerable time researching government data regarding emissions relating to oil and gas from producing countries around the world and in the United States of America. The conclusion was that production of oil and gas, at that time, from the United States produced less emissions into the atmosphere than a barrel of oil or an mcf of gas produced anywhere else in the world. As a result, I would hope that while our country and the rest of the world continues to use oil and gas for energy, that we would not regulate our domestic industry out of business and thereby import oil and gas that has greater emissions into the atmosphere than would have resulted if we produced it domestically. Since the time that data was gathered, our domestic industry has made great strides at reducing our emissions even more. The State of New Mexico can and should work to achieve a balance between mitigating risks associated with climate change and ensuring the continued strength of oil and gas as the state's largest and most successful private industry.

While the rule seeks to be a leader in emission reduction, we need to have balance and flexibility such that older marginal well reserves are not lost by costs that result in them being uneconomical while the resulting reduction in emissions is nominal. We also need the state to encourage other government bodies who permit rights of ways and other aspects of the business to not be an impediment to timely approval of projects which the delays result in additional emissions that could have been avoided. The final rules must preserve a balance between bold, meaningful steps forward on climate change and smart, flexible regulations that ensure the oil and gas industry will continue to thrive in New Mexico.

Oil and gas production provides significant employment and tax revenue to the State of New Mexico. Many point to the growth of renewables in our state, but while we still need oil and gas for energy in the world economy, we should try and maximize our lower emission product which provides huge financial benefit to the state. New Mexico can be a leader in the fight against climate change and the production of oil and gas.


