In Case No. 21467, Colgate seeks an order from the Division: (1) to the extent necessary, approving the creation of a 320-acre, more or less, Bone Spring non-standard horizontal spacing

unit; and, (2) pooling all uncommitted mineral interests within a Bone Spring non-standard horizontal spacing unit underlying the N/2 N/2 of Section 32 and N/2 N/2 of Section 31, Township 19 South, Range 28 East, NMPM, Eddy County, New Mexico. This non-standard spacing unit will be dedicated to the **Bolander 32 State Fed Com 121H** and **Bolander 32 State Fed Com 131H** wells, to be horizontally drilled. The producing intervals for these wells will be orthodox. Also to be considered will be the cost of drilling, completing and equipping said wells, the allocation of these costs as well as the actual operating costs and charges for supervision, designation of Colgate as operator of the wells, and a 200% charge for risk involved in drilling said wells. Said area is located approximately 19.5 miles southeast of Artesia, New Mexico.

In Case No. 21468, Colgate seeks an order from the Division: (1) to the extent necessary, approving the creation of a 320-acre, more or less, Bone Spring non-standard horizontal spacing unit; and, (2) pooling all uncommitted mineral interests within a Bone Spring non-standard horizontal spacing unit underlying the S/2 N/2 of Section 32 and S/2 N/2 of Section 31, Township 19 South, Range 28 East, NMPM, Eddy County, New Mexico. This non-standard spacing unit will be dedicated to the Bolander 32 State Fed Com 122H and Bolander 32 State Fed Com 132H wells, to be horizontally drilled. The producing intervals for these wells will be orthodox. Also to be considered will be the cost of drilling, completing and equipping said wells, the allocation of these costs as well as the actual operating costs and charges for supervision, designation of Colgate as operator of the wells, and a 200% charge for risk involved in drilling said wells. Said area is located approximately 19.5 miles southeast of Artesia, New Mexico.
