- 21 admitted interests within the Purple Sage-Wolfcamp Gas
- 22 Pool, underlying the unit and dedicated the unit to the
- 23 Momba Fed. Com 701, 702 and 703 wells.
- 24 COG since identified additional mineral
- 25 interest owners in the unit that have not been pooled

- 9 MR. RODRIGUEZ: Yes, correct.
