- 2 HEARING EXAMINER BRANCARD: Okay. According to
- 3 my computer clock, it's 9:50 a.m., and so we'll go back on
- 4 the record here in the hearings of the OCD on January 7,
- 5 2021.
- 6 If my scribbles are correct, I think we are
- 7 on Item 40, Case No. 21629, Colorado Operating.
- And I think we are doing status conference
- 9 here. So who's here for Colgate Operating?
- 10 MR. HOUGH: Good morning, Mr. Hearing Examiner.
- 11 Hopefully you can hear me; it looks like my video might
- 12 not be working. But this is Lance Hough with the Modrall
- 13 Sperling Law Firm, for Colgate Operating, LLC.
- 14 HEARING EXAMINER BRANCARD: Mr. Hough, we hear
- 15 you loud and clear. We don't see you but we hear you.
- 16 Other appearances in this matter?
- 17 EXAMINER ROSE-COSS: Mr. McDonald, call-in user
- 18 No. 5, are you still with us?
- 19 MR. McDONALD: Yes. I lost connection, but I am
- 20 back on.
- 21 EXAMINER ROSE-COSS: Okay. You're Call-in User
- 22 No. 9 now. But your case is up.
- MR. McDONALD: Thank you.
- 24 HEARING EXAMINER BRANCARD: So, Mr. McDonald,
- 25 you are with Prosperity Bank; is that correct?

1 MR. McDONALD: Yes, on behalf of the J. M.

- 2 Wellborn Trust.
- 3 HEARING EXAMINER BRANCARD: Right. Okay.
- 4 Are there any other interested parties in
- 5 this case, Case 21629?
- 6 Hearing none, let's start with Mr. Hough.
- 7 How do you want to proceed in this matter?
- 8 MR. HOUGH: Mr. Examiner, I believe the parties,
- 9 being the J.M. Wellborn Trust and Colgate, have reached an
- 10 agreement that -- uh, assuming that's what drew the
- 11 Division to set it for a status conference, Colgate is
- 12 prepared to present this matter by affidavit this morning.
- 13 We've submitted an exhibit packet timely, so, you know,
- 14 obviously we would like to proceed by affidavit presenting
- 15 this case. And my understanding is there an agreement has
- 16 been reached with J.M. Wellborn Trust.
- 17 HEARING EXAMINER BRANCARD: Okay. Examiners,
- 18 are you okay with this going by affidavit today?
- 19 HEARING EXAMINER ROSE-COSS: I'm okay if Mr.
- 20 McDonald is.
- 21 EXAMINER McCLURE: I have no problems.
- MR. McDONALD: Oh, this is Brent McDonald. We
- 23 do have an agreement to the basic terms of an Assignment.
- 24 We are reviewing the Assignment, the form that they sent
- 25 to us this morning.

1 HEARING EXAMINER BRANCARD: All right. So

- 2 you're okay with this case proceeding by affidavit,
- 3 Mr. McDonald?
- 4 MR. McDONALD: Yes, sir.
- 5 HEARING EXAMINER BRANCARD: All right. All
- 6 right.
- 7 MR. HOUGH: This case is for compulsory pooling
- 8 of the uncommitted interests in the Bone Spring Formation
- 9 of the north half/north half of Section 3, north
- 10 half/north half of Section 2, in Township 20 South, Range
- 11 29 East. That's Eddy County, New Mexico.
- This is for a 320-acre, approximately,
- 13 spacing unit. This unit is going to be dedicated to a
- 14 well named Meridian 3 Fed State Com 131H.
- 15 Included in the packets of exhibits that
- 16 were submitted are: Exhibit A. That is the Compulsory
- 17 Pooling Application Checklist;
- 18 Exhibit B. That's the affidavit of Mark
- 19 Hajdik, who is the landman involved here and has
- 20 previously testified before the Division. Attached to his
- 21 affidavit are B-1 through 6.
- B-1 is the Application itself. B-2 is a
- 23 draft plat confirmed with Colgate.
- 24 (Note: Reporter inquiry.)
- 25 I was just stating that we provided a draft

1 plat C-102 that include footages. We will be able to

- 2 supplement with that C-102 likely this afternoon,
- 3 definitely by tomorrow.
- 4 Also included there is Exhibits B-1 through
- 5 through B-5, our communication timeline, the tract map
- 6 with the list of working interests, overriding royalty
- 7 interests, a Well Proposal Letter, and authorization for
- 8 expenditure.
- 9 Attached as Exhibit C is affidavit of
- 10 Sergio Ojeda, the geologist involved in this matter. He
- 11 has previously testified before the Division. Attached to
- 12 his exhibit are Exhibits C-1 through -7. Those consist of
- 13 a Regional Locator Map, Cross Section Locator Map, Gun
- 14 Barrel Diagram, Third Bone Spring Structure Map, Third
- 15 Bone Spring Isopach Map, Stratigraphic Cross section.
- 16 That last one is a zoomed-in stratigraphic cross section
- just consisting of the target zone of the Third Bone
- 18 Spring Formation.
- 19 Exhibit D is an affidavit from myself, and
- 20 attached to it are Exhibits D-1, -2 and -3. Those are:
- 21 1, the hearing Notice; 2, a list of parties who Notice was
- 22 sent to, and then status of those mailings.
- 23 There was an Affidavit of Publication. We
- 24 showed that Notice was timely mailed out, then Notice was
- 25 also published in a newspaper of local circulation timely,

- 1 as well.
- 2 So unless there are any questions, I'd ask
- 3 that these exhibits be admitted into the record and this
- 4 matter be taken under advisement.
- 5 HEARING EXAMINER BRANCARD: Thank you,
- 6 Mr. Hough.
- 7 Are there any other parties in this matter?
- 8 Mr. McDonald, do you have any questions for
- 9 Mr. Hough?
- 10 MR. McDONALD: No, sir.
- 11 HEARING EXAMINER BRANCARD: Okay. Examiners,
- 12 any questions?
- 13 EXAMINER ROSE-COSS: Mr. Hough, thanks. The
- 14 only question I have: Could you just clarify what
- 15 additional information you will be supplementing?
- 16 MR. HOUGH: Certainly. That will be the C-102
- 17 as we provided. In lieu of that, B-2 is a draft plat. I
- 18 don't have the actual C-102 right now, so I will
- 19 supplement that by tomorrow at the latest.
- 20 EXAMINER McCLURE: Examiner McClure. I have no
- 21 questions.
- 22 HEARING EXAMINER BRANCARD: Okay. That's fine
- 23 with you, Mr. Coss?
- 24 EXAMINER ROSE-COSS: Yes, that's fine with me.
- 25 I guess I should just confirm that all the -- I suppose

1 you already mentioned it, but all of the Notice was done

- 2 timely?
- 3 MR. HOUGH: That is correct. The Notice was
- 4 mailed 20 days in advance of the hearing, and then the --
- 5 it was published in a newspaper of local circulation, was
- 6 9 business days prior to the hearing. That includes
- 7 recognition of The Holidays, as well.
- 8 EXAMINER ROSE-COSS: Okay. Thank you. Then I
- 9 have no additional questions.
- 10 HEARING EXAMINER BRANCARD: Okay. Thank you.
- 11 Once again, this is Case 21629, Application
- of Colgate Operating for a compulsory pooling. Are there
- 13 any other comments?
- 14 Hearing none, we will accept your witnesses
- 15 as experts, Mr. Hough, admit the exhibits, and we will
- 16 keep the record open for your supplement, entering
- 17 material, and then take the case under advisement once we
- 18 have that.
- 19 MR. HOUGH: Thank you, Mr. Hearing Examiner.
