1 HEARING OFFICER BRANCARD: Excellent. So I will

- 2 call -- and I'm working off the spreadsheet that is on our
- 3 website. There are 40 cases listed. The first case is
- 4 21578, Matador. And is Mr. Bruce on the line?
- 5 MR. BRUCE: Can you hear me?
- 6 HEARING OFFICER BRANCARD: We can, barely, but we
- 7 can.
- 8 MR. BRUCE: That should be -- I didn't see the
- 9 new spreadsheet on the website, so I'm kind of flailing
- 10 around with a long sheet. There's two Matador cases, but
- 11 they are connected to some Catena cases that are -- should
- 12 be on a, status conference.
- 13 HEARING OFFICER BRANCARD: Okay. So cases 21578,
- 14 21579, Mr. Bruce, you are saying should be part of the
- 15 status conference?
- MR. BRUCE: Yes.
- 17 HEARING OFFICER BRANCARD: 21482, et cetera.
- 18 MR. BRUCE: Yes.
- 19 HEARING OFFICER BRANCARD: So you are not going
- 20 by affidavit this morning; is that correct?
- 21 MR. BRUCE: That is correct.
- 22 HEARING OFFICER BRANCARD: Okay. So we will move
- 23 cases 21578 and 21579 down to Numbers 14, et cetera. That's
- 24 Mr. Padilla. Is that correct, Mr. Padilla?
- MR. PADILLA: (Inaudible.)

1 HEARING OFFICER BRANCARD: Mr. Padilla, can you

- 2 hear me?
- 3 MR. PADILLA: Yes, I can. Can you hear me?
- 4 HEARING OFFICER BRANCARD: Now I can hear you,
- 5 yes.
- 6 MR. PADILLA: Let me speak louder then. My
- 7 understanding was that these cases were all going to be
- 8 combined for a status conference.
- 9 HEARING OFFICER BRANCARD: Okay. So that we will
- 10 do, we will skip over 21578 and 21579 and we will move on to
- 11 Number 3 on the spreadsheet.
- 12 (Break to hear other docket items.)
- 13 HEARING OFFICER BRANCARD: So now that we have
- 14 gotten through the Chicago Cubs here, I will talk to the
- 15 Court Reporter for a second. Would it be a good time to
- 16 take a break?
- 17 (Discussion with court reporter.)
- 18 HEARING OFFICER BRANCARD: We are about to go
- 19 into status conferences, so why don't we take about a
- ten-minute break here until 9:50.
- 21 (Recess taken.)
- 22 HEARING OFFICER BRANCARD: It is 9:51, and we are
- 23 back on the record on the Oil Conservation Division hearing
- on January 21, 2021. So we are moving on to status
- 25 conferences, and it looks like we may have several of them

- 1 all at once here.
- 2 Number 14 on our list is Catena -- hope I'm
- 3 pronouncing that correctly -- Resources. Mr. Padilla?
- 4 MR. PADILLA: (No audible response.)
- 5 HEARING OFFICER BRANCARD: Mr. Padilla?
- 6 MR. PADILLA: (No audible response.)
- 7 HEARING OFFICER BRANCARD: Calling Case 21482,
- 8 Catena Resources, status conference.
- 9 MR. PADILLA: Can you hear me now?
- 10 HEARING OFFICER BRANCARD: I can hear you loud
- 11 and clear.
- MR. PADILLA: Thank you. Good. I'm entering an
- 13 appearance for Catena Resources in Cases 21482, 21483,
- 14 21485. They are all in the same area and can probably be
- 15 heard in conjunction with the first two cases, 21578, 21579.
- 16 And I believe we can also jump down to the bottom
- 17 of the page to Cases 22 and 23. You will notice that the
- 18 cases down there are Rambo and Rope, and the 21483 and the
- 19 21485 are also Rambo and Rope cases, so I think they can all
- 20 be combined. I'm sure Mr. Bruce will concur in that.
- MR. BRUCE: Yes.
- 22 HEARING OFFICER BRANCARD: Okay. Mr. Bruce, you
- 23 are representing Matador, I believe.
- MR. BRUCE: In Case 21482, I'm entering an
- 25 appearance for Mewbourne Oil Company, and in all of the rest

1 of them, but only as to that particular case. As to all the

- 2 rest of them, I am entering an appearance for Matador, plus
- 3 MRC Permian Company.
- 4 HEARING OFFICER BRANCARD: Mr. Padilla?
- 5 MR. PADILLA: Mr. Examiner, I may add, we have
- 6 another case -- or I should point out that 21485, I have a
- 7 problem with that, is that we advertised the case as being
- 8 in Sections 19 and 20 and in fact it should be Section 30.
- 9 But short of dismissing this case and restarting
- 10 all over again, and I don't think we pooled anyone here with
- 11 that typo, it should be Section 30, but I will ask your
- 12 guidance as to whether or not the Division and Ms. Murphy
- 13 may be more likely to answer that question as to whether we
- 14 need to start all over again, dismiss 21485 and we start all
- 15 over again.
- 16 HEARING OFFICER BRANCARD: I will defer to Ms.
- 17 Murphy, but since we are setting a hearing at some point in
- 18 the future here, there might be an opportunity for
- 19 additional notice (inaudible).
- 20 MR. PADILLA: I think if we set it far enough out
- 21 here we can still hear the 21485 case. I noticed that you
- 22 were scheduling hearings in April. So that would give us
- 23 plenty of time.
- 24 HEARING OFFICER BRANCARD: Yeah, our dockets are
- 25 starting to get a little crowded here. So first let me just

1 check. Mr. Bruce, I assume you are okay with 21578 and

- 2 21579 being considered then?
- 3 MR. BRUCE: Yes.
- 4 HEARING OFFICER BRANCARD: Okay. So from what I
- 5 understand, we have cases 21578, 21579, Number 1 and 2 on
- 6 our spreadsheet, and then we have cases 21482, 21483, 21485,
- 7 14, 15 and 16 on our spreadsheet. In cases 21460 and 21462,
- 8 22 and 23 on our spreadsheet. Is that correct, Mr. Padilla?
- 9 MR. PADILLA: That's correct.
- 10 HEARING OFFICER BRANCARD: So I will then ask for
- 11 appearances in all of those cases. And it looks like we
- 12 have Modrall representing Marathon, is that correct, in some
- 13 of these cases? Ms. Bennett, you need to hit one of your
- 14 other mute buttons.
- MS. BENNETT: Good morning. Deana Bennett on
- 16 behalf of Marathon Oil Permian. I have entered my
- 17 appearance on Marathon's behalf in Case Numbers 21482, 21485
- 18 and 21462. Thank you.
- 19 HEARING OFFICER BRANCARD: Okay. I also see COG
- 20 listed here.
- 21 MR. RODRIGUEZ: Yes. Michael Rodriguez for COG
- 22 Operating LLC, and COG is entering an appearance in 21482,
- 23 21483, 21485, 21460 and 21462, so all of the Catena cases.
- MR. PADILLA: Mr. Examiner, if I may add, I took
- over the 21460, 21462 yesterday instead of Holland & Hart.

1 HEARING OFFICER BRANCARD: Okay, thank you.

- 2 Looks like we also have Mewbourne in 21482.
- 3 MR. BRUCE: That is correct.
- 4 HEARING OFFICER BRANCARD: Mr. Bruce, I'm sorry,
- 5 you are representing Mewbourne in that case?
- 6 MR. BRUCE: Correct.
- 7 HEARING OFFICER BRANCARD: MRC Permian, are you
- 8 also representing them?
- 9 MR. BRUCE: I'm representing MRC Permian and
- 10 Matador Production Company in all the cases you listed
- 11 except for 21482. They have no interest in that case.
- 12 HEARING OFFICER BRANCARD: Okay. And with that I
- 13 will ask if there are any other appearances in these seven
- 14 cases, 460, 462, 482, 483, 485, 578, 579. Any other
- 15 appearances?
- 16 (No audible response.)
- 17 HEARING OFFICER BRANCARD: Hearing none, Mr.
- 18 Padilla, perhaps you would like to start us off on a
- 19 discussion about what you would like for --
- 20 MR. PADILLA: Well, I think in all of these
- 21 cases, since they are in the same general area, have to be
- 22 combined, obviously the Matador cases at the top of the
- 23 docket are competing applications, so there's two views on
- 24 who is going to operate, I guess. I'm not sure. I haven't
- 25 seen the applications on, on the first two cases, so -- but

1 my understanding is they are competing cases. So I would

- 2 imagine that this -- it would take at least -- maybe a
- 3 full day to try all of these cases. At least half a day,
- 4 so --
- 5 HEARING OFFICER BRANCARD: So we are looking at
- 6 this second hearing date in the month, and April 22 is the
- 7 one that's available. We could go further into May. And I
- 8 guess I will first ask the other parties if they have an
- 9 objection with these seven cases being heard all in the same
- 10 hearing. Mr. Bruce?
- MR. BRUCE: No objection.
- 12 HEARING OFFICER BRANCARD: Ms. Bennett?
- MS. BENNETT: No objection.
- 14 HEARING OFFICER BRANCARD: Mr. Rodriguez?
- MR. RODRIGUEZ: No objection.
- 16 HEARING OFFICER BRANCARD: Good. We got past
- 17 that.
- 18 HEARING OFFICER BRANCARD: April 22?
- 19 MR. PADILLA: That will be fine, Mr. Examiner.
- 20 HEARING OFFICER BRANCARD: Mr. Bruce?
- MR. BRUCE: That's fine.
- 22 HEARING OFFICER BRANCARD: Ms. Bennett?
- MS. BENNETT: No objection.
- 24 HEARING OFFICER BRANCARD: Okay, Mr. Rodriguez?
- MR. RODRIGUEZ: Sounds good.

1 HEARING OFFICER BRANCARD: Okay. So we have a

- 2 date, we have a consolidation. Are there any other issues
- 3 in this status conference?
- 4 MR. PADILLA: Mr. Examiner, I can submit a, a
- 5 prehearing order and circulate it.
- 6 HEARING OFFICER BRANCARD: Okay. I -- can I
- 7 count on you to do that?
- 8 MR. PADILLA: I've offered, yes.
- 9 HEARING OFFICER BRANCARD: You don't want to get
- 10 Marlene mad and come after you --
- MR. PADILLA: No, I don't.
- 12 HEARING OFFICER BRANCARD: -- if you fall behind
- 13 on that. So that would be great. You know, we have a form
- 14 that we are using, so I just fill in the form with the
- 15 dates, that would be great. And hopefully you can get that
- 16 to us within a week. Is that possible?
- 17 MR. PADILLA: That's fine.
- 18 HEARING OFFICER BRANCARD: All right. If there
- 19 are no other issues, then these seven cases are consolidated
- 20 for hearing on April 22.
- 21 MR. PADILLA: Mr. Examiner, if I can correct the
- 22 error on the 21485, and I think that would give me enough
- 23 time and include that case for another case number in that
- 24 pretrial order or to be heard at the same time.
- 25 HEARING OFFICER BRANCARD: Sure. Would you like

- 1 to just publish new notice?
- MR. PADILLA: I will do whatever, whatever I need
- 3 to do, including filing and submit. We are not allowed to
- 4 file an amended application at this point, I don't think,
- 5 but we may have to start all over again. I don't know what
- 6 we have to do.
- 7 HEARING OFFICER BRANCARD: Ms. Murphy, can you
- 8 give me guidance?
- 9 TECHNICAL EXAMINER MURPHY: I would think that
- 10 publishing the wrong section would be an issue.
- 11 HEARING OFFICER BRANCARD: Yes, we have to
- 12 correct that somehow. So do we need a new application?
- 13 TECHNICAL EXAMINER MURPHY: I would say you need
- 14 a new application.
- 15 HEARING OFFICER BRANCARD: Okay. Mr. Padilla, is
- 16 that workable?
- 17 MR. PADILLA: That's workable. I mean, I have
- 18 plenty of time for notice for this, and so we will file
- 19 that.
- 20 HEARING OFFICER BRANCARD: Okay. So that
- 21 would be Case 21485 which would get dismissed upon a new
- 22 application for that particular well.
- 23 MR. PADILLA: The well proposals are going to be
- 24 the same for that case. I will file an application with
- 25 this case number or at least reference the case number that

- 1 is the same case as previously filed.
- 2 HEARING OFFICER BRANCARD: That would be good,
- 3 then we can dismiss that case and deal with the new case.
- 4 MR. PADILLA: Okay.
- 5 HEARING OFFICER BRANCARD: Any other issues, Ms.
- 6 Murphy?
- 7 TECHNICAL EXAMINER MURPHY: So is this generally
- 8 cases 22140 and 21462 against all the other cases?
- 9 MR. PADILLA: No. That -- we have to go to case
- 10 14, 15, 16, and there's also a 21484 that has been continued
- 11 by COG to the February 18 hearing date. And of course the
- 12 first two cases on the docket would be competing cases.
- 13 TECHNICAL EXAMINER MURPHY: So my question is,
- 14 who is competing against whom?
- 15 MR. PADILLA: Let me, let me turn to Mr. Bruce
- 16 there. I know he's got -- he is more informed as to at
- 17 least 21461 and 21462. I think they compete against those,
- 18 but he can correct me.
- 19 MR. BRUCE: I think the two Matador cases are --
- 20 directly compete against -- there is so many of them. The
- 21 Matador cases are directly against 21483 and 21462. I think
- 22 that is correct. Check on the acreage. Yeah, 21460 is the
- other case, yeah, so that's correct.
- 24 TECHNICAL EXAMINER MURPHY: So 21460, 21462 are
- 25 against the Catena cases?

1 MR. BRUCE: No. No. No. I'm representing

- 2 Matador.
- 3 TECHNICAL EXAMINER MURPHY: I understand that.
- 4 MR. BRUCE: My two cases for Matador are directly
- 5 against 21483 and 21460.
- 6 TECHNICAL EXAMINER MURPHY: I thought you were
- 7 representing 21460.
- 8 MR. BRUCE: No, no, no.
- 9 TECHNICAL EXAMINER MURPHY: Okay.
- 10 MR. BRUCE: No, those are all Catena matters,
- 11 other than the two Matador cases, and I'm opposing them.
- 12 TECHNICAL EXAMINER MURPHY: Okay. Thank you.
- 13 HEARING OFFICER BRANCARD: Ms. Murphy, would it
- 14 be helpful for the parties to stipulate to a map that shows
- 15 the overlap of their projects? Or their units, sorry --
- 16 scribbling on pieces of paper trying to figure this out.
- 17 TECHNICAL EXAMINER MURPHY: It would, and it
- 18 would also be helpful if they continued to negotiate.
- 19 HEARING OFFICER BRANCARD: Well, I'm sure they
- 20 will do that, but assuming the worst, then we have to take
- 21 this to hearing.
- 22 TECHNICAL EXAMINER MURPHY: Right. And I guess
- 23 when they submit their exhibits, then we'll -- we'll see
- 24 what the competition is.
- 25 HEARING OFFICER BRANCARD: Okay. Just to put

- 1 folks on notice, it's helpful to us if there is a map
- 2 showing all of these proposed units so we can see what the
- 3 overlaps are.
- 4 MR. PADILLA: Mr. Examiner, we can get a map and
- 5 we can -- I know I have had to draw a map on some of these
- 6 things myself because they're not on the same proration unit
- 7 necessarily, and I wasn't aware of the Matador cases until
- 8 yesterday, and I took over the 21460 and 21462 yesterday, so
- 9 I'm not up to speed on what acreage those cases involve and
- 10 how they affect the Catena applications that we filed.
- 11 HEARING OFFICER BRANCARD: I believe you
- mentioned another case that's not listed today, 21484?
- 13 MR. PADILLA: Yes, and that is combined with
- 14 another 21352, the Catena cases, and those are set for
- 15 February 28 or continued. I think COG is the only opposing
- 16 party to those. Mr. Rodriguez can speak to that.
- 17 HEARING OFFICER BRANCARD: Just so I'm clear, are
- 18 you saying there is an overlap with those case with the
- 19 seven ones we are looking at today?
- 20 MR. PADILLA: I don't think there is an overlap.
- 21 I think those are separate applications, but I know we filed
- 22 them -- they are all in the same general area of Lea County.
- 23 HEARING OFFICER BRANCARD: Okay. I just want to
- 24 make sure there were no more overlaps here. Is that
- 25 correct, Mr. Rodriguez, are you aware of this situation?

1 MR. RODRIGUEZ: That's my understanding.

- 2 HEARING OFFICER BRANCARD: Thank you.
- 3 TECHNICAL EXAMINER MURPHY: We should make sure
- 4 of that because --
- 5 MS. BENNETT: I'm on one of those cases.
- 6 HEARING OFFICER BRANCARD: I'm sorry, Ms.
- 7 Bennett.
- 8 MS. BENNETT: I was saying, just for the record,
- 9 if we are talking about the cases that have been continued
- 10 to the February docket, Marathon is in those cases as well.
- 11 Just to clarify.
- 12 HEARING OFFICER BRANCARD: Right, okay. Ms.
- 13 Murphy?
- 14 TECHNICAL EXAMINER MURPHY: We should make sure
- 15 there is not overlap because those cases in February, if the
- 16 examiner is unaware, those could be taken under advisement
- 17 and written before they realize that this -- these other
- 18 eight cases are going on in April.
- 19 HEARING OFFICER BRANCARD:
- 20 MR. PADILLA: I don't think that there is overlap
- 21 in terms of spacing units, for example, when there is a --
- 22 you have Bone Springs in Wolfcamp wells, I think that all of
- 23 these are distinct for spacing units, but I can check on
- 24 that and make sure that I'm speaking correctly.
- 25 HEARING OFFICER BRANCARD: Yes, please do, so if

1 we need to modify what's happening in February, that would

- 2 be helpful.
- 3 MS. BENNETT: Yes, Mr. Examiner. This is Deana
- 4 Bennett. I was going to suggest that the parties take this
- 5 discussion off line and we can figure out exactly which
- 6 cases overlap with which cases, and if there is an overlap,
- 7 we will make sure that the cases are handled appropriately.
- 8 Thank you.
- 9 HEARING OFFICER BRANCARD: Thank you. Are there
- 10 any more issues on these seven cases that I have in front of
- 11 me right now?
- 12 (No audible response.)
- 13 HEARING OFFICER BRANCARD: Hearing none,
- 14 Mr. Padilla is to prepare a prehearing order for cases
- 15 21460, 21462, 21482, 21483, 21485, or its successor, 21578
- 16 and 21579. And hearing examiner will designate a date of
- 17 April 22 for hearing on these cases.
- 18 MR. PADILLA: Okay. Thank you, Mr. Examiner.
