- 19 operators, so they tag together two quarter sections from
- 20 two -- from two different sections.
- The application and the ad are in Exhibit 1.
- 22 Exhibit 2 is the landman's affidavit. It
- 23 contains all the usual information. In going through that,
- 24 if you get to Exhibit 2-C, which contains the list of the
- 25 parties being pooled, the total interests being force pooled
